CONDITIONS OF PERMIT:

- The application must be signed by the TPI member in whose name it is to be issued.
- This permit allows the holder only to park free of charge in on-street parking bays where pay and display or metered parking fees are charged. Permit holders will still need to observe the parking restrictions in terms of time limits one hour, two hour and three hour.
- Permitted vehicles are not exempt from any Act, Regulation or By-Law, other than the exemption permitted by this permit relating to the driving and parking of vehicles in public streets or public places.
- · You can not park in marked Disabled Parking Bays (those with the international wheelchair symbol).
- Permit not to be displayed when permit holder not in vehicle.
- Permit must be displayed face up on the left hand side of dashboard.
- · Permit is valid at the Darwin Waterfront and Royal Darwin Hospital.
