CONDITIONS FOR USE OF PERMITTED PARKING PERMITS FOR MEDIA VEHICLES

Permits are to be used for the purpose of “news gathering” only.

Permits are to be displayed at all times when “news gathering”.

Parking is permitted in time zones only – free of charge (you do not have to purchase a parking voucher from a parking machine), however time restrictions still apply ie 2P is two hours only.

Parking is not permitted on yellow lines, footpaths, nature strips, in loading zones or blocking driveways and similar such areas.

Permits are not to be photocopied.

Permit not valid at Darwin Waterfront Precinct.

Permit not valid in off-street car parks.
