# Policy No. 0044.100.E.R

### 1 Purpose

The purpose of this policy is to outline City of Darwin's commitment to a free library service which will provide all residents of Northern Territory with:

- equitable access to information,
- the opportunity to pursue individual lifelong learning,
- the ability to enjoy recreational interests, and
- access to safe community spaces,

in order that they are able to achieve a desired quality of life and participate in an informed capacity in the community.

City of Darwin's free public library service will be delivered through a decentralised library service model which extends out to the community by maintaining libraries in the suburban areas. The City of Darwin provides a public library and information service to residents, workers, students and visitors. The library provides a range of programs and services, resources and facilities through its physical and digital library services.

City of Darwin concurs with the statement of the Australian Library and Information Association (ALIA) that:

"Freedom can be protected in a democratic society only if its citizens have unrestricted access to information and ideas".

Accordingly, it is the policy of the City of Darwin to provide a public library and information service to residents of the Northern Territory.

# 2 Scope

This policy applies to Elected Members, City of Darwin employees, City of Darwin Library members, ratepayers, residents of the City of Darwin, and all people who utilise library services and programs. It operates in conjunction with other relevant policies and procedures.

# 3 Policy statement

City of Darwin will maintain and develop the provision of free public library services to the community.

#### 3.1 Membership

Membership is free to any Northern Territory resident on presentation of suitable ID and documentation verifying NT residency. Visitors to the NT, and those who cannot provide full documentation, may be eligible for alternative limited membership types.

Reciprocal borrowing is available to members of other NT public library services and City of Darwin Library members have free access to library services across the NT.

#### 3.2 Collections

City of Darwin manages and develops vibrant library collections to meet the informational, cultural and entertainment needs of the Darwin community. The physical collection is enhanced by a comprehensive range of online resources including eBooks, eAudio books, digital magazines and newspapers, and research databases.

City of Darwin maintains collection development guidelines that ensure the maintenance of a current, visually inviting and accessible collection and inform the public of the principles upon which the library service makes decisions regarding the collection.

#### 3.3 Partnerships

City of Darwin maintains a relationship and delivers a public library service in partnership with the Northern Territory Government through the provision of a Public Library Funding Agreement.

#### 3.4 Children and young people

City of Darwin supports children and young people through the provision of collections and programs that foster an appreciation of literature and promotes the development of information literacy skills.

#### 3.5 Places and spaces

City of Darwin maintains four libraries at Casuarina, Darwin City, Nightcliff and Karama. The libraries are accessible for all and are vibrant spaces which encourage active participation and promote lifelong learning opportunities for the community.

Each of the libraries provide free access to current technology and digital infrastructure including Wi-Fi and internet access with PCs, printers and copiers.

City of Darwin library programs allow participants of all ages to develop strong and productive connections with their library, other participants and their community, delivering real and significant benefit to individuals and the community.

#### 3.7 Staffing

City of Darwin Libraries will provide appropriate skilled, trained or qualified staff to support library users to effectively use the library and resources with the aim to improve literacy, online and digital skills.
