Lorraine Corowa gave thanks for the responses to queries received so far but asked if there were any plans to buttress the vegetation on the cliff face around the Rock Sitters Club and if there were coastal erosion plans apart from the offshore areas already described. This question was taken on notice.

ACTION – Jamie Lewis to report back next meeting as to Casuarina trees.

Ms Corowa asked if there was a zoning map.

ACTION – Jade Leask to distribute the map.

Lon Wallis confirmed if planning for the new Revegetation plan is forthcoming including community planting days – the committee to advise plans for next revegetation area. Query of the planting list for East Point full Species list to be provided.

ACTION – Jamie Lewis to send the species list to the committee and include information on how it is generated.

East Point Reserve Biodiversity Management Plan updates (Jade):

- Atlas moth reintroduction 10 of 14 cocoons put in place Mar-Jun 2021 have hatched remaining cocoons in stasis. More atlas moth larvae to be put in place after wet season. Jade will provide Equestrian club as possible additional location for release to contractors.
- Cane toad surveys will commence once first rains established.
- BoM weather monitoring structure 16mx16m structure no taller than 4m to be installed near aeromodellers.
