The Lord Mayor reported on his attendance at the annual Gold Plate Awards. It was one of the best in years and the hospitality talent we have in our city is outstanding. New categories were added this year including a 'barista' award. Industry has a preference for local produce and promoting local produce.

Councillor Klonaris reported on FFNT offered Malak residents a community Q&A session. Proceeded with the Olympic club representatives and a huge number of residents attended. Culminated in Darwin Olympic agreeing to go back to FFNT to Agreement for Olympic to FFNT to do a cost analysis/feasibility of alternate locations. Ngaree Ah Kit, Member for Karama attended and offered support for funding to cover the cost of that work to identify an alternative location.

Urging people to ring and report as the data about hotspots is important. Also met with Michael Rotumah, CEO of Larrakia Nation. He will be looking into duplication of services and cross-overs in rostering of similar services so they can be spread to achieve better coverage.

This matter is considered to be confidential under Section 99(2) - 51(e) of the Local Government Act, and the Council is satisfied that discussion of this matter in an open meeting would, on balance, be contrary to the public interest as it deals with subject to subregulation 51(3) – information provided to the council on condition that it be kept confidential and would, if publicly disclosed, be likely to be contrary to the public interest.

27.1 Event Permit and Venue Options

This matter is considered to be confidential under Section 99(2) - 51(e) of the Local Government Act, and the Council is satisfied that discussion of this matter in an open meeting would, on balance, be contrary to the public interest as it deals with subject to subregulation 51(3) – information provided to the council on condition that it be kept confidential and would, if publicly disclosed, be likely to be contrary to the public interest.

28.1 Outgoing and Incoming Correspondence - Anti-Social Behaviour
