### COMMITTEE'S DECISION

THAT a report be presented to the City Futures Committee by February 2018 which outlines the potential options, strategic content and financial considerations for the preparation of a Smart Cities Strategy for the City of Darwin.

Rationale.

A smart city strategy is also a resilient city strategy. Policies for smart and resilient cities focus on understanding how cities' challenges and needs are changing; anticipating demands and risks; and then using technology and contemporary governance frameworks to provide more effective and affordable solutions.

- While the recent smart city grant announcement focus on technology, a smart city strategy will allow the organisation as a whole develop and change in the short, medium and long term.
- The strategy needs to embed change adaptation into the organisation.
- Contemporary methods of community consultation must underpin a Smart City Strategy.
- A number of pillars could be considered in a smart city strategy for Darwin Including (But not limited to):
  - Cooperation (with industry, government and research institutions) and knowledge exchange.
  - Smart technology.
  - Embracing digital disruption and the implications of the originations ICT.
  - Smart Governance and behaviour change of the organisation.
  - Smart Environment (everything form renewables, transport, smart waste to cooling and greening).
- The overarching objective of any smart intervention is to increase the well-being of residents — and to sustain that change.
- Darwin is well positioned to deliver strong results if we embrace change and capitalise on our strengths of agility, proximity to Asia and support from industry and government.
