### PURPOSE

The purpose of this report is to provide an update on current and upcoming arts projects within the City of Darwin Arts and Cultural Development portfolio.

### **KEY ISSUES**

### DISCUSSION

City of Darwin is committed to supporting and growing the local creative, arts and cultural communities for the benefit of all who live, work, visit and study here.

In line with our newly developed Creative Strategy (scheduled to go to Council on 6 February 2024) Officers have prioritised projects that fit under the 3 priority areas of Celebrating Larrakia, Distinctly Darwin and Invigorating Spaces.

### Irrigation Tanks Artworks Project

Officers worked with artists who had submitted high quality EOIs for the Nightcliff Village Masterplan but were unsuccessful for that opportunity to develop an approach across Wards in partnership with the team from Operations Centre.

The Irrigation Tanks Artwork project contracts local artists to create and design new works for the purposes of upgrading and beautifying local infrastructure in the community. The project allows for collaborations between visual artists and digital artist-designers and responds to the themes of water, local ecology, and the natural elements within the Darwin region. The first series was completed in December 2023 and features works by Denise Quall in collaboration with Ciella Williams across four water tanks in the Waters Ward.

The next series will feature three artworks by local artist-designer Danny Crichton set for tanks located throughout the Richardson ward and another artwork by local Larrakia Artist Jason Lee, which will be situation in the CBD and within the Lyons ward.

Danny's artworks, *The Coastal Nature series,* will feature a playful interpretation of local flora and fauna as seen in and around the northern suburbs coastal areas. The series looks at beauty and repetition in nature and will be realised through bright and bold colour options.

Jason Lee's artwork design *Gunamidirra* (meaning saltwater in Larrakia) will be realised in a new colourway for this project and reflects the presence, life, and importance of saltwater to Darwin as connected to its country and peoples. *Gunamidirra* currently features on a range of



infrastructure including planter boxes in blue colourway throughout the CBD.

Examples of draft tank design concepts by Danny and Jason will be provided in meeting for Committee members to view. Artworks will become public once installed onto infrastructure early 2024.

### Lightbox Exhibitions Program March – August Series

Arts Access Darwin will curate the next Lightbox Exhibitions series, featuring artworks by artists who are involved with their Free Space Studio Collective initiative. Free Space Studio is a dedicated visual arts program designed to work with, support and elevate artists with disabilities, run by Arts Access Darwin and as part of Darwin Community Arts.

Amina McConvell, coordinator of the program, will curate the *10 Years in the Studio* (working title) lightbox series which will focus on a retrospective selection of abstract, expressive works by ten studio artists. The works connect with concepts of creative perception, self-understanding, and identity. This series endeavours to provide a space for imaginative

interactions with the artists' interior and exterior worlds, reflecting and defining the spaces they live, work and create in. It also aims to elevate and celebrate the Free Space Studio program, its artists, the skills and the body of works they have achieved over a decade of operation. The series will be launched early March and will run until the end of August 2024.

The annual call out for Expressions of Interest (EOI's) for curators for the following 12 months of exhibitions will open in April 2024.

The Lightbox Exhibitions Program offers an opportunity to showcase local artworks of high calibre, based on a shared and relevant theme and curated by a local creative. The program considers applications including traditional visual art forms, photography, graphic and digital artforms and printmaking. Visual artists of all ages, backgrounds, and stages in their career are encouraged to apply.

### Happy Place 2.0 (East Point Reserve Artworks) Update

Gloria Richards series The Happy Place 2.0 project at East Point Reserve is well underway with three of the proposed original artworks on public furniture items now completed. Some modifications have been made to proposed locations due to significant wearing and damage identified after the original scope. Alternative locations have been confirmed within the East Point reserve which provide high visibility and variations. These include a second bench seat within the Monsoon Forest Trail and a vinyl wrap design to feature on a water tank by Lake Alexander. All artworks are sealed and graffiti coated.

Gloria infuses tones from the local ocean and bush landscape and embeds them into the design concepts, responding to where Larrakia land meets the Arafura Sea and the associated human activities and ways of being that take place in this location. Each artwork will be a site-specific construct of intricate patterns and interlocking forms that evoke the essence and energy of Darwin's vibrant tropical life and draw from a bold and varied colour palette.

The series of works are scheduled to be completed by the end of April 2024 and are party funded through a Tourism Town Asset Grant and City of Darwin.
