- c) Identify actions that City of Darwin can take to improve access and inclusion of Council's services, facilities, and programs.
- Identify gaps, issues and challenges relating to access and inclusion that City of Darwin can advocate for and/or partner with businesses, services and organisations to address.
- e) Advocate for access and inclusion through providing education and information to improve community awareness of the needs and rights of those with access and inclusion issues, through positive and proactive media, social marketing, community events, festivals, forums, and other initiatives.
- f) Keep Council informed on industry developments, standards, and legislation which can improve access and inclusion to Council services, facilities, and programs.
- g) Guide the <u>review development and</u> implementation of City of Darwin's Access and Inclusion PlanStrategy and review of existing.

### 5. MEMBERSHIP

In accordance with the *Local Government Act 2019*, the City of Darwin shall appoint suitably qualified individuals to be members of the Committee based on selection criteria related to their expertise, experience, dedication and commitment to the purpose of the group.

#### Membership provisions

- a) Up to ten eight community members, with a minimum number of six; and
- b) Four organisational memberships consisting of
  - i. National Disability Services NT (NDS NT)
  - ii. Council on the Ageing NT (COTA NT)
  - iii. Relevant/Identified Northern Territory Government representative(s)
  - iv. Identified organisation representing vulnerable members of the community which could include <u>disability</u>, refugees and/or new migrants, <u>Indigenous peoples</u>, and the LGBTQI+ community.
- <u>c) An organisational or community member is to identify as First Nations</u> representative (appropriate organisation or community member)
- e)d) One Council Member (and one Alternate Council Member)

## How can I improve access and inclusion at my event?

We've created a list of considerations below that you can implement to improve the inclusivity of the event.

## **Promotional material**

- Is there promotional material available in accessible formats? e.g. large print.
- Is the text at least a minimum of 12 point type size and is there an absence of background graphics and patterns?
- Does the invitation or promotional material list accessibility features, e.g. hearing loops, accessible parking and accessible toilets.
- Is the language appropriate? e.g. talking about 'accessible toilets and parking' rather than 'disabled toilets and parking'.
- Have you encouraged your audience to identify their access requirements? e.g. a sign language interpreter.
- Have you provided information about accessible public transport points close to the venue?

## Indoor facilities

- Is there level access to and within the venue with no steps or other barriers:
  - o From accessible parking spaces or other arrival points through the main entrance(s)?
  - To all the areas being used by participants including conference rooms, dining areas, outside areas and exhibition areas?
- Are doors easy to open and wide enough for a person using a wheelchair or scooter to get through?

- If participants have to use a lift, is it big enough for a person using a wheelchair or scooter to get in and out?
- Is there an accessible unisex toilet at the same location as other toilets, or close by?
- Is there good lighting and acoustics?
- If the venue has an inbuilt PA system, is there also a hearing loop or similar system to assist people with hearing impairment?
- Does the venue have clear signage?
- Is the venue clear of obstacles and trip hazards?
- Do guests have access to a separate, quiet area to allow them to take a break, if needed?

# **Outdoor facilities**

- Are there accessible portable toilets?
- Is there adequate accessible parking and drop off zones close to the event entrance?
- Are there clear signs to identify the location of features such as toilets, first aid points and main event spaces?
- Are there designated areas reserved for people using wheelchairs close to stages or main event areas and good paths of travel to those areas?
- Does the event layout provide for the best access and circulation?

# Staff and volunteer engagement

- Have staff been briefed on all the access provisions set in place for the event?
- Is someone responsible for addressing access issues if they arise during the event and do all team members know who that is?
- Do staff have a good understanding of appropriate ways to communicate with persons with a disability? e.g. focusing on the person, not their disability.

# Other considerations

- Are processes in place for honouring Companion cards and similar services?
- Is there a broad range of food and drink items for participants to choose from, including for those with special dietary requirements?
- Have you considered employment opportunities for people with lived accessible experience, or engaging an organisation that supports disabled employees to deliver services at the event.
- Do participants have access to the safe reporting of harassment or discrimination?

City of Darwin allocates approximately \$55 000 towards capital works as prioritised by the Access and Inclusion Advisory Committee and approved by Council each financial year.

Currently \$16,815 is committed based on this process for 2023/2024.

This report proposes additional recommendations to Council regarding the 2023/2024 Disability Access Operational budget with a total of \$14,166.

#### Access Audit of Bombing of Darwin Event – Event Day

Local disability services organisation Carpentaria have completed a site visit and supplied a letter of recommendation regarding access for Bombing of Darwin event.

To further support and supply recommendations for 2025 Carpentaria will attend the event itself to further assess and support.

#### Accessibility Seminars for local businesses - incidentals

As recommended by the committee on 5 October 2023 Accessibility Seminars for local businesses will be held at Harry's Place, 1 Willeroo Street, Tiwi. This is an accessible space with modern meeting facilities. This will accommodation 64 people for each seminar.

Seminars will be scheduled from 8am to 10am on Tuesday 19 March and Thursday 21 March 20240 Breakfast will be supplied.

The onsite Café supporting employment of people with a disability will cater for the event.

Incidental costings per seminar are:

- \$400 + GST room hire
- \$768 + GST catering at \$12 per person for 64 attendees
- \$100 tea/coffee/juice

That is a total of \$,1268.00 for each seminar, a total of \$2,536.

#### Access Guides for Parap and Nightcliff Pools

City of Darwin in line with the Access and Inclusion Advisory Committee's focus for 2024 to increase accessibility communications this project will have a detailed guide to accessing and using these City of Darwin facilities available on the City of Darwin website.

The Nightcliff Pool is available for assessment immediately. Parap pool will be assessed after the installation of a pool hoist which is scheduled for the first quarter of 2024.

On completion of the Casuarina Aquatic and Leisure Centre an access guide will be completed for this asset.

A completed guide for Nightcliff and Parap Pools has been quoted at \$5,315 each.

#### **Previous Council Decisions**

At the Ordinary Council meeting on 31 October 2023 Council endorsed the committee's following recommendation:

- 1. THAT Council transfer an amount of \$55,000 from the Disability Access Capital Projects budget to the Disability Access Operational Projects budget.
- 2. THAT Council approve the following projects to be funded from the Disability Access Operational Projects budget:
