# PURPOSE

The purpose of this report is to provide an update to the Cyclone Tracy Commemoration Advisory Committee.

#### **KEY ISSUES**

- The Cyclone Tracy Commemoration website now includes Search Engine Optimisation and a number of communication tactics have commenced.
- The podcast episodes have been drafted and are currently being reviewed.
- The signs and commemoration trail are also in progress and advice is sought from the Committee on proposed trail locations and stories.
- An exhibition will be held at the Civic Centre between November and December 2024. Feedback is sought from the Committee on additional exhibition stories.

# DISCUSSION

# Cyclone Tracy communications plan

Advertising on radio, television, and social media will commence in early October. Search engine advertising has commenced. Further communication tactics will promote the Cyclone Tracy Program throughout October and November.

#### Podcast update

Draft episodes have been approved and production elements are being finalised. The podcast will be promoted through various platforms commencing in October.

#### Cyclone Tracy interpretative signs

Three new interpretive sign locations have been added to the trail. One located at Casuarina Senior College alongside the twisted metal sculpture, one will accompany the Cyclone Tracy memorial at East Point Reserve and the third will be at Bundilla Beach and feature the kinetic sculpture. The sign company is currently working through construction and design of the sign content and installation is planned for October.

#### Cyclone Tracy commemoration trail

The audio trail is currently being developed. A narrator has been secured. Approvals will be sort shortly to add locations to the trail, outside of the interpretative sign locations. The proposed locations include:

- Museum and Art Gallery NT
- Botanical Gardens
- Old Town Hall
- Chung Wah Museum
- Christ Church Cathedral

Feedback is sought from the Committee on other proposed trail locations and stories.

# Cyclone Tracy public contributions

City of Darwin have received correspondence from survivors, family members and the general public wanting to share their memorabilia of Cyclone Tracy with City of Darwin so their memories and stories contribute to community events acknowledging and remembering the iconic natural disaster.

City of Darwin has liaised with those who have memorabilia contributions to obtain the items and the story/s behind them. These items and their stories are being curated to be displayed at the City of Darwin Community Contributions Exhibition that will be held at the Civic Centre between November and December 2024.

Some items received to date are:

- Printed photos
- Super 8 movies
- Symphony

There are some items that were not in a condition they could be used in the exhibition, and we are looking for more memorabilia in good condition with stories we can curate into the exhibition.

# PURPOSE

The purpose of this report is to provide the Cyclone Tracy Commemoration Advisory Committee with a copy of the updated Terms of Reference.

#### **KEY ISSUES**

- On 13 August 2024, Council adopted, pursuant to Section 82 of the Local Government Act 2019, to adopt the updated Terms of Reference at **Attachment 1**.
- The purpose of the Cyclone Tracy Commemoration Advisory Committee is to provide advice to Council on matters outlined in the Committee's roles and functions.
- The Committee provides recommendations to Council to enable an informed decision to be made on the delivery of a program of events and activities for the 50<sup>th</sup> anniversary of Cyclone Tracy.

#### DISCUSSION

City of Darwin is the lead organisation in the delivery of the 50<sup>th</sup> Cyclone Tracy Commemorative Program.

The Cyclone Tracy 50<sup>th</sup> Anniversary falls in the 2024/25 financial year. The Cyclone Tracy Commemoration Advisory Committee plays an important role in the planning for appropriate activities and coordination of stakeholder contributions to the program across the Darwin Municipality.

#### 5 Membership

#### 5.1 Members

Membership of the Committee will be appointed by Council.

Council will appoint suitably qualified individuals to be members of the Committee based on selection criteria related to their expertise, experience, dedication, and commitment to the functions of the group.

The Committee will, where possible, appoint a First Nations representative – either an appropriate organisation or community member.

Membership will consist of:

- up to four community members
- up to six organisational memberships consisting of:
  - o Australian Defence Force
  - o Larrakia Nation
  - o Library and Archives NT
  - o Museum and Art Gallery NT
  - o Northern Territory Government NT Major Events Company
  - o Northern Territory Government Department of the Chief Minister and Cabinet
- the Lord Mayor
- one Elected Member
- one Elected Member (alternate)
- City of Darwin Chief Executive Officer
- Member for Solomon, Mr Luke Gosling OAM, MP.

#### 5.2 Chair

The chair of the Committee will be the Lord Mayor.

The Committee Chair is responsible for:

- ensuring the good conduct of meetings in accordance with the role and functions of the Committee
- ensuring that the Committee's recommendations and actions are in line with the Terms of Reference.

The Committee chair may be called upon to represent the Committee to Council.

The Committee may appoint a Deputy Chair for the purpose of chairing a meeting if the Chair is not present.

#### 5.3 Terms and vacancies

Membership term for community and organisational members will be for two years.

Membership term of an Elected Member will be for two years, by nomination at an Ordinary Council meeting.

Membership will expire if a member does not attend three consecutive meetings without an approved leave of absence.

#### 6 Meetings

The Committee will adhere to the requirements for meetings as outlined in the *Local Government Act* 2019 (NT), *Local Government (General) Regulations 2021* (NT) and relevant City of Darwin policies.

#### 6.1 Frequency and location

Subject to direction by Council, the Committee will set its meeting schedule the calendar year prior.

The Committee will meet at least four times per year and no more than eight times annually, between February and November.

Time and location of meetings is to be determined by the Committee.

Special meetings can be convened by the Chief Executive Officer (CEO) on the request of the Chair, or a majority of committee members. The CEO will then issue a Notice of Meeting with the time, date and location, and the items to be discussed at the special meeting.

#### 6.2 Voting

For voting purposes, the Chairperson will accept motions moved and seconded by members of the Committee, by show of hands.

A Committee decision is by majority vote of voting members present at the meeting.

A majority vote is half plus one of the members present.

Each member present has, and must exercise, one vote on a question arising for decision at the meeting.

The Chair must exercise, in the event of an equal number of votes, a second or casting vote.

#### 6.3 Secretariat

City of Darwin will provide secretarial services to the Committee. This includes assisting the CEO to ensure:

- the business papers are distributed no later than three business days prior to a meeting and are available on the website
- proper minutes are kept and ensure that they are tabled at the next meeting of Council
- a copy of the minutes is, within ten business days after the date of the meeting to which the minutes relate, available on the website.

#### 6.4 Meetings

Meetings are open to the public unless confidential business is being considered.

Observers with specialist skills and experience may also attend by invitation of the Committee and/or Council.

#### 6.5 Committee Term

The term for the Committee will be up to a period of two years.

#### 7 Quorum

Quorum consists of a majority, being half plus one of its members holding office at the time of the meeting.

#### 8 Code of conduct

All Committee members are required to abide with Schedule 1 Code of Conduct of the *Local Government Act 2019* (NT).

This includes the requirement to declare gifts and/or benefits.

#### 9 Conflict of interest

Committee members must declare any real or perceived conflicts of interest when joining the Committee. Conflicts of Interest must also be identified at the start of each meeting in which a member has a conflict of interest on a matter.
