THIS REPORT IS PRESENTED BY THE CHAIR OF REMEMBERING CYCLONE TRACY INC (RCTI)

UPDATES

- Significant feedback has been received, either through comments on the Cyclone Tracy Survivors Facebook Page which is approaching 6,000 members, or through personal approaches or emails.
- The RCTI committee has settled on a commemorative period of nine days from Monday, 23 December to Tuesday, 31 December 2024. While RCTI committee recognises the many reasons put forward why this is a difficult time, those who plan to either return or participate in the planned events believe this is the most relevant and appropriate time.
- A major continuing project of the RCTI committee has been to identify and register survivors of Cyclone Tracy, both direct and indirect, wherein this particular group is identified as the Cyclone Tracy Survivor Community.
- To date, more than 900 survivors have registered and numbers are increasing by an average of five to ten a day.
- To extend the range of our appeal for registrations, RCTI is in the process of commissioning a short promotional video to be offered to news media organisations around Australia and the world in the hope of reaching out to more survivors who are still living outside Darwin.
- RCTI is in the process of developing a personal identity card to be issued to every survivor which will allow those who return to access a range of discounts on food, accommodation, tourism and other services that we hope to negotiate with Darwin businesses.
- RCTI has already begun the process for having a Commemorative Coin printed by the Royal Mint and the Northern Territory Government has accepted the proposal for the issuance of a Commemorative Number Plate.
- RCTI has a number of printing proposals, including posters, bumper stickers and stationery required for administrative purposes and the local company, ZipPrint, has kindly agreed to provide said printing as part of a wider donation package.
- Qantas Airways Ltd has likewise offered promotional airfares worth \$20,000.
- RCTI have received a Northern Territory Government Minor Grant of \$15,000 to fund both the promotional video and some administrative support.

• The local company, Halikos Group, has made a significant donation and RCTI is still seeking funding from other sources as well, including through Facebook and our supporter base, to continuously promote our proposed program of activities.

Proposed Program of Activities of RCTI are as follows:

- a welcome function on 23 December 2024
- a possible theatrical event
- a potential Christmas lunch
- bus tours taking in sites of relevance to survivors
- exploring options for merchandise using '*Remembering Cyclone Tracy*' logo
- offer the use of said logo to City of Darwin for use in its commemorative projects, including the plaques, which are currently under discussion, and
- possible production of banners, in collaboration with City of Darwin.
