#### **PURPOSE**

The purpose of this report is to inform the committee of the outcome of the recent City of Darwin elections and the membership of the 24th term of Council.

#### **KEY ISSUES**

- On 23 August 2025, City of Darwin elections were held for Lord Mayor and elected representatives across all wards.
- On 6 September 2025, the NT Electoral Commission announced the appointment of the new Lord Mayor and six new Elected Members with seven Elected Members returning for an additional term.
- On 30 September 2025, at their first Ordinary Council meeting, the Council made appointments to Council Executive and Advisory Committees.

#### **DISCUSSION**

On 23 August 2025, City of Darwin elections were held for 24th term of Council for the City of Darwin. The elections were for Lord Mayor and Elected Representatives across all wards. City of Darwin local government area is made up of a Lord Mayor and four wards with each ward having three elected representatives.

On 6 September 2025, the NT Electoral Commission announced the appointments of City of Darwin Council representatives.

- The new Lord is Mayor Peter Styles.
- Chan Ward is represented by two returning Elected Members Councillor Peter Pangquee and Councillor Ed Smelt and a new Elected Member Councillor Julie Fraser.
- Lyons Ward is represented by two returning Elected Members Councillor Sam Weston and Councillor Mick Palmer and a new Elected Member Councillor Nicole Brown.
- Richardson Ward is represented by one returning Elected Member Councillor Jimmy Bouhoris and two new Elected Members - Councillor Shani Carson and Councillor Edwin Joseph.
- Waters Ward is represented by two returning Elected Members Councillor Sylvia Klonaris and Councillor Kim Farrar and one new Elected Member Councillor Patrik Ralph.

#### **DISCUSSION**

An update is provided to the Committee on current items associated with Darwin Military and Civilian History Advisory Committee.

#### **Cor Infinitus Memorial**

The Cor Infinitus memorial has been installed adjacent to the Darwin Oval Carpark on the Esplanade, honouring veterans and first responders who tragically lost their lives to suicide after serving our nation and community.

Key features include a path, a shaded reflection bench, and a commemorative plinth.

Delivered in partnership with the Darwin Military and Civilian History Advisory Committee. The project was developed through consultation with local stakeholders and veterans' groups. It was supported by City of Darwin's Better Suburbs Program and funded in part by the Northern Territory Government's Veterans Engagement and Support program.

Images of the reflection bench and Cor Infinitus Memorial are below.







An unveiling ceremony will be held and is being arranged by Veterans Engagement and Support, Department of People Sport and Culture. Details of the ceremony will be provided to committee representatives once confirmed.

#### **WWII Interpretive Signage Replacement Project**

#### Stage 1

In 2024, due to their poor condition, City of Darwin replaced eight interpretive signs at the war relics at East Point across from the Darwin Military Museum. The eight signs replaced were:

- No. 1 9.2-inch gun emplacement
- Cordite magazine
- Engine room and tower base
- Underground searchlight engine room
- RH 6-inch gun emplacement
- Semi-underground magazine x 2
- Right Hand tower
- Armourer's hut

#### Stage 2

In 2025 stage 2 commenced with a further ten interpretive signs identified for replacement at East Point and Dudley Point. To update the committee, City of Darwin has completed the installation works. The ten interpretive signs that have been replaced are:

- Fannie Bay 'Ack Ack'
- Interstice ... or just an empty space
- Pee Wee ... is it a bird?
- Powering on ... a futile excavation
- The boom net ... harbour gatekeeper
- New guns ... guarding the boom
- Y' Watch ... what's in a name?
- Lighting up ... the shining lights
- Going underground ... limiting the damage

• Out on a reef ... a watery watch
