DISCUSSION

Copyright License Agreements

A priority within our Creative Strategy 2024-2030 is Celebrating Larrakia. This focus areas seeks to elevate stories, culture, and creativity through increased audience exposure. A related goal is setting up annual commissioning agreements with Larrakia artists.

In consultation with Larrakia Nation Aboriginal Corporation, Arts Officers have established copyright agreements with local creatives for use of artworks across a variety of Council projects. The team is excited to work with Keelan Fejo, Taleena Lui Villaflor and Fabian McLennan and a selection of their original works. Further public art projects have engaged the use of these artworks. The Arts Officer worked with Libraries to include local artist's work on two recent projects:


Dalay Reading Club

In December, Libraries launched a new reading club for children named after the Larrakia word for the monsoon season (Dalay). Taleena Lui-Villaflor's work *'Three Green Sea Turtles (Doedleera)'* features on the Dalay Reading Club forms, posters and incentives for young readers to engage with throughout the program. Taleena is a proud Larrakia woman and artist. Taleena began creating and making art when she was young and has learnt many of her designs and styles from her grandmother.

New Library Card Design

Fabian McLennan's Dangalaba (crocodile) motif from his artwork '*Mix Dreamings of Larrakia & Tiwi Connections*' is set to be included on a new print run of library cards. Fabian's artwork represents his Larrakia and Tiwi family connections and hunting. Fabian is a Larrakia man through his father and Gurindji man through his mother. He inherited the name 'Pompa' by his late father and Larrakia Elder George McLennan. His father was part of the Stolen Generation,



represent the Bush turkey and Crocodile eggs, with the Shovel Spears representing the Tiwi connection and used for Ceremonies and stories.

Smith Street Public Art Project

Announcements were made on 10 February regarding the five artists selected for this public art opportunity. Denise Quall is one of the selected artists and her work Hermit Hustle will be installed as a road mural on the intersection of Searcy and Smith Streets later this year during the redevelopment. The selection of the artists was undertaken by an independent panel of experts ranging from MAGNT, commercial gallery, First Nations Creative Agency, freelance artist and Charles Darwin University Arts Lecturer.

Community Grants program – NAIDOC and Reconciliation funding

City of Darwin's NAIDOC Week and Reconciliation Week Funding is back for 2025. The grant round opens on 1 March and closes on 31 March. There is \$50,000 in funding to support activities taking place during NAIDOC Week 2025 and Reconciliation Week 2026.

Applicants can apply for grants of \$5,000 - \$10,000 and must be First Nations Organisations that are registered with the NT Indigenous Business Network or Supply Nation.

Priority is given to activities that:

- celebrate Larrakia or other First Nations achievements or history
- connect community and encourage participation.
- actively promote Reconciliation.
- have broad community engagement and participation

In 2024 this funding supported three exciting projects:

- Impact North Reconciliation Week Changemaker Event: a series of networking and upskilling events for Aboriginal business leaders
- Guyugwa BlakHouse @ Brown's Mart: a NAIDOC celebration weekend featuring exhibitions, healing, workshops and performances
- Story Indigenous Mural: a mural by artist Shaun Francis celebrating the contribution of Indigenous players to Wanderers Football Club

Reconciliation Week programming and engagement

Early conversations are underway with a First Nations Darwin Event company to work with City of Darwin delivering Reconciliation Week activities this year. There will be both internal events for City of Darwin staff including a BBQ at the Operations Centre and external events hosted at Civic Centre and through our Libraries.

Library programming

In addition to the updated Library card and Dalay Reading Club activity outlined above the Library Family and Children's program have scheduled a number of actions in the coming month to support community engagement and learning. These include the following:

An author's talk by Dr Tracy Westerman AM, leader in First Nations mental health and author of Jilya, will be delivered at CDU's Casuarina campus on 20 March.

The Libraries Cultural Connections Collection continues to grow, and the team are promoting its use across all our library facilities.

Larrakia online training

Moogie Downs have been contracted to undertake the development of a Larrakia online training package for City of Darwin in partnership with Larrakia Nation Aboriginal Corporation.

City of Darwin wish to support the creation of an online module for use by its staff and for Larrakia Nation Aboriginal Corporation's broader use. The creation of this online module will deliver on commitments made through City of Darwin's Innovate Reconciliation Action Plan August 2023-July 2025, specifically:

• Promote reconciliation through our sphere of influence

• Increase understanding, value and recognition of First Nations cultures, histories, knowledge, and rights through cultural learning

This project is expected to be delivered by mid-June 2025.
