PURPOSE

The purpose of this report is to provide an update on City of Darwin's NAIDOC 2025 and Reconciliation Week 2026 Grants program.

KEY ISSUES

- On 1 March 2025 City of Darwin opened our NADIOC 2025 and Reconciliation Week 2026 grant program. This is the second year of this program which grew out of our Innovate Reconciliation Action Plan August 2023 July 2025.
- On 31 March applications closed.
- The first round in 2024/25 received 4 eligible applications.
- This second round in 2025/26 received 8 applications.
- The NAIDOC and Reconciliation Week grant program runs alongside City of Darwin Community Grants and has up to \$50 000 quarantined under the NAIDOC and Reconciliation Week category.
- Applications are currently being assessed, with recommendations to go to Council in late May.

DISCUSSION

As part of City of Darwin's commitment to strengthening relationships with First Nations organisations, advancing reconciliation and celebrating NAIDOC in 2024 we created a new program for NAIDOC and Reconciliation Week Grants.

On 1 March 2025 City of Darwin opened our NADIOC 2025 and Reconciliation Week 2026 grant program. This is the second year of this program. On 31 March applications closed.

The first round in 2024/25 received 4 eligible applications. This 2025/26 round received 8 applications, showing an increase in activity and knowledge of these grants.

The NAIDOC and Reconciliation Week grant program runs alongside City of Darwin Community Grants and has up to \$50 000 quarantined under the NAIDOC and Reconciliation Week category. Applicants to this category must be First Nations businesses or organisations and registered with NT Indigenous Business Network or Supply Nation.

Applicants can apply for \$5 000 - \$10 000 to deliver activity across NAIDOC or Reconciliation Week.

The priority areas across these grants include activities that:

- Celebrate Larrakia or other First Nations achievements or history
- Connect community and encourage participation
- Actively promote Reconciliation
- Have broad community engagement and participation

A panel of assessors are trained across the organisation to assess applications for both Community Grants and the NAIDOC and Reconciliation Week Grants with representation from First Nations staff.

Applications are currently being assessed, with recommendations to go to Council in late May.

Applications received covered a wide variety of activity including Cultural and Family Fun Days, Sporting activities, Leadership Development, Sewing workshops, services anniversary event. Once recommendations have been endorsed by Council the Committee will be updated on the status of successful applications.

PURPOSE

The purpose of this report is to provide the committee with an overview of City of Darwin's Reconciliation Week events.

KEY ISSUES

- Reconciliation Week dates for 2025 are 26 May to 31 May, this year's theme is Bridging Now to Next.
- This year City of Darwin have engaged Northern Territory Indigenous Business Network (NTIBN) member XhalEvents as an event delivery partner for 3 key activities across Reconciliation Week.
- Activities include Monday 26 May lunchtime event at Raintree Park, Thursday 29 May staff only Breakfast BBQ event at Operations Centre and Saturday 31 May Family event at Casuarina Library.
- In addition to the Reconciliation Week events programs City of Darwin have supported a Pre event Darwin Beach Choir Voices for Reconciliation at Darwin Ski Club on 11 April.

DISCUSSION

Reconciliation Week dates for 2025 are 26 May to 31 May, this year's theme is Bridging Now to Next. As part of our Reconciliation Action Plan City of Darwin is committed to organising at least one National Reconciliation Week event each year.

This year City of Darwin have engaged NTIBN member XhalEvents as an event delivery partner for 3 key activities across Reconciliation Week.

Activities include:

- Monday 26 May lunchtime event at Raintree Park
- Thursday 29 May staff only Breakfast BBQ event at Operations Centre
- Saturday 31 May Family event at Casuarina Library

All activities are free and the activities on Monday and Saturday will be advertised widely through networks and the marketing, communications and engagement team of City of Darwin. Promotions include direct email campaigns, electronic screens in customer services and libraries, postcards, social media and media releases.

Each event engages First Nations facilitators and providers as a priority.

Monday 26 May Raintree Park will include a performance by singer songwriter Jaxon De Santis, the Thursday 29 Operations Staff closed event will also have guest speakers from 1% - Jaidah Vigona and Dante Rodrigues highlighting mental health programs for young First Nations men and the Casuarina Library event on Saturday 31 will include creative and cooking workshops by artists Shaun Lee and Danella Lee as well as a smoking ceremony and the Darwin Beach Choir teaching a First Nations song to children.

Copies of promotional material will be distributed via email with hard copies available in the meeting.

In addition to the Reconciliation Week events outlined City of Darwin supported a Pre event – Darwin Beach Choir – Voices for Reconciliation at Darwin Ski Club on 11 April. Support provided for this event included the engagement and payment for Welcome to Country and Didj playing by Uncle Roque Lee through Larrakia Nation Aboriginal Corporation and the engagement of First Nation's Production Company Moogie Downs to develop the film clip for inclusion in the national Reconciliation Australia program – Voices for Reconciliation.

The final edit of this clip will be played at the meeting.

Since the previous reporting period, actions which were reported across multiple years have been consolidated into single reportable actions and duplicates have been removed from the system. 76 actions were active or due during 2023/24 and as per status graphic below: 22 actions have been completed, 45 are on track, 7 are listed as monitor, and 2 are listed as off track. One action is not due to commence until 1 July 2024.

1. Welcome and Acknowledgement of Country

Nicole Browne delivered a Welcome to Country, acknowledging the Traditional Custodians of the land and paying respects to Elders past and present.

2. Opening Remarks and Purpose of Meeting

Jason Elsegood, facilitator of the session, welcomed attendees and outlined the objectives of the inaugural meeting. The purpose was to bring together stakeholders interested in reconciliation across the Northern Territory and to begin shaping the structure and direction of a coordinated reconciliation initiative.

3. Presentation of Discussion Paper

Jason presented key points from the discussion paper, which explored:

- The current landscape of reconciliation activities in the NT
- Opportunities for coordinated action
- Possible structures for a representative reconciliation body
- Guiding principles and immediate priorities

4. Discussion and Outcomes

4.1 Preferred Legal Structure

There was a unanimous consensus with all attendees that an Incorporated Association is the most appropriate legal structure.

Attendees agreed that this model:

- It is simple and accessible to establish
- Keeps compliance manageable
- Aligns with the group's early-stage needs and grassroots nature

4.2 Group Support and Engagement

Strong support was expressed for the formation of the group. Attendees were enthusiastic about having ongoing collaboration. All participants requested to be kept informed and involved as things progress.

4.3 Urgency and Reconciliation Week

The group voiced a strong desire to move forward quickly, with Reconciliation Week only six weeks away. The sense of urgency was supported by a shared commitment to begin creating visibility and action around reconciliation in the NT.

5. Agreed Interim Actions

Cross Cultural Consultants (CCC) will:

- Continue to coordinate and facilitate the group during the establishment phase.
- Act as the central point of contact for communication and administration.
- Receive and share Reconciliation Week events from members to support broader promotion and participation.

6. Next Steps

1. Letter of Commitment: Jason Elsegood will draft and circulate a Letter of Commitment for organisations to sign, pledging their support for the formation of the group and its objectives

2. Legal Entity Registration: Jason will initiate the process of registering an Incorporated Association under the name: Reconciliation Northern Territory

3. Communication and Planning: A follow-up meeting will be scheduled shortly to maintain momentum, coordinate Reconciliation Week activities, and progress the formal establishment.

7. Close of Meeting

Jason thanked all attendees for their engagement, insights, and enthusiasm. He reaffirmed the importance of the work ahead and the collective energy already building.
