BACKGROUND

Darwin Fusion 2025

Darwin Fusion, held on the 22 and 23 May 2025, was a two-day program that celebrated and promoted the important role that local government and Sister and Friendship City partnerships have in increasing business, trade, investment and people-to-people links between Darwin and our international partners.

The program included:

- Delegate Saltwater Welcome Ceremony at 6:00 pm, on 21 May 2025 at Waterfront Lagoon.
- 2025 International Relations Conference from 9 am to 4:30 pm on 22 May 2025 at DoubleTree Hilton on The Esplanade.
- Networking Dinner from 7pm on 22 May 2025 at DoubleTree Hilton on The Esplanade.
- 2025 Darwin International Trade Show from 9 am to 1:30 pm on 23 May 2025 at DoubleTree Hilton on The Esplanade.
- Minister for Trade, Business and Asian Relations VIP reception at the Parliament House from 3:00 pm – 4:00 pm on 23 May 2025.
- Garramilla International Food Fair from 5 pm on 23 May 2025 at Bicentennial Park, The Esplanade.

The Trade Show and Food Fair were open to the public and promoted across Northern Territory media and City of Darwin and Discover Darwin web pages and social media channels. The Conference and Networking Dinner were invite-only events for local, interstate, and international delegates.

EVENT BRIEFING

2025 International Relations Conference

The conference was attended by over 140 international, interstate and local delegates, including:

- Ambassadors of China, Vietnam, Greece, and the High Commissioner of India and their diplomatic staff
- Consul General of Timor Leste
- Consul and Head of Post of the Consulate of the Republic of Indonesia in Darwin and their diplomatic staff

- Lord Mayors and Mayors
- City of Darwin Elected Members
- Members of Parliament
- international government, business, industry, educational and academic representatives, and
- community organisations, including from Ambon, Indonesia; Denpasar, Indonesia; Dili, Timor-Leste; Guangzhou, China; Ho Chi Minh, China; Saumalaki, Indonesia.

The conference had keynote addresses from the following:

- Ambassador of China
- Ambassador of Greece
- Ambassador of Vietnam
- the High Commissioner of India
- Consul General of Timor Leste, and
- Consul and Head of Post of the Consulate of the Republic of Indonesia in Darwin.

Each speaker presented on the importance of international partnerships in growing trade and investment between our respective regions and the value that local governments and Sister/Friendship Cities have in the development of such relations.

There was a breakout session at the conference, where delegates engaged in meaningful dialogues and knowledge sharing regarding the benefits and opportunities of international and Sister City frameworks.

Some of the most engaging topics included:

- building meaningful international relationships between Sister Cities
- measuring the value of international city relationships
- arts and cultural exchange and transitioning to commercial businesses
- sharing knowledge and expertise in alternative energy and transition to low/zero/carbon positive industries, and
- fostering continual improvement and innovation between Sister Cities.

The Lord Mayor also had one-on-one meetings with the Ambassador of China, Ambassador of Vietnam, Ambassador of Greece and High Commissioner for India, where they discussed opportunities to broaden and strengthen Darwin's trade and investment opportunities through our local government, Sister and Friendship City partnerships.

The conference received local and international news coverage, including 500 million views across 190 countries and territories for Phoenix Satellite TV.



2025 Darwin International Trade Show

The second day of the program focused on the 2025 Darwin International Trade Show. Over 50 stalls showcased products and services across tourism, hospitality, arts and culture, wholesale and retail trade, training and education, scientific, migration, human resources, not-for-profit, manufacturing, information technology and agriculture.

The Trade Show facilitated business-to-business connection and business and industry promotion between local and international product and service providers and customers, to strengthen trade and investment opportunities.





Garramilla International Food Fair

Hosted in partnership with Larrakia Nation Aboriginal Corporation, the Garramilla International Food Fair was attended by over 1,500 interstate, international and local community members.

Thirteen food stalls participated in the Food Fair, showcasing the diversity of Darwin's multicultural cuisine. Additionally, there was 12 cultural performances from local and international cultural and community groups that promoted our strong international ties, our multicultural community groups and organisations, and demonstrated the rich culture and heritage of Larrakia and First Nations peoples. Attendees had the opportunity to engage and develop a deeper understanding and appreciation of the Larrakia people and Darwin's multicultural identity.







9.3 UPDATE ON THE FRIENDSHIP CITY PROPOSAL WITH THE CITY OF KOCHI, INDIA.

BACKGROUND

The Sister City Advisory Committee resolved at a Committee meeting on 11 February 2021 to recommend that City of Darwin engage with the local Indian community and business groups in identifying an opportunity for a Friendship City Relationship with a city in India.

PURPOSE

The purpose of this report is to present an update on the progress for the resolution to progress engagement with the City of Kochi towards the development of a Friendship City Relationship with City of Darwin.

KEY ISSUES

- In 2021, City of Darwin conducted community group engagement to identify opportunities and recommendations for an appropriate Friendship City candidate in India.
- City of Darwin engaged with the Darwin Malayalee Association who provided recommendation that the City of Kochi in India would be an appropriate candidate for consideration.
- The City of Kochi is a major port city on the south-west coast of India bordering the Laccadive Sea, a part of the Arabian Sea. The City of Kochi and its outer regions have a total population of approximately 3 million. Kochi is the Indian state of Kerala's financial, commercial and industrial capital, and one of the fastest-growing second-tier metro cities in India.
- The City has international trade connectivity via an international Airport and Port. Darwin and Kochi share similarities in their tropical climate, strategic positioning as trade hubs into Asia, and multicultural communities.
- Following initial discussions with the Darwin Malayalee Association and the City of Kochi Government, in July 2022 the Lord Mayor of Darwin sent a letter to then Mayor of Kochi Municipal Corporation, inviting Kochi Municipal Corporation to enter into a Friendship City relationship with Darwin. The letter highlighted partnership opportunities across education, economic and professional exchanges. However, progress on formalising a partnership stalled after 2022.
- In 2025, during Darwin Fusion's International Relations Conference, the Lord Mayor met with the High Commissioner for India where they discussed the opportunities to revitalise dialogue regarding the development of a Friendship Partnership between City of Darwin and City of Kochi.

- Following the meeting, the Lord Mayor received correspondence from Adv. M. Anil Kumar (Mayor, Kochi) Chairman, Centre for Heritage, Environment and Development to formally propose the establishment of a Sister City relationship between the City of Kochi and the City of Darwin.
- The Mayor of Kochi highlighted the below areas of cooperation:
 - Foster people-to-people links through cultural, educational, and youth exchange programs.
 - Support trade and investment between India and Northern Australia, especially in sectors like maritime logistics, renewable energy, and digital innovation.
 - Collaborate on urban policy, including climate resilience, coastal protection, smart city planning, and sustainable tourism.
 - Encourage institutional and academic partnerships between universities, research organisations, and training institutes.
 - Promote the creative arts, including festivals, traditional crafts, film, and food exchanges.
- In accordance with City of Darwin's international relations processes, we will seek to establish a Friendship City memorandum of understanding with the City of Kochi as a first step forward in our partnership.
