PURPOSE

The purpose of this report is to propose the meeting schedule for the Tree Advisory Committee for 2026 up to 30 June 2026.

KEY ISSUES

- In accordance with the adopted Terms of Reference for the Tree Advisory Committee, the Committee will set its meeting schedule for the upcoming calendar year.
- The date, time and location of meetings are to be determined by the Committee.
- To assist, proposed dates, times and locations are outlined in this report for consideration by the Committee.
- At the Council meeting held on 30 September 2025, Elected Members requested a review of the Advisory Committees and respective terms of reference. Consequently, meetings will be scheduled up to 30 June 2026.
- Construction of the Civic Centre progresses and is adjacent to the City of Darwin meeting rooms, possibly causing construction noise when meetings are happening. A change of venue is therefore proposed.

DISCUSSION

The Terms of Reference for the Tree Advisory Committee (Clause 6.1) advise that the committee meet at least four times per year and no more than eight times annually between February and November.

Dates, time and location of the Tree Advisory Committee meetings are to be determined by the committee. The proposed dates and times presented in this report are for endorsement or discussion of alternative dates and times as determined by the committee. The proposed dates and times are in accordance with the adopted 2024 and 2025 meeting schedules.

In proposing the dates and times for the Tree Advisory Committee, it is noted that the Civic Centre Bidjpidji (meeting room 1) may be impacted by construction noise due to the adjacent construction activities. Car parking availability in the area of the Civic Centre can also be difficult to find quickly and easily. It is therefore proposed the meetings will be held at the Operations Depot, 65 Bishop Street, Woolner. There is free and accessible car parking on site, however committee members will be required to wear covered footwear.

It is noted that attendance at the meetings will be offered in person and via Microsoft Teams.
