KEY ISSUES

- The Animal Management Advisory Committee (AMAC) has concluded its consideration of the animal management plan and made several recommendations.
- Council to be measured on achieving the goals laid out in formation of the committee
- Increased education was a major theme
- Socially responsible pet ownership was the key message
- The by-laws (**Attachment B**) require amendment to provide quantifiable definitions for issues such as barking nuisance.
- Dogs rushing at fences are a nuisance issue that is not easily improved.
- Definition of a community complaint and greater education on Council process will enable swifter resolution of issues under complaint.

SUBJECT: REVIEW OF ANIMAL MANAGEMENT PLAN

DISCUSSION

The Animal Management Advisory Committee (AMAC) reviewed Council's Animal Management Plan and By-laws to ensure they reflect contemporary community expectations around a number of aspects of animal management, including but not limited to:

- Number of dogs per residence
- Licences to keep more than 2 animals
- Number of dogs in neighbourhoods
- Definition of 'nuisance'
- Containment of cats

The Animal Management Plan (the Plan) has served Council well as a practical guide to the Council's animal management by-laws. It was noted however that the plan is often misread and open to differing interpretations by the public.

Additionally the Plan does not appropriately communicate future direction and goals for contemporary animal management practices within the municipality. The Committee considered that the Plan does not communicate to the owners of dogs and cats their responsibilities in an effective fashion.

AMAC recommends that the Animal Management Plan be replaced by an animal management strategy (the strategy) to be developed over the next six months and then widely disseminated for public feedback prior to adoption.

The strategy could include many requirements to demonstrate a progressive animal management policy. It will also ensure that budgetary requirements are fully considered and forecast to achieve the outcomes sought by the document. A four year strategy would allow Council to measure its success, be appropriately scored on achieving its goals and allow for transparency within the community on how key issues are being managed.

<u>Issues</u>

Education was a major theme from the members of AMAC; it was identified that many issues could be targeted via education and advertising initiatives, to clearly demonstrate what socially responsible pet ownership looks and feels like to the community.

Socially responsible pet ownership was the key message AMAC wanted to encourage and future branding should reflect this message. Events such as desexing days and awareness surrounding cat ownership at peak registration periods were all seen as positive drivers to begin to change the perceived attitude around animal ownership in the City of Darwin municipality.

It was generally accepted that the by-laws are adequate and do not require major changes except in the area of nuisance. The by-laws require quantifiable definitions for issues such as barking nuisance.

It was identified that individuals in the community have varying tolerances regarding noise and dogs or cats in general. Dogs rushing at fences are a nuisance issue that requires review, however given the alignment of property boundary fences within the municipality the issue is not easily addressed.

As Council acts for the community as a whole, defining what a community complaint is was seen as a beneficial way to alleviate instances of an individual being able to make unreasonable complaints. Partnered with an improved nuisance definition and greater education on Council process this is seen to enable swifter resolution of issues under complaint.

Cat control is an emergent issue. Again education is seen as a key priority along with improved service provision for access to traps. An incorporated collection opportunity has been identified as an avenue for consideration. AMAC considered that overarching Northern Territory legislation that dealt with the regulation of the sale/giving away of dogs and cats should be pursued.

Opportunities

Technology was seen as an agenda that required further exploration to provide greater infield opportunities for officers and the members of the public to resolve and document issues.

Fees and charges were seen as effective levers to encourage desexing and coupled with planned opportunities, such as community events, it was envisaged that it would see more animals registered within the city at a lower cost.

AMAC recommends the 2016/17 fees be reviewed to include:

- Demonstration of benefits for registered animals
- Increased fees for entire animals
- Increased discounted fees for de-sexed concession/ pension card holders
- Removal of concessions for entire dogs for pensioners and concession card holders - three year phase out period
- Creation of a new fee for members of a recognised feline association in line with fees for members of a recognised canine association
- Refundable deposit for anti-barking collars, in line with the refundable deposit for cat traps.

Greater rewards for having a registered animal were flagged, including greater opportunities to obtain animals after hours without additional charge for registered animals. Investigation of initiatives such as a voucher system to access better animal welfare services for owners of registered animals via partnerships with local vets and service providers is to be investigated.

Considerations

For the community's benefit the process between the future direction and goals of animal management and the enforcement activities of the Regulatory Services section in relation to animal matters required clarification or separation.

It was considered that a comprehensive enforcement policy and guidelines should be developed and published on Council's website to provide a broad understanding of how Council will approach enforcement.

A comprehensive compliance policy would ensure all parties were aware of their responsibilities and demonstrate that Council officers conduct a fair and diligent investigation of reported issues and that the principles of natural justice are followed in any investigation to ensure a fair decision is reached.

1 Policy Summary

This Policy addresses:

- Animal Management Plan,
- Pets in Drains
- Cat Registration
- Number of Cats Allowed
- Dangerous Dogs

2 Policy Objectives

The policy provides direction in the application of the City of Darwin (Animal Management) By-laws.

3 Background

Animal management is an important function of the Council. Registration of dogs and a By-law dealing with dogs has been in force for many years. The By-law was last reviewed in 2007 and new provisions added dealing with Cats.

4 Policy Statement

Part A Animal Management Plan

Council Policy is to adopt an Animal Management Plan from time to time. The current Animal Management Plan is appended to this policy.

Part B Pets in Drains

It is not Council policy to extract pets from drains. The responsibility for pets entering and being removed from drains lies with the owner.

In special cases where Council assistance is required a minimum fee will be charged to the owner on an hourly basis.

Part C Cats

Registration

Pursuant to By law 56 (4) Darwin City By-laws (Part 3 Animal Management) that it be a requirement of registration that dogs and cats over the age of three months be fitted with an approved permanent electronic subcutaneous implant from 1st October 2008.

Number of Cats Allowed

Pursuant to By law 58 (1) City of Darwin By Laws (Part 3 Animal Management) for the period 1st July 2008 to 30th June 2009 the number of cats or class of cats per premises shall be unlimited.

From 1st July 2009 pursuant to By law 58 (1) City of Darwin By Laws (Part 3 Animal Management) the number of cats or class of cats per premises shall be two (2) excluding those cats registered in 2008/2009.

Part D Dogs

Dangerous

Council will control dangerous dogs through the existing by-law provisions rather than making a new by-law to ban particular breeds of dog.

A Declared Dogs Register onto which dogs which breach by-laws in relation to at large, attack and menace are entered has been established pursuant to By law 55 of City of Darwin By Laws (Part 3 Animal Management).

Exercise Areas

THAT pursuant to By law 62 (1) City of Darwin By Laws (Part 3 Animal Management) all parks, reserves, gardens and beaches under Council's care and control with the exception of East Point Reserve be declared dog exercise areas and that no ovals are exercise areas. That the buffer zone adjoining Lee Point Road is a dog exercise area. That bitches in oestrus are not permitted in exercise areas.

Conditions for the use of these areas are:

- In exercise areas dogs shall be accompanied by the owner.
- In exercise areas dogs are not required to be restrained by a lead unless organised sporting activities are in progress or the dog is within 10 metres or as otherwise sign posted of playground equipment or barbecue facilities or the dog is being exercised on a cycle or pedestrian path within the area.
- In exercise areas dogs will not contravene any provisions of Part 3 City of Darwin By Laws (Part 3 Animal Management) .
- Owners must act in accordance with any signs relevant to particular areas.

Impounding Extension

For the purpose of By-law 80 of the City of Darwin By Laws (Part 3 Animal Management) dogs at large which are unregistered or unidentified or registered dogs which are unable to be returned to an owner are impounded.

All dogs impounded shall be held for four (4) working days after the expiration of which time the pound manager may arrange for the destruction or disposal of the dog.

Licences To Keep More Than Two

THAT pursuant to By law 58 (1) City of Darwin By Laws (Part 3 Animal Management) that the number of dogs, declared dogs, class of dogs per premises shall be two (2).

Licences for exemption from these provisions are to be viewed as a concession rather than a right and will be granted only after thorough consideration. New applications for licences to keep more than five dogs in a residential area will not be granted.

Registration Fees

In setting dog registration fees Council will provide concessions for aged and invalid pensioners and owners who are members of the NACA. Only one concession will apply per dog.

Where a registered dog dies or leaves the municipality in the first six months of registration for the financial year, registration fees may be refunded on a pro-rata basis.

Where a licence to keep more than two (2) dogs has been issued for the financial year and is no longer required within the first six months of issue, licence fee may be refunded on a pro-rate basis.

Where a dog is de-sexed in the first six months of registration the registration fee for an entire dog may be refunded on a pro-rata basis.

Electronic Tags - Registration Requirement

Pursuant to By law 56 (4) City of Darwin By Laws (Part 3 Animal Management) that it be a requirement of registration that dogs and cats over the age of three months be fitted with an approved permanent electronic subcutaneous implant from 1st October 2008.

Restriction Areas

Dog exclusion areas:

- The Mall is a dog exclusion area at all times.
- The East Point Reserve from the area bounded by the entry gateway and Lake Alexander fence is a dog exclusion area at all times.
- THAT pursuant to By law 62 (2) (a) City of Darwin By Laws (Part 3 Animal Management) the markets whilst operating are dog restricted areas.
- THAT pursuant to By law 62 (2) (a) City of Darwin By Laws (Part 3 Animal Management) all playgrounds and the area within 10 metres of any playground is a dog restricted area.
- THAT pursuant to By law 62 (2) (a) City of Darwin By Laws (Part 3 Animal Management) all public BBQs and the area within 10 metres of any public BBQ is a dog restricted area.

5 Legislation, terminology and references

Part 3 (Animal Management) City of Darwin By Laws.

Excerpt City of Darwin By-Laws

71 Dog causing nuisance

- (1) A dog is a nuisance if the dog:
 - (a) is habitually at large; or
 - (b) makes a noise, by barking or otherwise, that:
 - (i) persistently occurs; or
 - (ii) continues to such a degree or extent that it unreasonably interferes with the peace, comfort or convenience of a person in another premises; or
 - (c) chases or runs at:
 - (i) a person (whether or not the person is on foot or otherwise and whether or not there is a fence or other barrier between the person and the dog); or
 - (ii) an animal (other than in the course of droving, tending, working or protecting stock); or
 - (d) is offensive or endangers the health of a person or animal (other than in the course of droving, tending, working or protecting stock); or
 - (e) causes damage to anything outside the premises where the dog is usually kept.
- (2) If a dog is a nuisance, the owner of the dog commits an offence.
- (3) If an authorised officer is satisfied that a dog is a nuisance, the officer may serve on the owner of the dog:
 - (a) a notice requiring the owner to have the dog complete the training specified in the notice within the timeframe specified in the notice; or
 - (b) an order requiring the owner to prevent the behaviour specified in the notice.
- (4) An order under clause (3)(b) remains in force for no more than 6 months after it is served.
- (5) The owner of a dog must comply with a notice or order served on the owner under clause (3).
- (6) An offence against clause (2) or (5) is a regulatory offence.

63 Unregistered dog or cat

- (1) A person must not keep an unregistered dog or cat within the municipality.
- (2) An offence against clause (1) is a regulatory offence.
- (3) It is a defence to a prosecution for an offence against clause (1) if the person charged with the offence proves that the dog or cat had not been kept in the municipality for a period of one month or more immediately before the date of the alleged offence or for periods totalling one month during the 3 month period immediately before that date.
- (4) Clause (1) does not apply to:
 - (a) a pound manager keeping a dog or cat in a pound; or
 - (b) the Royal Society for the Prevention of Cruelty to Animals keeping a dog or cat in a refuge maintained by it; or
 - (c) a veterinarian keeping a dog or cat for the purposes of treatment; or
 - (d) a dog or cat under the age of 3 months, of which the burden of proof lies on the person asserting the age.

Agenda Items:

Mandatory Desexing

Kate asked that it not be called 'mandatory desexing' as people often react to it or dismiss it but perhaps it should be more about encouraging people through rebate and registration charge levers.

Alderman Knox agreed to encouraging Desexing rather than calling it Mandatory Desexing.

Julie asked that cat seizure fees be higher and a portion of the fees go to a feral cat programme.

Sharon presented the group with research regarding mandatory desexing from arguments for and against and what effects it may have on animals also with what other Councils have done.

It was also found through the research that it is hard to enforce mandatory desexing.

The group was asked that they submit by the next meeting their ideas on how to encourage desexing and different incentives.

It was asked of Sharon what happens currently with animals at the pound and problem animals. Animals at the Pound are kept for four days before being assed to be re-homed.

Alasdair looked at the By-laws and its noted that the R.S.P.C.A gets special treatment but PAWS should be added to help with re-homing of animals. Kate would like to see fees and payment plans be moved to an agenda item for further discussion.

Alderman Knox suggested that it be changed from naming particular organisations to 'Approved Shelters'

Kate noted that Council recognising and working with Volunteer Rescue Organisations (including shelters), represents an opportunity to cost-effectively progress goals such as reduced numbers of animals surrendered to, and euthanized at pounds, increased desexing, registration and microchipping rates, and education of owners at the point of purchase of a new pet. Volunteer Rescue Organisations in other jurisdictions have been able to gain formal approval to work with pounds, and in doing so, the groups become exempt from certain administrative costs associated with rescuing and rehoming cats and dogs (expoundment costs, etc). This allows them to drop their own adoption fees and rehome more animals to approved homes..

Animals on Property

Julie believes that there should be different rules for cats and dogs around licencing along with land sizes.

A large discussion followed regarding animal licencing, land sizes and different breeds of dogs and issues, with keeping only one dog on the property can cause issues with noise as animals can become bored and bark.

It was decided that the rego fee structure needs to be reviewed first before deciding on licencing.

It was noted that under the current fees and charges there is no concession for residents with concession cards or cheaper fees for over 65 pensions.

Steve mentioned that there are pension concessions however changes to fees and charges for animal registrations have been flagged for next financial year and will be considered by ELT. These considerations include the points just raised.

This should read "animals are assessed for rehoming on entry to the pound if there is no identified owner. Dogs that are not rehomed to the nominated approved service are euthanized following the mandated timeframe of 4 days"?

Kate asked about rehoming rates and it was discussed that currently the rehoming rate is 90% - 73% being returned to owners and 13% going to adoption agencies like RSPCA and PAWS. Steve advised 90% is an excellent rehoming figure when compared to other pounds he has worked with.

Kate reminded Steve to circulate her email dated 15th February 2016 on fees and desexing levers.

REABL 3rd Submission tabled-Terms of Reference

The group discussed submission regarding a departure from the terms of refence for the committee, members were asked to comment. No concerns were raised regarding this, agreement was obtained that the committee were on target.

REABL second submission reply email was discussed - REABL repeats it's request that AMAC provide the statistics requested in REABL's second submission.

It was identified that the request for the statistics is not reasonable for commenting on the committee comments and recommendations. Kate enquired about the resources required. It was explained that this formed the basis why detailed financial statistics are not being provided and if they are desired by REABL they can request the information via the appropriate process of RTI.

General discussion around de-sexing and how it can be promoted.

Steve advised that this could be achieved via education, engagement with vets for subsidised de-sexing, discounted registration fees.

Kate suggested limiting subsidised de-sexing to people with low socioeconomic status and to rescue groups so they can provide lower adoption fees.

Julie was concerned that rescue group adoption fees were not static and that sometimes it was dependent on the breed. She does not agree with rescue groups selling animals as legitimate pedigrees for a higher fee without health checks, papers etc. Robin suggested that Council should look at prohibiting the sale of dogs and cats unless you are a rescue group or registered breeder. It was agreed that there was a need for this issue to be addressed but that it was not within the scope of this committee.

Discussion about responsible pet ownership - what is it? How do we promote it? It was agreed that a compulsory check list when registering a cat or dog would be a good way to inform pet owners of their responsibilities/requirements and Council Bylaws.

Discussion about the need for online registrations. Sharon advised that the development of a new website was in progress and perhaps the facility to complete new registrations may be available. Only registration renewals can be done online at this stage.

Discussion about registration fees. Anthony suggested a possible reduction in fees for defence personnel. This was not supported by the committee. Kate stated that the fee structure should not put anyone at a disadvantage and should encourage desexing.

From this discussion the following recommendations were put forward:

- 1. To investigate legislative mechanisms for the purpose of regulating the sale of dogs and cats within the Northern Territory. Moved Kate; Seconded Justine.
- 2. To include an educative check list as part of the registration process. Moved Kate; Seconded Robin.
- 3. That fee's be adopted to support and reward socially responsibly ownership incorporating;
 - Discounted fees for de-sexed concession/ pension card holders
 - Increased concessions for pensioners and concession card holders for entire dogs
 - Equity for members of a recognised feline association. Moved Julie; Seconded Steve.
- 4. That the animal management strategy includes subsidised de-sexing / registration days targeted at low socioeconomic status pet owners and recognised organisations who promote responsible pet ownership. Moved Robin; Seconded Kate.

Correspondence received:

REABL correspondence – submission 4 & 5

Robin expressed her concern about the nuisance barking process and suggested that officers use the phone and email instead of letters to speed up the process.

Steve explained some of the complexities with nuisance barking complaints such as complainants not using the normal channels to lodge complaints, contacting officers directly, often after hours and other factors that may result in slower response times.

Robin asked about the 35 days that was raised in the incoming correspondence. Steve explained the process and timelines. Robin would like to see procedure improved. Steve explained the ramifications of entering someone's property and removing their dog.

Discussion moved on to the definition of nuisance barking. Steve explained that dogs bark on and off for various reasons; there can be no problem for 7 days then a dog barks for one day – is that dog a nuisance? Factors need to be considered such as environmental issues, varying levels of tolerance, is it a community nuisance?
