*The Notice of Motion was raised by Member G Lambrinidis.*

#### Motion

- A. That Council purchase a small BBQ trailer up to the value of \$9,000 for use at Council events and functions during the dry season.
- B. THAT guidelines be developed for the usage of the trailer, that may include hire fees for community organisations.

#### Reason

The Council and its affiliated committees organise many outdoor events throughout the year which can be difficult to cater for. Sausage sizzles provide a low cost catering option and are a favourite amongst Darwinians. A small BBQ trailer can be used by other not-for profit organisations and would be a great way for Council to promote itself as well as outdoor activities. Other Councils, such as Palmerston have invested in a similar BBQ trailer which is free and available for use by members of the community, local organisations and groups to support activities and programs that directly benefit residents of the City of Palmerston.

Ideally the trailer should be no more than 6x4 foot and enclosed so it is protected from the weather and stabilising bars so it cannot tilt when not being towed. It should have a large slide out BBQ, that is fixed to the trailer and include space for plastic tables and storage boxes for utensils. The utensils should be provided before its first use.
