- Consideration of the functionality so that public use supports the biodiversity plan and strengthens community involvement
- Review the security of the area and installation of surveillance infrastructure to prevent antisocial behaviour and vandalism
- Inclusion of more rigorous cane toad management practices
- Management and/or removal of the PowerWater sewerage outflow

Subject: Bird data, Bird watching Platform and shorebirds

Hi Jade

A couple of things occur to me, reflecting on the meeting:

- 1. One of the most popular birdwatching spots in the reserve is around near the western rock shelf. Bush birds there often use the bubbler to get a drink, but recently this has been dry more often than not. I think that an elevated water point (by this I mean a small trough perhaps 3-6 feet above ground, above wallaby height) would be a good amenity for this area.
- 2. I see the biodiversity management plan includes a birdwatching platform. There is a reasonable site for such a thing near the western rock platform, which would be quite useful for shorebird observation at high tides. Happy to discuss options with you.
- 3. One of the key issues for shorebirds is high tide disturbance, and at East Point there is a particular issue with disturbance by fishermen in one small area on the rock platform (the last rocks that inundate as the tide rises, on the southern edge of the western rock platform). If fishing could be excluded within 100m of this particular platform, it would greatly reduce disturbance to roosting shorebirds. Alternatively, if a sign pointing out that disturbance is an issue could be put in place, this may go some way to reducing the problems.
- 4. Not sure if council is aware, but there were three inland bird species which were recorded at East Point reserve for the first time (I think) during 2019 or 2020.
- 5. I can provide whatever relevant data I have from my research, for the purpose of your biodiversity surveys.

Hi Darwin City Council

Lake Alexander and East point reserve is a credit to City Of Darwin Council staff. It is a great facility for all types of water sports which includes the Surf life Saving fraternity, Sailing Australia as well as the Darwin Triathlon Club.

The surrounding landscaping is well maintained. There is potential the make this area on par with the Nightcliff foreshore and the Water Front for an public area that allows Darwin residents maintain a healthy lifestyle.

May I make the following suggestions to be investigated and added to the short and long term strategic plan of the area.

1 Enlarge the lake. This could be investigated to make another channel on the eastern side. This would be a circular loop for swimmers as well as board and canoe paddlers.

(Marked in white)

2 Create a DUAL running path around the lake. I would envisage this would be a good 1200m track with distance markers on the ground.

(Marked in black)

3 Darwin Runners Club also has a number of Wednesday night runs at Lake Alexander. Their annual road championships as well as the ABC half marathon is run from the carpark.

I suggest a tunnel under the road near the children's playground and bridge.

This will keep Runners, Walkers and children crossing the main road safe, where even though there is a crossing there, many drivers don't pay attention

4 The running track to east point , past the rock sitters and back to the car park via the areoclub is well maintained and heavily used on the weekend. There is a 200m section just near Pee Wees and the old bbq shelter. This would be an great alternative run/walk if this was bitumised.

The cliff also has great view for the tourists of the city. All just thoughts from a community that uses the facility extensively.

Thanks again for the debrief last week following the East Point Reserve Advisory Committee meeting.

Once again I'm very sorry that I was not able to attend due to short notice.

I'm looking forward to the next meeting on 27 May and making a solid contribution to the Committee.

As discussed an update or briefing on the following issues would be useful from my perspective as these are the key issues that people raise with me.

 Measures that can be undertaken by the City of Darwin to deal with anti-social itinerant behaviour at East Point Reserve.
 I acknowledge that this is a challenging space, however it is a key issue for many users of the reserve.

The issue is particularly important in relation to the area around Lake Alexander and onto the beach near the BBQ tables, playgrounds, pop up vendors and toilet facilities.

- 2. An update on any current commercial proposals the City of Darwin has received for East Point Reserve.
- 3. What actions have been undertaken by the City of Darwin to scope the development of a new "Nightcliff Café" style development at East Point Reserve.
- 4. In the interest of inclusion I would like to understand if there are any plans for installing new and more seating along the foreshore for seniors and those recovering from illness enabling them to comfortably walk between seats in certain key spots.
- 5. It would be good to get an update on the Casuarina trees near Rock sitters and the plans to reinforce the cliff face in that area to avoid further loss of the trees and damage to footpath.
