INTRODUCTION

Larrakia artists from the Larrakia Nation Arts Centre present their family stories in a unique series of public art installations to create a rich spirit of place for the Lyons community.

The project was co-sponsored by the Lyons JV partners, Canberra Investment Corporation Limited and Defence Housing Australia, with the federal Department of Information Technology, Communication and the Arts (DCITA), and Balarinji Studio. A whole of government approach under Shared Responsibility Agreement policies also provided funding input from both Federal and Territory governments to the project. As owner of the Lyons Community Centre where most of this art is situated, Darwin City Council has a special custodianship role in relation to these works.

Larrakia people are the Aboriginal traditional owners of the land and waters of the greater Darwin area, with traditional responsibility for lands including the Darwin Peninsula, the Cox Peninsula and adjacent islands and land west of the Howard River. Today, more than 1600 people claim membership of the Larrakia language group, representing eight Larrakia groups.

Larrakia people have spiritual as well as cultural and economic relationships with land in the Darwin region. Several Dreaming tracks travel into, out of and around the traditional Larrakia estate. Two powerful Dreamings in the area are the Rainbow Serpent, which travels the seas between the Daly River, Port Darwin and beyond, and Kangaroo, which travels over country in the Middle Arm. Wickham Point and East Arm area.

LARRAKIA ART AT LYONS

The Larrakia artists have created cultural images around the Lyons Community. These include paintings on play equipment, etchings on benches, sculptures, a mural, and bollard, light decoration and pavement inlay designs.

These works tell stories of Larrakia culture.

All the land and waters in the greater Darwin area are rich with animals and birds. The Lyons area was a place where Larrakia people came out bush to camp with their families. You can see goanna and lots of birds like ibis, cockatoos, and eagles. Turtles come and lay their eggs on the beach there, and Larrakia people believe that it's up to them to look after the turtles.

There are lots of insects like dragonfly and butterflies as well as sea and mud creatures. You can see barramundi going after mullet in the creek and in the sea, stingray and squid and sharks. Stories tell about a Frog dreaming here called *ngartba-ngartba* in Larrakia. He is a little sand frog with three eyes on top where his forehead is. These frogs call when the rains come and the elders do a frog dance.

When the Larrakia people camped there, they enjoyed lots of bush and mud tucker. They would gather roots, berries, bill goat plums, milky plums, wild peanuts, passionfruit, arrowroot and long yams in the dry season. They also collected nuts from the pandanus and even sugarbag or bush honey from the little local black bees. The men would smoke them out from a tree to get the honey.

They collected oysters and mussels straight from the rocks, and longbum and mudcrab. They went fishing with spears as well as drag-nets, and caught stingrays and catfish, barramundi, skinnys, shark and prawn.

INTERIOR paintings

The Lyons collection of Larrakia paintings was commissioned to capture the spirit of Larrakia culture in the Darwin region, and the connection of Larrakia people to the land at Lyons. Images capture the rich natural environment that the Larrakia use for bush tucker and medicines, and illustrate many of the totems that Larrakia people relate to. Joe Raymond's painting tells his family's story of the legend of Old Man Rock (Derri-ba Nungalinyi), a central Larrakia story of Lee Point.


Old Man Rock Sculpture - Entry Courtyard and Foyer

The Old Man Rock ground sculpture has been developed from a painting by Larrakia Artist Joe Raymond telling his family's story of Old Man Rock. Concrete and stainless steel and local pebbles have been used in its creation. Collin Sainty and Techy Masero collaborated with artists from the Lyons Larrakia project to realize this work.

Old Man Rock (Derri-ba Nungalinyi) is the central Larrakia story of Lee Point. Family stories tell about Old Man Rock's wives: Binybara and Majamarraba. He also has a brother rock at Tree Point. Sometimes, his wife Binybara forms herself into an ibis and at low tide, goes to visit Old Man Rock. At high tide, he is covered again and she returns to shore.

Some stories say Old Man Rock turned himself into an octopus and grabbed two daughters and their father and then turned them into rocks. The Larrakia people make sure not to disturb him when they fish or hunt in the area.





Larrakia artists worked with tutor Colin Holt to create a series of delicate ceramic pieces depicting the rich variety of bush food and mud tucker that they enjoyed while camping at Lee Point. These included bush peanuts, billy goat plums and long yams, and turtle and mud crab. A selection of the ceramic pieces are exhibited in the main room of the Lyons Community Centre mounted in glass and perspex for all to enjoy.

Covering the main room of the Lyons Community Centre, sketches of bush tucker by Larrakia artists have been translated into bold floor designs. These are created in marlomeum.





EXTERIOR

Larrakia sculptures sea turtle and rock waterhole

This major sculptural work is a collaboration between Larrakia Nation artists James Gaston, Peter Browne, Dianne (Deede) Quall, Dotty Fejo, Jocelyn Archer and artist Techy Masero.

The principle vertical sandstone carving depicts birds and reptiles from traditional Larrakia art. The stone floor in porcellanite, slate, sandstone and river pebbles, built around the sculpture, symbolizes waterholes. Larrakia-style animals in porcellanite, connect with the waterholes and tell the story of fauna at Lee Point. The sea turtle, standing 1.5 metres high and 4 metres long is a central motif in Larrakia's history as coastal people in the Darwin region.

Painted on iron orb, this work is a collaboration between several Larrakia artists including Tanya Williams, Pauline Baban and Denise Quall. As well as bush tucker and plants, a striking image of a basket dominates this work. This mural can be enjoyed from the walkway and from the main room of the Neighbourhood Centre.

Flanking the main path leading to the Neighbourhood Centre, the bollards feature bronze lids designed by the Larrakia artists. The designs and moulds for the lids were created at the Larrakia Arts Centre.

The artists created full-size cut-out designs for light decorations. Artist Techy Masero then transformed these designs into environmentally safe decorative elements made of steel.

Using an etching process to decorate anodised aluminium seats, the Larrakia artists depicted animals and bush food designs. These benches are now scattered around the grounds of the Lyons Community Centre.





EXTERIOR path inserts

Larrakia drawings have been translated into stainless steel paving insets. These surprise pedestrians on paths in the vicinity of the Lyons Community Centre.

In late 2008 the Lyons Joint Venture (JV) sought approval from the Development Consent Authority to vary the Development Consent over the remaining stages of the Lyons development.

Amongst other alterations the JV sought approval to develop a 15 metre wide by 30 metre deep pedestrian and cycle link to Lee Point Road. The link was proposed to create a safe pedestrian and cycle access onto Lee Point Road and allow easier access to Lee Point and Casuarina Beach Nature Reserve. An additional benefit of this access will be to create a distinct linkage with the proposed development of Muirhead.

Similar pathways have been permitted at Lyons as evidenced by the pathway from Marrabala Court to Damabila Drive in stage 7.

The Lyons Design Guidelines will make it mandatory that the residents who adjoin the proposed walkway will only install permeable fencing which will increase the surveillance of the pathway.

Based on best practice urban design principles the JV does not want this access to be created as another road access as it will only increase the potential for additional traffic movement through Lyons in an area which has been designed to be a quieter residential precinct.

As can be seen from the photos the pathways are permeable and allow easy pedestrian and cycle movement. The proposal meets the CPTED requirements which has been an important principle adopted by the Lyons JV.

We therefore respectfully request that Council reconsider its position and to agree to endorse this proposal.



This report provides an update on the progress and location of the proposed Police Monument and seeks endorsement of Bennett Park as the preferred location.

PREVIOUS DECISIONS

Decision No. 20\0536 (29/07/08)

- B. THAT Council support the proposal to erect a suitable monument in the city to recognise the contribution made by the Northern Territory Police.
- C. THAT further discussions take place regarding the preferred site and that the final site be referred back to Council for approval.

GENERAL:

In 2008 the NT Police Commissioner approached Council with a request for approval in principle for the construction of a monument to commemorate the contributions of the NT Police.

A Steering Committee was convened by the Office of the NT Police Commissioner with representation from the NT Police Association, NT Retired Police Association, NT Police Museum & Historical Society and Council.

The Steering Committee met several times in 2008 to discuss the project and its potential location. Locations considered included Bennett Park, Civic Park, Tamarind Park, Raintree Park, the Esplanade, and the lawns of Parliament House.

Bennett Park and Civic Park were identified as preferred locations for the monument due to the historical link between the NT Police Force and these locations. Of these two locations, Bennett Park has been identified as the preferred location.

SUBJECT: POLICE MONUMENT - UPDATE ON PROGRESS AND LOCATION

The Northern Territory Government Planning Department and Heritage Branch have indicated their support for this proposed location as an appropriate site for the Police monument.

The Office of the Police Commissioner has estimated that a budget of \$350,000 will be required to see the project to completion.

The cost of maintenance of the monument has yet to be considered, but may fall to Council if the monument is installed on Council land. At the time of preparing this report, Council was awaiting advice as to this aspect.

A goal of Darwin City Council's Evolving Darwin plan is the promotion of Darwin. We aim to achieve an increase of visitors to our City through the promotion of Darwin as a host city for sport, culture and other events and the promotion of Darwin's history, particularly it WW11 experiences and to increase the number of business delegates visiting our City.

An increased number of visitors to the area helps support existing local business and helps create opportunities for the creation of new businesses. Darwin City Council would like to opportunity to work with the Northern Territory Government to achieve these promotion activities.

With the Northern Territory Government's assistance we have to preserve the Darwin Harbour and protect the ecological systems within in. This is not a task that Darwin City Council can deliver on its own.

<u>Housing</u>

Another factor in achieving our vision of "enhancing Darwin's unique lifestyle and tropical feel" is to move towards undertaking an influencing role in the planning and developmental processes that impact Darwin. SYNOPSIS:

At the February First Ordinary Meeting, Canberra Investments are making a presentation to Council on various aspects of the Lyons residential development. One aspect of the presentation concerns a walkway proposed between Lyons and Lee Point Road.

GENERAL:

In August 2008 a walkway was originally proposed in a development application for the subdivision of land at Lyons. The walkway was proposed midway on a long stretch of Lee Point Road. The purpose of the walkway was to link the residential development within the proposed subdivision to Lee Point Road. Another purpose of the walkway would be to provide a bikeway to link to Lee Point Road.

At the time of considering the development application to include the walkway, the rezoning of land to facilitate the development of the Muirhead suburb had not been exhibited. Staff briefed Council on the walkway proposal and advised that the walkway not be permitted without an accompanying road connection adjacent to the walkway. The lack of certainty relating to the future development of Muirhead was also a concern.

In its letter of 8th August 2008, Council made the following comments on the proposed walkway to Development Assessment Services:

"Council will not accept a pedestrian linkage of this isolated type without an accompanying road. Council requests that the authority requires amended plans demonstrating a necessary connecting road from Lee Point Road to the current proposed outlet to the north in Stage 10 or directly to the hospital through Stage 10. This road entrance from Lee Point Road should be combined with the proposed pedestrian link. The whole of the existing Phase 2 layout of the development does not have an outlet to Lee Point Road over

its entire abutting length. This has been a point of contention throughout the whole of the development of the Lyons subdivision and Council has consistently put its case forward in this matter. The matter has not been received positively by the developer or the DCA. The developer has indicated that this was not acceptable for a raft of reasons including that a connection from Lee Point Road was not necessary, it would require amendment to a subdivision layout that had been finalised and approved, that it would involve the developer in significant additional construction costs and also result in unacceptable loss of lot yield".

Current Situation

The future of the large parcel of Defence land east of the Lyons submission has now been clarified by a rezoning application to allow the development of the suburb of Muirhead. The proposed walkway will provide a pedestrian link between the suburbs of Lyons and Muirhead. A safe pedestrian crossing will need to be installed on Lee Point Road at this location to facilitate the pedestrian link.

The original proposed walkway was in the vicinity of 15 metres in width which is wide for a walkway. The average width for a walkway in most Darwin suburbs is about 3 metres. These do tend to look narrow and result in a "corridor" effect if adjacent fences are screened. The proposed walkway offers the opportunity to be designed to reduce antisocial behaviour by incorporating Crime Prevention Through Environmental Design (CEPTED) principles.

If approved the walkway would need to be developed to take into account CEPTED principles and address such matters as adequate lighting, appropriate vegetation, and no screening on adjacent property fences (this tends to reduce visual observation of walkway activities). Adjacent fences should be no higher than 1.2 metres.

If the walkway is not provided some residents would have to walk more than 400 metres to access Lee Point Road.

FINANCIAL IMPLICATIONS:

Provision of the walkway is at the developer's expense.
