SYNOPSIS:

The Darwin City Centre Revitalisation Project 2009 is the result of a successful submission for Federal Government grant funding under the Community Infrastructure Program-Strategic Projects.

As the result of the submission, \$3.6 million in Federal funding was secured towards the construction of the following key project components:

- A. Knuckey Street Connection 1;
- B. Smith Street Connection 2 (Smith Street Mall);
- C. Smith Street Connection 3 (Knuckey Street to Peel Street); and
- D. Raintree Park.

The remainder of the project budget of \$7.0 million is made up of contributions from the Darwin City Council, Northern Territory Government and the private sector totalling \$3.4 million.

A presentation regarding the concepts for Smith Street, The Mall and Raintree Park was made at Council's Ordinary meeting on the 11 August 2009.

At it's meeting on 30 June 2009 Council adopted the Knuckey Street concept design for the purpose of consultation.

This report provides an update on progress and seeks Council's approval to proceed to tender on Knuckey Street concepts and adoption of concepts for the balance of the project.

GENERAL:

OVERVIEW

The Darwin City Centre Revitalisation Project 2009 is a collaboration of the Australian Government, the Darwin City Council, the Northern Territory Government and elements of the Private Sector.

A description of each key component of the Darwin City Centre Revitalisation Project 2009 is provided below:

- A. The key philosophies driving the Darwin City Centre Revitalisation Project 2009 are:
 - Improving the streetscape design of the city streets;
 - Greening these streets and providing more shade;
 - Building better pedestrian connections less clutter, more movement;
 - Establishing a safe pedestrian environment; and
 - Creating a framework for a combination of public and private sector investment; and
 - Provide a "kick start" for the revitalisation of Darwin's City Centre.
- B. Smith Street Connection 2 (Smith Street Mall):
 - Removing clutter within the Mall to open it up to increased pedestrian traffic; (existing seats and raised planters).
 - Upgrading existing shade structures in the Mall so that they become key "event" spaces in the Darwin Central Business Zone;
 - Introduction of a central row of tree clusters, including large trees shade trees (eventually) with new seating nodes; and
 - Introduction of additional compact children's' play equipment, as part of the Public Art strategy.
 - New way finding and tenancy signage.

- C. Knuckey Street Connection 1:
 - Introduction of lit tree build-outs and large shade trees; with stone and timber seating nodes.
 - Upgrading of a tourist bus set-down area, incorporating seating and information panels; and a new upgraded footpath in front of Raintree Park.
 - Opportunity for a secure taxi set down area.
 - Promotion of alfresco dining opportunities in the Darwin Central Business Zone; and
 - Improving the ground works and aesthetics of the Smith Street/Knuckey Street intersection, thereby promoting pedestrian movement along Smith Street and Knuckey Street,
- D. Smith Street Connection 3 (Knuckey Street to Peel Street):
 - Removal of existing landscaping elements such as raised planter beds and shrubbery, to create a safer and more inclusive pedestrian environment;
 - Creation of and enhanced Wet Season covered link between the Chinatown Car park to the Smith Street Mall;
 - Promotion of alfresco dining opportunities in the Darwin Central Business Zone;
 - Promotion of a diverse and active retail edge; and
 - Introduction of large shade trees.
 - Improved lighting.
- E. Raintree Park:
 - Creation of a vibrant "city square"
 - Expansion of soft landscape (ground cover and turf) around the base of the Rain Trees to improve tree health.
 - Incorporation an enhanced retail promenade to the park edge.
 - Creation of a new 'stage' area to improve the ability of the overall park structure to cope with key community events; and
 - Promotion of disabled-compliant and stronger cross-city pedestrian connections.

This project is an example of a high profile project involving all three tiers of Government and has generated widespread private sector interest, having already lead to a private sector monetary contribution towards the Raintree Park component, with the possibility of further private sector contributions.

The aims of this project are to create a *sustainable, event friendly, retail friendly* and 24 hour city.

The outcomes of the projects are anticipated to include:

- Northern Territory Government Supportive of the design minor issues raised with traffic concern at the intersection of Knuckey and Smith Street, this has been resolved by removal of a planter. The Government is fully funding this project.

A number of non-supportive comments were made from two of the owners namely opposed to the project and strongly opposed to it, not supportive of trees in road reserve and the loss of parking. A written submission was received objecting to the proposal from Gaymark Property Group, being owners of property within Knuckey Street. (Attachment C)

The General Manager Infrastructure has had a further meeting with the owner regarding his email and the design concepts.

As a result of internal review and consultation a few minor amendments have been made these include the removal of one (1) planter area outside Darwin Central and the use of *Allosyncarpia Ternate* adjacent to Raintree Park area only with the balance of trees remaining *Syzygium Armstrongii*. These amendments were included in the presentation to Council at the 11 August 2009 meeting.

SYNOPSIS:

This report is to brief Council in relation to the SkyCity proposal presented to Council on the 11 August 2009 and advise of key issues which are being addressed by officers. A further report and recommendations will be submitted to Council on completion of investigations.

GENERAL:

For a long period of time, SkyCity has been in discussion with Council in relation to the potential purchase of Lot 5772 (car park area) this area is currently under licence to SkyCity.

On 6 August 2009 Council received correspondence from SkyCity advising that at this junction it does not wish to pursue the purchase of the car park. (Attachment A)

On 10 August 2009 further correspondence was received by Council, from SkyCity regarding Car Park access to Little Mindil (Lot 7651), **Attachment B**. The letter seeks access to Little Mindil by way a direct access route through Lot 5772 (car parking area) owned by Council. They proposed that the access be secured by a right of way for the SkyCity over Council land. The areas and affected land is shown on a plan attached to the letter. (**Attachment B**)

At Council's Ordinary Meeting on the 11 August 2009 Council received a presentation by SkyCity regarding the development of Little Mindil and future development of the SkyCity allotment addresses issues in the letter of 10 August 2009.

Officers are currently considering the proposal and request by SkyCity and issues being considered include but are not limited to:

- The impact on the potential future Lot 7552 if a right of way is created.
- Review of possible alternatives to a right of way i.e. access provided via SkyCity land.
- Long term parking requirements of the precinct including parking requirements of SkyCity's development plans.
- Issues of appropriate compensation.
- Preliminary assessment of the proposal Little Mindil and Tropical Tourist Resort development.
- The construction of a promenade linking Myilly Point with Mindil Markets area via a tripartite agreement which has not previously been raised with Council and appears to have been a result of discussions with the Northern Territory Government and SkyCity.
- Implications of proposals on current and future surrounding uses and Council assets.
- Infrastructure and service authority restrictions and issues.

The issue surrounding the proposed developments and SkyCity's request of Council require careful and detailed investigation and consideration. SkyCity have indicated their desire for a quick resolution. However, this matter will take time to fully and adequately consider. Officers have placed a priority on the preparation of a report to Council regarding this matter and all reasonable resources are being used.

Based on available resourcing, the proposal is to have a detailed report to Council at it's 2nd Ordinary Meeting in September 2009.

SkyCity have been informed of the process required and officers will continue to liaise with SkyCity regarding the matter.

As you are aware, SKYCITY Darwin Ply Ltd (SKYCITY) has been in discussions with the Darwin Gity Council (Council) in relation to the polantial purchase of the car park area (Cesino Car Park) localed on that part of Lot 5772 Town of Darwin (Lot 5772) between SKYCITY's Lot 5244 Town of Darwin (Lot 5244), Gilruth Avenue, the tennis courts and the Little Mindli site.



Car Park Access to Little Mindil - Lot 7651 Town of Darwin

Background

SKYCITY Darwin Pty Ltd (SKYCITY) was selected by the NT Government as the successful proponent for the development of a low rise Tropical Tourist Resort in the Mindil Beach locality, facilitated by the sale of Lot 7651 Town of Darwin (Little Mindil) to SKYCITY.

The proposal submitted by SKYCITY was unique from competing proposals in that the low rise Tropical Tourist Resort would be constructed on SKYCITY's existing Gala Lawns rather than Little Mindil. Little Mindil is to be developed by SKYCITY as an open area and car park for SKYCITY events with certain guaranteed rights of public access and public use of Little Mindil. The design concept plan for Little Mindil is attached, showing the improvements to be made. This design concept is consistent with that presented by SKYCITY to Council in September 2007.

Little Mindil Development Features

Key features of the Little Mindil development are:

- levelling the Little Mindil site, grassing the site and the introduction of shade trees;
- revegetation of the escarpment including the removal of weeds and the maintenance of the vegetation incorporating a weed control program;
- creation of a monsoon vine forest landscape buffer at base of the escarpment;
- creation of a permanent public access easement on the southern side of the creek over a shared pedestrian and cycle pathway to be constructed along the top of the creek bank to link the existing pedestrian pathway on Gilruth Avenue to Little Mindil beach and a proposed promenade along the beach;
- lighting of pathways for public safety;
- removal of rubbish from the creek and the promotion of existing trees and mangroves;
- creation of a series of story boards along the Creekside public access pathway about the history of Little Mindil to present day;

SKYCLLY has also agreed with the Territory to construct a new promonade along the Little Mindli boachfront to link to Mylly Polit to Council land on the northern side of the creek via a pedestrian footbridge.

The design has been developed to provide an enhanced amonity to be enjoyed by the public through the improvements outlined above.

Public Access Requirements

SKYCITY wishes to facilitate public vehicular access to Liftle Mindil by way of a direct route through the existing Casino Car Park located on Council land (part of Lot 5772 Fown of Darwin). The proposed access route is shown on the attached map and takes account of the existing topography, infrastructure and set up of the car park. The proposed access route can accommodate a 12.5m long heavy duty rigid truck (such as a fire truck or large service vehicle).

SKYCETY has determined that vehicular access to Little Mindli is not possible directly from Gilruth Avenue because of safety reasons. SKYCETY has also considered alternative access routes through SKYCETY land and at other points through Council land however such alternatives are not viable for the following consums:

- Alternative 2 on the attached sketch plan (whether accessed from SKYCHY land or Council land) must avoid the existing second site and then has the negative features of:
 - a. Increasing the likelihood of interaction between vehicles and pedestrians moving from the car park towards the open space area, creating safety issues;
 - b. requiring additional road works and traffic on Little Mind0, reducing amenity;
 - c. requiring cars to enter the car park at one end rather than the centre, resulting in negative traffic flow issues within the car park;
- Alternatives 1a, 1b and 1c on the attached sketch plan (whether accessed from SKYC(1Y) land or Council land) were considered within the confines of the requirements of avoiding the sewerage pump station facility and the drainage system and outlet and were deemed unsuitable because:
 - they may encourage cars to cut corners through the two 90 degree bends immediately prior to the creek crossing;
 - b. they are less direct and intuitive for traffic flow; and
 - alternatives 1b and 1c can only accommodate an 8.8m long medium duty rigid truck.

Form of Access Rights

To facilitate the proposed vehicular access by the preferred access route SKYCITY is seeking from Council an easement (to be registered on the title to Lot 5772 Town of Darwin) which would allow SKYCITY to:

3

- construct (to the extent any additional works are necessary) and maintain (a) the access route; and
- (b) have a right of way over the access area, which means that SKYCITY, its patrons and the public are able to (with or without vehicles) enter on and pass over and along the access route to gain access to the Little Mindil car park.

Compensation

SKYCITY proposes that the compensation to be provided to Council for the grant of the requested easement is the landscaping of the Council road reserve between Gilruth Avenue and Little Mindil, further enhancing the amenity of the area for the general public.

SKYCITY believes that its works proposal (rather than any cash payments) is fairly reflective of:

- the benefit that the general public will derive from the additional (1)infrastructure and amenity provided by SKYCITY on Little Mindil;
- the fact that SKYCITY will be responsible for costs of the construction and (2)maintenance of any improvements associated with the access route:
- the consistency of the access route proposal with existing facilities on (3)Council's Lot 5772, noting that SKYCITY has rights to maintain such car park facilities until 2030; and
- (4)the lack of any viable access alternatives.

Timing and Processes

SKYCITY is presenting its Tropical Tourist Resort and Little Mindil developments to Council at its meeting of 11 August 2009. It is hoped that this presentation will assist Council in understanding the proposed developments and the importance of the proposed access route in the overall scheme. SKYCITY is also looking forward to receiving any feedback from Council in relation to the proposed developments.

Because resolution of the issue of access is a matter to be considered by the Development Consent Authority as part of SKYCITY's Development Application under the Planning Act, and SKYCITY is looking to commence site works on Little Mindll before the end of 2009, your early response to the above would be appreciated.



The Development Consent Authority (DCA) is now meeting every fortnight. This revised schedule has implications on the timing of Council's response to Development Assessment Services on development applications and planning scheme amendments.

This report identifies how Council might address the issue of fortnightly versus monthly DCA meetings.

GENERAL:

The revised meeting schedule of the DCA means that development applications and planning scheme amendments are being scheduled for consideration by the DCA before Council has the opportunity to comment on applications at its monthly Town Planning Committee Meeting.

Attachment A shows Council meeting times including the Town Planning Committee and the scheduled meetings of the DCA for the remainder of 2009. The Attachment also shows the meeting schedule relationship between Council's Town Planning Committee Meeting, 1st Ordinary Meeting, 2nd Ordinary Meeting and the meeting schedule of the DCA. It can be noted that out of the seven remaining DCA meetings for 2009, Council's Town Planning Committee Meeting can service four of the DCA dates, being 4 September, 9 October, 6 November, and 4 December. However, the three DCA meetings that fall on 18 September, 23 October and 20 November, would require town planning reports and letters to go before Council's 1st Ordinary Meeting, specifically the meetings of 15 September, 13 October and 10 November.

An alternative in presenting town planning matters to 1st Ordinary would be to call three special Town Planning Committee meetings on the Wednesdays of 16 September, 21 October and 18 November, 2009 respectively. Calling additional special meetings is an additional cost to Council. If additional special meetings are

required, Council could consider requesting the NT Department of Planning and Infrastructure to make a contribution to this cost as it is necessary due to the NT Government's revised DCA meeting policy.

This report puts forward options for Council's consideration on how it can provide timely comment for the remainder of 2009 to Development Assessment Services without compromising the professional consideration and timeframe required in adequately assessing proposed developments.

<u>Options</u>

- 1. Reports and letters on Development Applications and Planning Scheme Amendments (DAs and PSAs) will still be considered by the monthly Town Planning Committee (where the DCA meeting to deal with these applications follows immediately after the Town Planning Committee Meeting). Where this cannot take place, reports and letters on DAs and PSAs will go to Council's Ordinary meetings to ensure Council's comments are made to Development Assessment Services in time for the DCA meeting.
- 2. Call a Special Town Planning Committee Meeting to assess Reports and letters on DAs and PSAs on an as required basis; or
- 3. Circulate Officers reports and draft letters on DAs and PSAs by e-mail to Elected Members for comment, prior to sending the final response to Development Assessment Services.

Option 1 will be recommended as it requires no additional Council meetings therefore no additional Costs and results in a decision of Council. It should be noted that this option may increase the length of the Ordinary meetings.

A review of the process will be undertaken at the end of 2009 with a further report to Council.

A Coordinated Approach to Development Assessment

The revised DCA meeting schedule also raises the issue of the length of time Council has to respond to development applications and scheme amendments. Councils receives development applications when they are advertised in the press and then has two weeks to meet its statutory obligation of making a submission in the required timeframe set down in the NT Planning Act.

This two week timeframe is the same period given to NT Government Departments and residents of Darwin. If the NT Government is serious about a coordinated "one stop shop" approach to planning assessment then development applications should be distributed to Darwin City Council, as a major stakeholder in the process, at the same time or immediately after the applications are received by NT Government's Development Assessment Services. will have more time to make it's assessment and Council maybe able to consider the majority items at it's normal meeting cycle.

To seek a more coordinated approach to planning assessment Council should write to the NT Department of Planning and Infrastructure seeking the early distribution of development applications for assessment.

- If submissions are received the Development Consent Authority (DCA) must conduct a hearing in respect of those submissions;

- After consideration of this report the Minister must do one of the following:
 - Amend the planning scheme;
 - Alter the planning scheme in response to recommendations of the DCA's report; or
 - Refuse to amend the planning scheme.

Part 2 Planning schemes and proposals

Division 1 Planning schemes

7 Northern Territory Planning Scheme

(1) There is a Northern Territory Planning Scheme that applies in relation to the whole of the Territory except any area of land:

- (a) in relation to which another planning scheme applies; or
- (b) specified in the NT Planning Scheme as being excluded.

(2) The NT Planning Scheme may refer to an area of land by describing the land, or referring to a map or plan of the land.

8 Other specific planning schemos

(1) The Minister may, on the Minister's own initiative or following a request by a person or body, make a specific planning scheme that applies in relation to the area of areas of fand described in the planning scheme or in a map to which the planning scheme refers.

(2) The Minister may, on the Minister's own initiative or following a request by a person or body, repeal a specific planning scheme.

(3) Divisions 2, 3, 4 and 5 apply in relation to the making or repeat of a specific planning scheme as if a reference in those Divisions to an amendment of a planning scheme were a reference to the making or repeat of a specific planning scheme.

(4) If the Minister makes or repeals a specific planning scheme on his or her own initiative, Divisions 3, 4 and 5 apply (with the necessary changes) in relation to that action as if the Minister had received a request for the specific planning scheme to be made or repealed.

9 Contents of planning scheme

(1) A planning scheme may include any of the following:

 (a) provisions that include statements of policy in respect of the use or dovelopment of land;

(b) provisions that permit, prohibit, restrict or impose conditions on a use or development of land;

(c) provisions that provide instructions, guidelines, or assessment criteria to assist the consent authority in assessing development applications;

(d) other provisions in connection with planning for or control of the use or development of land;

 (c) other provisions that are necessary or convenient for giving effect to the planning scheme;

(f) maps, plans, designs and diagrams.

(2) A provision of a planning scheme may apply in relation to all the land to which the planning scheme applies or may apply to a specified part of that land. (3) A planning schemo may refer to, adopt or incorporate (with or without modification) a specified document, as in force at a particular time or as in force from time to time.

Division 2 Amendments and requests for amondments of planning schemes

10 Meaning of declared class of amendments

In this Division, a reference to a declared class of amendments is a reference to a class of amendments to which a declaration in force under section 11(3) relates.

11 Amondmont of planning scheme generally

(1) The Minister may amond a planning scheme in accordance with this Part.

(2) To avoid doubt, the repeat and substitution of a planning scheme in its entirely is an amendment of the planning scheme.

(3) The Minister may declare in writing that, in the Minister's opinion, a class of amendments of a planning scheme is not so significant as to require exhibition.

12 Amondmont of planning scheme on Ministor's initiative

(1) The Minister may decide to amond a planning scheme on his or her owninitiative as the Minister sees fit.

(2) If the Minister is satisfied the proposed amendment is within a declared class of amendments or is not so significant as to require exhibition, the Minister may:

> (a) amond the planning scheme without taking any further action under Division 3, 4 or 5;

(b) give notice of the amendment in accordance with section 28; and

(c) provide reasons for the amondment in accordance with section 29.

(3) In any other circumstances, Divisions 3, 4 and 5 apply in relation to the proposed amendmont.

13 Request for amondment of planning scheme

(1) A porson or body may, in writing, request the Minister to amond a planning schemo as proposed in the request. (2) After considering the request, the Minister may:

(a) if the Minister is satisfied the proposed amendment is within a declared class of amendments or is not so significant as to regulae exhibition:

(i) decide to amond the planning scheme without taking any further action under Division 3, 4 or 5;

(ii) amend the planning scheme as proposed;

(iii) give notice of the amondment in accordance, with section 28; and

(iv) provide reasons for the amendment in accordance with section 29;

(b) decide to continue consideration of the proposed amendment by placing it on exhibition; or

(c) decide to refuse to amond the planning scheme as proposed.

(3) As soon as practicable after making the decision, the Minister must give written notice of the decision to the person or body who requested the proposed amendment.

(4) If the Minister decides to refuse to amond the planning scheme as proposed, the notice of the decision must include the reasons for the refusal.

Division 3 Exhibition of proposals

14 Definitions

16 Notice relating to rezoning or grant of permit

(1) This section applies in relation to land that will be affected by one of the following proposals if carried out:

> (a) a proposal to amond a planning scheme by establishing of changing a zone;

(b) a proposal to grant or vary an exceptional development, permit.

(2) Subject to this soction, on or before the first day of the period of exhibition (or the proposal, the Minister must:

(a) cause a notice to be served on the owner of the land; and

(b) cause to be placed on or in the vicinity of the land as many notices, in accordance with subsections (4) and (5), as the Minister considers appropriate.

(3) Subsection (2) does not apply if the Minister considers:

 (a) it is impracticable to comply with the subsortion because of the location of the land or the number of parcels of land; and

(b) it is reasonable to expect that all persons likely to be affocted by the proposal will receive sufficient notice of it by means of the notice published in a nowspaper under section 17.

(4) A notice referred to in subsection (2)(b) must include the following information:

If the offender is a body corporate - 500 penalty units.

17 Publication of notice of proposal

(1) The Minister must cause a notice containing the following information to be published in a newspaper circulating in the Torritory or in the area to which the proposal relates:

> (a) that a proposal to amend a planning scheme, or to grant or vary an exceptional development permit, is to be placed on exhibition;

 (b) each place where the proposal is to be placed on exhibition;

(c) the period of exhibition;

(3) If a proposal rolates to land that is not within a Division area or is within more than one Division area, the Minister must appoint a person or body (which may be a Division of the Development Consent Authority) to be the reporting body.

22 Submissions and hearing

(1) A porson may, within the period during which a proposal is on exhibition, make a written submission about the proposal to the reporting body.

(2) If the reporting body receives any submissions, it must conduct a hearing in respect of these submissions and invite all persons who have made submissions to appear at the hearing and be heard in relation to the proposal.

(3) The hearing must be conducted with the minimum of formality and in a manner that onsures procedural fairness.

23 Directions by Minister relating to consultation

(1) If the Minister requires a reporting body to carry out consultation in addition to the other processos required by this Division, the Minister must in writing direct the reporting body to do so.

(2) The direction may include requirements about the persons with whom, and the manner in which, the consultation is to be carried out.

24 Reports

(1) After the reporting body has conducted a hearing in respect of submissions about a proposal, and carried out any consultation as directed by the Minister, the reporting body must provide the Minister with the submissions and a written report about:

(a) issues raised in the submissions;

(b) issues raised at the hearing and during any consultation; and

(c) any other matters the reporting body considers the Minister should take into account when considering the proposal.

(2) If no submissions are received by the reporting body, it must provide the Minister with a written report about issues raised during any consultation and any other matters it considers the Minister should take into account when considering the proposal. (3) The Minister may also request any other person or body to give the Minister a written report about matters relevant to the proposal or to anything referred to in the reporting body's report.

Summary of Progress:

The Strategic Leisure Group has undertaken the following key tasks to date for the Youth Energy Precinct Feasibility Study:

- Review of background information
- Demographic and Leisure Trends Review
- Presentation to Council
- Meetings with internal Council stakeholders
- Site investigations and inspections
- Stakeholder engagement
- Design Workshop

Project Status:

Strategic Leisure Group has made four trips to Darwin to date, the most recent of which (August 4-7) was to:

- Update the Project Working Group (internal Staff) on progress and review outcomes of consultation with young people and preliminary facility analysis.
- Conduct a Design Workshop with young people, youth agencies and other key stakeholders identified in the study.
- Meet with potential users of/ partners in the proposed YEP and refine their potential involvement and levels of commitment.

Key Results From Youth Engagement, Consultation and Visioning

Key methods: Face-to-face consultation, surveys (211), comments cards (177), YAG, youth consultation team, new media.

- Appropriate Management and Operation of the YEP will be crucial to success.
- Involvement of Young People in design and management is critical.
- Transport and accessibility are core issues for location and viability of the YEP.
- Personal Safety at the YEP and in the surrounding area are major concerns which impact on choice of location and design.
- Bus is the most common form of transport- however there are concerns about safety on buses, at transit centres and when using buses at night.





Four locations were suggested during the investigation stage:

- Lot 7003, Leanyer: Vanderlin Drive, Leanyer. Behind the Leanyer Water Park
- Old Bunnings Site/ Casuarina Pool: Vanderlin Drive, Casuarina
- Lakeside Drive, Alawa
- Disused supermarket site, Progress Drive, Nightcliff

Key determinants of a preferred location were developed to assist in identifying a "successful" location:

Proximity to Public Transport Hub

Natural Surveillance

Complementary to Surrounds

Proximity to Youth Destinations

Suitability of Site

Availability of Site

A numerical value was applied to an assessment of these determinants for each site and the following overall scores were derived:

It should be noted that this assessment is based on existing conditions and that design and development strategies could increase suitability of some sites.

Design Workshop

A design workshop was held on the evening of the 6th August. Over 20 people attended and the Youth Consultation Team helped facilitate the session. The workshop was attended by young people, DCC staff, Alderman Sangster, members of YAG, youth agencies, schools and Arts organisations.

The purpose of the workshop was to review the results of the consultation phase and then to investigate design options for the YEP based on core elements.

One of the suggestions arising from the workshop was for the inclusion of a covered outdoor court which could act as a flexible space to cater for roller sports and other sports.

The main elements of the YEP are shown in the following table.
