#### SYNOPSIS:

A Proposed Subdivision Application for Section 5694 (41) Boulter Road Hundred of Bagot **(Attachment A)** has been referred to Council for comment pursuant to Section 48 of the Planning Act. The following report addresses relevant Council issues and recommends that Council endorse comments provided to the Development Consent Authority objecting to the application.

Area:

#### **GENERAL:**

Applicant: Mr Jack Devries

**Zone:** CP (Community Purpose)

## Proposal:

Subdivision to create 10 lots

#### History:

In July 2010 the Northern Territory Government gazetted the NT Planning Scheme Amendment 125 Berrimah North Planning Principles. The Plan known as the Berrimah North Area Plan nominated several intersections, stormwater management issues such as water sensitive urban design and other key planning principles (Attachment B).

In October 2010 an application to rezone Lots 5694 and 5695 from CP (Community Purpose) to MD (Multiple Dwelling Residential) was referred to Council by the Development Consent Authority for comment. No objection was raised at the time regarding the rezoning however, Council raised the issue of a future contribution plan for the provision of public infrastructure in Boulter Road. The Northern Territory Planning Scheme was amended by the Minister for Lands and Planning on 9 February 2011 in accordance rezoning the allotments from CP to MD.

#### Site and Surrounds:

The subject site is currently zoned MD (Multiple Dwelling Residential) and the applicant is proposing to subdivide the single parcel of land into 10 multi dwelling allotments, allowing for up to 32 multiple dwellings to be built on the site.

The allotment is currently unused. The allotment is surrounded by Community Purpose Zone Land and is directly adjacent to land used as a plant nursery, with the rear boundary abutting the Marrara Christian College.

The site is predominantly flat with no permanent structures other than some limited mature vegetation. No easements exist on the site and access is from Boulter Road.

Matters to be taken into account (pursuant to Section 51 of the NT Planning Act 1999):

#### Northern Territory Planning Scheme:

The proposed development is in the MD (Multiple Dwelling Residential) zone, and requires consent for this proposal.

#### **Disability Discrimination Legislation:**

Disability Discrimination Act issues are addressed under the Building Act requirements. Council places a statement of support for equal opportunity on all responses.

#### **Council Issues:**

As a result of the development of the Berrimah North Area Plan, Council identified the need for the provision of upgrade infrastructure within Boulter Road to service the rezoning and infill of this area.

Consequently, Council has engaged a consultant to assess future infrastructure needs and prepare a contribution plan for Boulter Road Upgrades and associated infrastructure including roadworks, stormwater drainage and street lighting. All development that occurs in the area covered by the proposed contribution plan will be subject to a financial contribution towards this infrastructure.

This Plan will ensure that capital assets associated with the rezoning and infill of the area is attributed to the land developers not the general community. Should the Development Consent Authority approve this application, Council requires that a Development Permit Condition requiring that a financial contribution be paid in accordance with Darwin City Council requirements or an associated contribution plan that may be in place at the time of finalisation of the subdivision and title release.

The Berrimah North Area Plan and Planning Principles states:

#### 14.1.2 Berrimah North Planning Principles

- *"3. Provide safe, accessible, equitable and interesting built environment and public domain that includes:* 
  - (a). a robust and legible shared use street grid which connects with the adjacent street network, pedestrian and cycle routes;
  - (b). pedestrian and cycle paths which are clearly defined, attractively landscaped to provide shade and interest, well connected to existing routes;
  - (c). consistent provision of high quality street furniture, paving, wayfare signage and pathway lighting;
  - (d). thoughtful integration of public art;
  - (e). a series of connected, landscaped public open spaces and corridors designed to facilitate comfortable and safe use during the day and night;
  - (f). impounded water bodies with appropriate water quality for their intended use;
  - (g). positive relationships between buildings and streets to promote passive surveillance; and
  - (h). active frontages and visually interesting ground level uses.
- 4. Promote climatically responsive, energy efficient urban design and architecture that contributes to the character of the precinct by:
  - (a). implementing sensitive water use practices across the site;
  - (b). implementing a whole-of-site water management system which addresses both stormwater and groundwater;
  - (c). incorporating strong landscape treatments to provide shade and which are largely comprised of native vegetation'
  - (d). identifying areas of pedestrian priority over vehicle traffic;
  - (e). providing seating, shade and weather protection to adjacent pedestrian footpaths;
  - (f). facilitating natural cross ventilation;
  - (g). integrating generous balconies for outdoor living'
  - (h). minimising direct solar penetration to all buildings through orientation and use of screens, awnings, eaves and the like; and
  - (i). using construction materials appropriate to a tropical environment".

The proposed subdivision and road layout plan within this application, is not in accordance with the Berrimah North Area Plan, which nominates specific road access points to Boulter Road. The proposed subdivision layout introduces a new intersection point within Boulter Road, which Council does not support. The proposal presents the opportunity for all lots fronting Boulter Road to establish similar cul-de-sac access points, resulting in multiple crossovers within close proximity to one another resulting in significant traffic issues.

Should the Development Consent Authority approve this intersection it may restrict the future rezoning and development of surrounding land. The approval of this application would be a significant departure from the Berrimah North Area Plan. It will be recommended that the Development Consent authority be advised that Council does not support any subdivision that is not in accordance with the Berrimah North Planning Principle and Area Plan. In addition, should the Development Consent Authority approve this application then Council will not accept the road and other social infrastructure (i.e. open space) within the current boundaries of Section 5694 (41) Boulter Road.

The response letter further advises that Council would support the deferment of this application to allow the development, consideration and adoption of a revised Berrimah North Area Plan that promotes consistent and orderly subdivision of the area and may address this proposal. Alternatively, Council would support the subject site remaining a single freehold lot with a single private crossover to Boulter Road, with an internal unit title subdivision.

The response letter also notes the plan's failure to demonstrate;

- (a) an adequate road network layout plan for the subdivision which forms part of an overall network plan in accordance with the Berrimah North Area Plan;
- (b) integrated pedestrian and cycle paths;
- (c) consideration of the predicted effects of climate change in its urban design principles including effective on-site water management;
- (d) integration of public art; and attractive landscape treatments comprised of native vegetation.

Plans also indicate that the cul-de-sac turn around area is to have a radius of 8.5m. This is insufficient for a waste collection vehicle and it has been requested that it be increased to a minimum of 9.5m.

Council further requests that if this application was to be endorsed by the Development Consent Authority then a pre-condition be that information regarding water sensitive urban design within the site be provided to Darwin City Council for approval. All stormwater discharged from the site into Council's stormwater drainage system must be at pre-development flows and water quality must be to the satisfaction of Darwin City Council and relevant Northern Territory Government Authorities.

Council has requested that any infrastructure plans required for roads, stormwater, sediment and erosion, and landscaping and open space be submitted to the General Manager Infrastructure for approval. Council has also requested that any infrastructure that is to be its responsibility is to be located within its road reserve or public open space and must also accommodate the predicted adverse effects of climate change. Responsibility for any infrastructure located within private land will not be accepted by Council.

#### REVISED Parcel Description: Section 5694 (41) Boulter Road Hundred of Bagot Proposed Development: Subdivision to create 10 lots.

Thank you for the Development Application referred to this office 21 April 2011, concerning the above. This letter may be placed before the next Ordinary Council Meeting. Should this letter be varied or not endorsed by Council, you will be advised accordingly.

The following issues are raised for consideration by the Authority:

- Council objects to the granting of a Development Permit for the following reasons:
  - Council objects to this application as it does not adhere to or clearly demonstrate how it will comply with the Northern Territory Planning Scheme Section 14.1.2 Berrimah North Planning Principles and associated Area Plan.

Council's concerns are predominantly with Sections 14.1.2.3 and 14.1.2.4 being the Berrimah North Planning Principles which aim to:

- 14.1.2.3 "Provide safe, accessible, equitable and interesting built environment and public domain...", and;
- 14.1.2.4 "Promote climatically responsive, energy efficient urban design and architecture that contributes to the character...".

In this regard, Council notes the proposal specifically fails to demonstrate;

- (a) an adequate road network layout plan for the subdivision which forms part of an overall network plan in accordance with the Berrimah North Area Plan;
- (b) integrated pedestrian and cycle paths;
- (c) consideration of the predicted effects of climate change in its urban design principles including effective on-site water management;
- (d) integration of public art; and
- (e) attractive landscape treatments comprised of native vegetation.

Furthermore, the proposed subdivision layout introduces a new intersection point within Boulter Road, which Council does not support. It is noted that the Development Consent Authority concurs with this view. The proposal presents the opportunity for all lots fronting Boulter Road to establish similar cul-de-sac access points, resulting in multiple crossovers within close proximity to one another resulting in significant traffic issues.

Should the Development Consent Authority approve this intersection it will/could restrict the rezoning and development of surrounding land. The approval of this application would be a significant departure from the Berrimah North Area Plan. It will be recommended that the Development Consent authority be advised that Council does not support any subdivision that is not in accordance with the Berrimah North Area Plan. In addition, should the Development Consent Authority approve this application that Council will not accept the road and other social infrastructure (i.e. open space) within the current boundaries of Section 5694 (41) Boulter Road

Council would support the deferment of this application to allow the development, consideration and adoption of a revised Berrimah North Area Plan that promotes consistent and orderly subdivision of the area and may address this proposal.

b) Alternatively, Council would support the subject site remaining a single freehold lot with a single private crossover to Boulter Road, with an internal unit title subdivision.

# ii). Should the above issues be adequately addressed, Council requests the following also be addressed:

#### General Infrastructure

a) Council has requested that any Infrastructure plans required for roads, stormwater, sediment and erosion, and landscaping and open space be submitted to the General Manager Infrastructure. Council has also requested that any infrastructure that is to be its responsibility is to be located in its road reserve or public open space and must also accommodate the predicted adverse effects of climate change. Responsibility for any infrastructure located within private land will not be accepted by Council.

#### Infrastructure contributions plan

b) Council is currently assessing future infrastructure needs and preparing a contributions plan for Boulter Road upgrades and associated infrastructure including roadworks, stormwater drainage and street lighting. All development that occurs in the area covered by the contributions plan will be subject to a contribution towards this infrastructure upgrade.

This plan will ensure that Capital assets associated with the rezoning and intensification of use for the area is attributed to the land developers not the general community. Should the Development Consent Authority approve this application, Council requires that a Development Permit Condition requiring that a contribution be paid in accordance with Darwin City Council requirements or a plan that may be in place at the time of finalisation of the subdivision and title release.

#### Climate Change

c) Infrastructure should be designed to try to accommodate for a change in weather patterns as a result of climate change. Research indicates that there will be an increase in annual rainfall, an increase in the number of days of high temperature and that storm events are predicted to occur less often but of a greater intensity than currently experienced.

#### **Road Network**

d) The design and specifications for any driveway shall be provided in accordance with Councils guidelines and technical requirements, to the satisfaction of the General Manager Infrastructure, Darwin City Council.

The plans indicate that the cul-de-sac turn around area is to have a radius of 8.5m. This is insufficient for a waste collection vehicle to turn around and should be increased to a minimum of 9.5m. All road design should allow for free turning of Heavy Rigid Vehicles (i.e. Waste Collection Trucks).

#### Stormwater Drainage

- e) The design and specifications for the proposed stormwater drainage connections to Council's network shall be provided in accordance with Councils guidelines and technical requirements, to the satisfaction of the General Manager Infrastructure, Darwin City Council.
- f) Council further requests that if this application was to be endorsed by the Development Consent Authority that a pre-condition be that information regarding water sensitive urban design within the site be provided to Darwin City Council for approval. All stormwater discharged from the site into Council's stormwater drainage system must be at pre-development flows and water quality must be to the satisfaction of Darwin City Council and relevant Northern Territory Government Authorities.

#### Sedimentation and erosion plan

g) Council requests the Authority requires an erosion and sediment control plan relevant to the works being proposed prior to the commencement of works. The discharge of any stormwater into Council's drainage system is to be to a standard such that it will not have detrimental impacts upon the environment. Council will not allow any polluted stormwater run-off into its drainage systems.

#### Allotment Setbacks

g) Council does not support the setback of buildings less than that outlined in the Northern Territory Planning Scheme.

#### Landscaping and Open Space

- h) The design and specifications for any proposed landscaping with the road reserve shall be provided in accordance with Councils guidelines and technical requirements, to the satisfaction of the General Manager Infrastructure, Darwin City Council.
- i) Any areas of public open space should consider Crime Prevention Through Environmental Design (CPTED) principles.

Council comments on issues for which it is the sole responsible authority, under the Local Government Act and associated By-Laws:-

- a). Council requests the Authority requires a schematic plan demonstrating all stormwater to be collected on the site and discharged to the satisfaction of Council's General Manager Infrastructure. The applicant's plans fail to demonstrate how onsite stormwater will be collected and discharged without the provision of Council's stormwater infrastructure and drainage network.
  - 1). The plan shall include details of site levels and demonstrate how the proposed development will be connected to Council's future stormwater drain connection point/s. The plan shall also indicate how stormwater will be collected on the site and connected underground to Council's future system.
  - Council requires a stormwater drainage plan to confirm that it is technically feasible to collect stormwater on the site and dispose of it. It is also necessary to ensure that no stormwater will sheet-flow into the road reserve or onto adjoining properties.

Should this application be approved, the following conditions pursuant to the Planning Act and Council's responsibilities under the Local Government Act are also recommended for inclusion in the Development Permit issued by the Development Consent Authority.

- All development is to conform to Councils relevant Subdivision and Development Guidelines at the time of a development permit being issued.
- A contribution plan for the future upgrade of Boulter Road is being developed by Council and will apply to this application.
- Full designs, drawings, specifications, construction and certifications for all works associated with the subdivision in accordance with Councils Subdivision and Development Guidelines shall be submitted for approval, prior to any construction activity on site, by the General Manager Infrastructure, Darwin City Council and all approved works constructed to Council requirements at the applicant's expense.
- Kerb crossovers and driveways to the site shall be provided and disused crossovers removed, public footpath and cycleways shall be provided, stormwater shall be collected and discharged into Council's drainage network, and reinstatement works carried out, all to the requirements and satisfaction of the General Manager Infrastructure, Darwin City Council and at no cost to Council.

- All developments on or adjacent to any easements on site in favour of Council shall be carried out to the requirements and satisfaction of the General Manager Infrastructure, Darwin City Council.
- Engineering design and specifications for the proposed and affected roads, including streetlighting, stormwater drainage, vehicular access, pedestrian/cycle corridors, streetscaping and landscaping of nature strips shall be submitted for approval by the General Manager Infrastructure, Darwin City Council. All works are to be designed, constructed and maintained to Council's Subdivision and Development Guideline requirements at the applicant's expense.
- Any easements or reserves required for the purposes stormwater drainage, roads, access or for any other purpose shall be made available free of cost to the Darwin City Council or neighbouring property owners.

In considering this application, the Development Consent Authority is requested to take into account any implications of the Disability Discrimination Act (Cth) or the Anti Discrimination Act (NT) with regard to access for the disabled.

## ITEM NO: 13.3

### SYNOPSIS:

A Planning Scheme Amendment for Section 5602 (55) Boulter Road Hundred of Bagot **(Attachment A)** has been referred to Council for comment pursuant to Section 48 of the Planning Act. The following report addresses relevant Council issues and recommends that Council endorse comments provided to the Development Consent Authority by staff.

### **GENERAL:**

Applicant: Earl James and Associates

**Zone:** CP (Community Purpose) **Area:** 1.83 m<sup>2</sup>

### Proposal:

Rezone from CP (Community Purpose) to MD (Medium Dwelling Residential)

History:

#### Site and Surrounds:

In July 2010 the Northern Territory Government gazetted the NT Planning Scheme Amendment 125 Berrimah North Planning Principles. The Plan known as the Berrimah North Area Plan nominated several intersections, stormwater management issues such as water sensitive urban design and other key planning principles. **(Attachment B)** 

The subject site is currently zoned CP (Community Purpose) and the applicant is proposing to rezone to MD (Multiple Dwelling Residential). Surrounding land is predominantly CP.

The site is relatively flat with a large built structure that appears to be for residential use. There is also limited mature vegetation with expanses of open space between structures.

The site is directly adjacent land that is used as a plant nursery and is opposite the Council for Aboriginal Alcohol Program Services. The rear boundary abuts Marrara Christian College. The southern boundary is also utilised for Community Purposes.

No easements exist on the site and access is from Boulter Road.

Matters to be taken into account (pursuant to Section 51 of the NT Planning Act 1999):

### Northern Territory Planning Scheme:

The proposed development is in the CP zone, and requires consent to be rezoned.

#### **Disability Discrimination Legislation:**

Disability Discrimination Act issues are addressed under the Building Act requirements. Council places a statement of support for equal opportunity on all responses.

#### **Council Issues:**

Council objects to this application as it does not demonstrate how it will contribute to the future development of the area and its adherence to the Berrimah North Planning Principles and associated Area Plan.

In this regard, Council staff are concerned that lots already rezoned to MD within the Berrimah North Area are diverting from the Planning Principles and associated Area Plan by proposing additional intersections with Boulter Road, which could result in a poor urban design and traffic outcomes and ongoing management issues for Council and restrict the development opportunities for this site.

As a result of the development of Berrimah North area, Council has identified the need to upgrade infrastructure with Boulter Road to service the rezoning and infill of this area. Council is currently assessing future infrastructure needs and preparing a contribution plan for the Boulter Road upgrades and associated infrastructure is including roadworks, stormwater drainage and street lighting.

This Plan will ensure that capital assets associated with the rezoning and infill of the area is attributed to the land developers not the general community. The response letter indicates that any development that occurs in the area covered by the contribution plan will be subject to a contribution towards this infrastructure upgrade.

The above information is contained within the response letter to the Development Consent Authority (Attachment C).

The Berrimah North Area Plan and Planning Principles states:







### i). Council objects to the scheme amendment for the following reasons:

a) The proposed rezoning is in keeping with the zones and uses identified in the Northern Territory Planning Scheme Section 14.1.2 Berrimah North Planning Principles. However, Council cannot support this application as it does not clearly demonstrate how it will comply with the Berrimah North Planning Principles and associated Area Plan.

In this regard, Council is concerned that lots already rezoned to MD within the Berrimah North Area are diverting from the Area Plan, which could result in poor urban design and traffic outcomes and ongoing management issues for Council.

b) Council is currently assessing future infrastructure needs and preparing a contributions plan for Boulter Road upgrades and associated infrastructure including roadworks, stormwater drainage and street lighting. All development that occurs in the area covered by the contributions plan will be subject to a contribution towards this infrastructure upgrade. This plan will ensure that Capital assets associated with the rezoning and intensification of use for the area is attributed to the land developers not the general community. The subject site is identified as allotment 1707, Town of Nightcliff commonly referred to as 138 Ryland Road, Rapid Creek. The site is currently zoned SD (Single Dwelling) and the proponent has applied to rezone it MD (Multiple Dwelling Residential).

The site is predominantly flat with an existing single dwelling. A metal boundary fence and some limited vegetation are also present on site.

The site abuts lots in the SD, MD and MR zones. To the north-west of the site immediately adjacent is zoned MD and the site to the south-east is zoned SD. The rear boundary abuts land zoned MR (Medium Density Residential). An allotment surrounded by SD zoned land to the south-east is zoned MD. This lot is one separated from the subject site by one lot.



#### Attachment A - Description of Proposed Amendment


This proposal to amend the NT Planning Scheme seeks for the Minister for Lands and Planning to rezone Lot 1707 (138) Ryland Road, Town of Nightcliff from Zone SD (Single Dwelling Residential) to Zone MD (Multiple Dwelling Residential) to facilitate future redevelopment opportunities consistent with the development that has occurred and has the potential to occur on surrounding land.

Lot 1707 is located in the suburb of Rapid Creek with frontage to Ryland Road. The site has an area of 931 m<sup>2</sup> and is of regular shape. It is located within walking distance of the local park on Clarke Crescent, the recently renovated Rossiter Street shops and the Rapid Creek foreshore conservation parklands. The site is also proximal to the Rapid Creek Shopping Centre and to local primary and middle schools. Additionally the site is on the key Bus Route 4 (with an all weather bus shelter only 2 doors down) providing direct linkages to Darwin City, Casuarina Shopping Centre and local amenities, as well as recreation facilities located at Nightcliff and the Charles Darwin University's Casuarina campus.

The site is currently developed with an aging ground level single dwelling which was constructed in the early 1980s; some thirty years ago.

Figure 1 below identifies the existing zoning regime that applies to Lot 1707 and the surrounding locality.

#### **SYNOPSIS:**

Darwin City Council has now conducted two consistent Annual Community Satisfaction Survey's in July 2009 and 2010.

McGregor Tan has again been engaged to run the 2011 survey, commencing the week of 18 July 2011.

The purpose of this report is to seek Council's endorsement of the proposed questionnaire for this years survey (**refer Attachment A**).

#### **GENERAL:**

As with previous years, McGregor Tan's proposal includes sampling and questionnaire design, piloting of the surveys, fieldwork including supervision, briefing, interviewer costs, quality control and validation, telephone and online costs, travel costs, data preparation and processing, data analysis, documentation, reporting and a presentation of results.

We are pleased to note that McGregor Tan has now moved from using the electronic white pages and has now accessed a database from CustomLists.net that includes both landlines and mobile numbers, therefore increasing the reach of community members.

As with last year, Council will also provide hard copy survey questionnaires at the Civic Centre and Council libraries.

In regards to the proposed questionnaire, it is desirable that the core set of questions remain the same each year in order to accurately monitor and analyse movement in the results. However, there is also scope to include some 'hot topic' questions – questions that may only be relevant at a point in time to understand a current situation or threat.

Now that the survey has been consistently run over the past two years and we are now just beginning to establish new data sets, it is therefore recommended not to make any wholesale changes to the questions.

Please refer to Attachment A for a copy of the proposed questionnaire.

#### FINANCIAL IMPLICATIONS:

The quoted price for conducting the survey is \$25,000 (excluding GST). This includes 'pilot testing' the survey with approximately 20 residents, conducting the Computer Aided Telephone Interview (CATI) with 700 residents and developing the final report including a presentation of results.

Funding for this has been included in the 2011/2012 budget.

#### SYNOPSIS:

This report presents a summary of Darwin City Council's performance as at 31 March 2011 against the Evolving Darwin, Towards 2020 Strategic Plan and the 2008-2012 Corporate Plan (Attachment A).

#### **GENERAL:**

#### Background

The Evolving Darwin, Towards 2020 Strategic Plan contains a suite of 'State of the City' indicators and also 'Strategic Indicators'. The purpose of these indicators is to provide Council's key decision makers with the most current information on the external environment and a quantitative assessment of how Council is progressing against achieving the goals and outcomes of the Evolving Darwin Plan. The final version of the Evolving Darwin, Towards 2020 Strategic Plan was endorsed by Council on 31 March 2009 (Decision Number 20/1387).

At that time Council also endorsed the 2008-2012 Corporate Plan. The Corporate Plan specifically outlines the long term, high profile activities that Council staff will be implementing to achieve the Evolving Darwin Strategic Plan.

Throughout both reports the use of traffic light symbols and icons have been used. These icons represent:-

- Green the target has been achieved;
- Yellow the result was within 10% of the target; and
- Red the result was an unfavourable variance of greater than 10%.

It should be noted, that many of the indicators contained within the report currently do not have targets and are identified as 'trend' indicators. Where possible, targets will be established for 2011/2012 which will be informed by actual data collected throughout the past two years.

#### Performance - Strategic Plan / Corporate Plan (Attachment A)

The "State of the City" indicators shows consistent growth in a number of areas. The Darwin population continues to grow, up by 1.82% from last year with an estimated residential population within the Darwin municipality of 77,290. The overall greater Darwin region (incorporating Palmerston and Litchfield) now totals 127, 532.

Unemployment rates have fallen over the past 12 months. The Northern Territory unemployment rates have decreased by 22.58%, currently there are 3,100 unemployed people in the Territory. The overall average Australian unemployment rate has also fallen, however at only a rate of 7.5% over the same period. In line with this, total earnings in Darwin has increased by 5.25% over the 12 month period compared to an increase of just 4.23% for the Australian average.

In regards to the housing market, the total number of recorded sale of houses and units within the Darwin municipality has again declined – down 41.3% over the past 12 months. Unit rental vacancy rates still remains tight at 2%, however vacancy rates for houses has increased to 3.6%.

The total amount of office space in Darwin has decreased by 10,872 sqm. The majority of Darwin Office space is graded as "Premium / A Grade" at 49.74% (an increase of 2.48 percentage points). B grade has also increased from 30.82% to 32.44%, C and D grade stock has decreased.

Council's performance against the Corporate Plan is strong.

Of the 132 actions identified in the Corporate Plan:-

- 63% are 'ongoing' actions
- 13% are progressing within the specified timeframes
- 15% have been completed
- 8% are progressing but have fallen slightly behind schedule
- 1% have had there start dates deferred until next financial year (due to budgeting reasons)
- 1% are not yet scheduled to start.

Council has met or exceeded the majority of its Strategic Plan performance indicators.

#### **EXECUTIVE SUMMARY**

Darwin City Council made a commitment to regularly review and report on progress against Council's Evolving Darwin, Towards 2020 and Beyond Strategic Plan which was endorsed by Council on 31 March 2009.

The Evolving Darwin plan sets out the long term direction for Council, detailing Council's vision for the municipality, the goals and outcomes that Council will strive to achieve for our community and the strategies which illustrate how Council is going to achieve these outcomes.

The Evolving Darwin plan also contains a suite of "State of the City" indicators. These indicators, although in the majority of cases are outside of Council's control, are important to monitor. These indicators help us understand the current state of our municipality and will allow Council to more accurately plan for future services and infrastructure that match our changing population and community needs.

The Darwin population continues to grow, up by 1.82% from last year with an estimated residential population within the Darwin municipality of 77,290. The overall greater Darwin region (incorporating Palmerston and Litchfield) now totals 127, 532.

Unemployment rates have fallen over the past 12 months. The Northern Territory had an unemployment rate of 3.1% in March 2010, now at 2.4% as at March 2011, representing a decrease of 22.58%. The overall average Australian unemployment rate has also fallen, however at only a rate of 7.5% over the same period. In line with this, total earnings in Darwin have increased by 5.25% over the 12 month period compared to an increase of just 4.23% for the Australian average.

In regards to the housing market, the total number of recorded sale of houses and units within the Darwin municipality has again declined – down 41.3% over the past 12 months. Unit rental vacancy rates still remain tight at 2%, however vacancy rates for houses has increased to 3.6% (highest rate since December 2006). These trends are also reflected in the average weekly rental prices, with the most significant decrease occurring in 3 bedroom houses in the inner city where the average price is currently \$566, down from \$717 for the same period last year. Prices for houses in the Northern suburbs are only slightly lower and unit rental prices are relatively unchanged. The sale prices for houses and units have not yet shown any decreases.<sup>1</sup>

In terms of Darwin City Council's performance against the Evolving Darwin: Towards 2020 and Beyond Strategic Plan, the overall picture is good. The majority of actions and supporting indicators are on track to achieve the planned results. Contained within the report are further details including the current status of all actions.

A number of the supporting indicators can only be measured annually, therefore will be reported in the June 2011 progress report.

Until the next report "Progrediamur" - "let us go forward".

#### **STATE OF THE CITY - Social**

#### **Overview of Social Indicators**

As shown in **Figures 1** and **2**, the Darwin municipality (local government area), has experienced consistent population growth since 2003. The latest estimated residential population per the ABS data shows the Darwin population is currently 77,290, up from 75,908 in 2009, which represents a growth of 1.82%.

The fastest growth area in the municipality occurred in Lyons with 732 residents, representing a growth rate of 56.39%. The other contributing factor was growth in the Inner City, with an additional 485 residents set up home in the City, representing 11.77% growth. Growth also occurred in the following suburbs; Bayview/Woolner (4.03%), Parap (2.86%), Tiwi (2.63%) and Wanguri (2.17%). All other suburbs remained relatively stable with the exception of Larrakeyah which decreased by 4.43%. Refer to **Figure 3** for further information.

As at June 2010, 127,500 resided in the overall Darwin Statistical Division (SD), which incorporates Litchfield and Palmerston, representing an increase of 2,600 (2.61%). The Darwin SD was the second fastest growing capital city SD in Australia, with Darwin continuing to account for approximately one-third of the entire NT population.


Darwin's growth rate was the lowest in the overall Darwin SD at 1.82%. The average growth rate for the statistical division was 2.17%. For the first time since 2006-07 Litchfield grew by 2.92% and overtook Palmerston as the fastest growing LGA in the NT. Palmerston experienced a 2.67% growth rate. The current figure for the whole of the Northern Territory is 229,700, an increase of 1.5%.


Not surprisingly, Darwin has the lowest population density of any capital city SD in Australia at 41 people per sq km. Nightcliff and Wagaman are currently have the highest density rates at 2,700 people per sq km.


Figures 4-6 are based on Census data, therefore no change since the last progress report.


**Figure 7** shows that unemployment rate in the Territory is far lower than the Australian average (2.4% compared to 4.9%). Although NT unemployment is lower, it seems to be trending down in the same manner as the Australian average. **Figure 8** translates the unemployment rate into real persons. Currently there are 3,100 unemployed people in the Territory.

**Figures 9 – 11**, represent students figures just for the Casuarina campus. The number of higher education students has decreased, however the number of vocational education and training (VET) students has risen. **Figure 10** shows that of the higher education students at the Casuarina campus, 65% are from the Territory, over 15% are from overseas representing an increase of 3% from last year (an additional 83 international students) with the remaining,19% coming from interstate. Further analysis shows that of the 65% from the Territory, 28% are from outside of the municipality. This means that more than half (52.97%) of the 3,147 students attending CDU are from areas outside of the Darwin municipality. Updated figures for 2010 will be sourced from Charles Darwin University for the June final report.


















Evolving Darwin, Towards 2020 Strategic Plan Progress as at March 2011





### **Overview of Economic Indicators**

**Figures 12 – 13** represents occupancy rates and takings for hotels, motels and serviced apartments (15 or more rooms) within the Darwin municipality. Seasonal fluctuations are expected for wet vs. dry season and this year seems to be tracking just a little better than previous years in both occupancy rates and takings from accommodation. Please note, the data is lagged therefore most recent data is as at December 2010.

**Figure 14** shows that since the end of 2007, Territorians are earning more than the Australian average. This figure is linked to the current unemployment rate which is lower in the NT compared to the rest of Australia. The latest figures available are November 2010 which show that Territorians are earning an average of \$1,063.90 per week as compared to the Australian average of \$996.60. The NT average earning rose 5.25% since November 2009 compared to the average Australian increase of 4.42% over the same period.

**Figures 15 – 20** is based on data from the Real Estate Institute of NT's "Real Estate Local Market" (RELM) report. The total number of recorded sale of houses and units within the Darwin municipality has again declined – down 41.3% over the past 12 months (inner Darwin down 46% and Northern suburbs down 40.1%). However the median price was increased slightly, up 3.6% from the same time last year (inner Darwin up by 2.6% and northern suburbs up by 10.3%). The highest number of house sales has occurred in Anula, followed by Karama, Lyons and Leanyer.

In relation specifically to units and townhouses, the majority of sales occurred in Darwin City followed closely by Stuart Park. The number of overall Darwin sales has decreased by 31.9% since last year (inner Darwin down by 23% and northern suburbs down by 26%). The median price for Darwin overall is up by 6.3% (inner Darwin still down by 0.7% since the same time last year but has experienced a 12.9% increase since last quarter).


This has also translated into lower rental prices with a 3 bedroom house in Darwin 4.4% lower than the same time last year (21.1% lower in inner Darwin and 1.6% lower in the northern suburbs).


Average rental prices for units have also decreased with a 2 bedroom unit in inner Darwin down 8.4% and down by 3.2% in the northern suburbs.




This has shown that the total amount of office space in Darwin has decreased by 10,872 sqm. The majority of Darwin Office space is graded as "Premium / A Grade" at 49.74% (an increase of 2.48 percentage points). B grade has also increased from 30.82% to 32.44%, C and D grade stock has decreased.


The total vacancy rate of office space has decreased from 8.4% to 7.2%. Premium / A grade vacancies have decreased, C grade has decreased and the biggest decrease was in the D grade stock, falling from 62.6% to 14%. Only B grade stock vacancy rate has increased from 6.3% to 9.38%.


















### **Overview of Environmental Indicators**

According to the latest ABS data (Energy in Focus: Energy Efficiency of Australian Homes, April 20010), solar energy was used by an average of 7% of Australian households for heating water in 2008, nearly double the use in 2005. However, the Northern Territory by far exceeds the Australian average and all other states and territories with 54% of Territorians using solar energy to heat water, up from 42% in 2005.

Also according to ABS statistics (Environmental Issues: Water use and conservation, March 2010), in percentage terms the Northern Territory ranks the highest in having dual flush toilet systems yet the lowest across Australia in having water-efficient shower heads. The Territory also ranks the lowest in using rainwater from rainwater tanks and in use of grey water (1.3% compared to Australian average of 9.1% and 5.6% compared to 15.9% respectively).

The positive areas of this report shows that Territorians are above the Australian average when it comes to using mulch, watering at cooler times of the day, watering more thoroughly but less frequently and watering only when necessary.

**Table 2** outlines current Council data against the Environment indicators. **Table 3** has been collected through the recent Annual Community Satisfaction survey. Residents within the Darwin municipality have a very high propensity for travelling by car with a very disappointing number utilising public transport, with results worsening from 2009.

#### ITEM NO: 13.9

#### SYNOPSIS:

Pursuant to Part 5.2 of the Local Government Act 2008, Council may establish committees. In addition, Council may appoint representatives to outside organisations.

This Report provides the framework for Council to make appointments to Committees and Outside Organisations.

As the 2012 Council general election will be held on Saturday 24 March 2012, appointments to committees and outside organisations will terminate on Friday 23 March 2012. The incoming Council will then determine the appointments.

#### **GENERAL:**

Part 5.2 of the Local Government Act 2008 provides the power for Council to establish Executive and Advisory Committees:

#### Part 5.2 Council committees

#### 54 Council committees

- (1) A council may establish council committees.
- (2) A council committee consists of the persons appointed by the council to be members of the committee.
- (3) The members of a council committee may consist of, or include, persons who are not members of the council.

#### Note

A member of the council's staff is eligible for appointment as a member of a council committee (even though staff members may be disqualified from membership of the council itself).

- (4) The terms and conditions on which a person holds office as a member of a council committee are to be as determined by the council.
- (5) The council may abolish a council committee.

#### 55 Nature of committee's functions

- (1) A council committee has the functions assigned to the committee by the council.
- (2) The assigned functions may be of an executive or advisory nature.
- (3) An executive committee carries out, on behalf of the council, functions delegated to it by the council.

#### 56 Control and direction by the council

A council committee is subject to control and direction by the council.

#### 57 Procedure

Subject to any directive by the Council, a Council may determine its own procedure.

#### FINANCIAL IMPLICATIONS:

Elected Members are entitled to an Extra Meeting Allowance when attending meetings of external agencies or organisations to which the Council has formally appointed or nominated through or with LGANT, a representative.

The draft 2011/2012 Municipal Plan is currently out for community consultation and includes Extra Meeting Allowances within the budget.
