KEY ISSUES

- The purpose of the Local Government Special Purpose Grants is to improve community infrastructure and service delivery outcomes.
- The Department generally offer two rounds of Special Purpose Grants each financial year. Given the recent election and the late calling for applications the Department is only offering one round for the 2012/2013 year.
- There is a total of \$2.9m grant funding that will be shared on a priority basis across the Northern Territory.
- Applications close on 30 November 2012.

RECOMMENDATIONS

THAT Report Number 12TC0091 entitled Special Purpose Grant Funding, including **Attachments A & B**, be received and noted.

BACKGROUND

The Department of Local Government offer grant funding to Northern Territory municipal and shire councils via the Special Purpose Grants program.

The objectives of the program are:-

- To support the implementation of key Northern Territory Government policy platforms such as Stronger Futures, Territory 2030 and the growth town Local Implementation Plans.
- To assist in the delivery of key outcomes outlined in the shire and municipal strategic and/or operational plans and the regional management plans.
- To assist in developing local government capacity to provide legitimate representation, effective governance, improved service delivery and sustainable development.
- To assist local governing bodies and the constituent communities they represent to become stronger and self sustaining.
- To assist in the delivery of essential council infrastructure and services.
- To provide a potential source of additional funding to those non local government bodies that provide local government/municipal services (e.g. trustees of reserves, cemetery trusts and LGANT).

The City of Darwin has been successful in securing funding for three projects over the past few years.

DISCUSSION

The City of Darwin was first advised on 7 November 2012 that a round of Special Purpose Grant Funding had opened. Applications are due by 30 November 2012.

In discussion with the Chief Officers Group and Managers, two projects have been identified as priorities for Council.

Civic Centre Generator Project

Total funding of \$260,000 is required to purchase, install and connect a back up generator for the Civic Centre. This funding includes minor building works that will be required to install the generator. Refer **Attachment A.**

The Nightcliff Community Centre Hall Cooling Project

A total of \$422,228 is being sought to fund this project. The project scope includes, the installation of solutions for reducing the internal temperature of the hall to ensure usability all year round. Refer **Attachment B**.

Please note, in addition to the two applications as provided, the City of Darwin as TOPROC secretariat, will also be lodging an additional application. On behalf of TOPROC we will be seeking \$115,000 to fund a consultancy regarding developing appropriate governance models for a new regional waste management facility.

Nil budget implications. As shown in **Attachments A and B**, the City of Darwin has not committed any additional funds. We have however, committed staff time to each of these projects.

In addition to the upfront costs, both of these projects will require very minor increases to the annual capital works program for the ongoing maintenance of these new assets.

RISK/LEGAL/LEGISLATIVE IMPLICATIONS

As shown in **Attachment A**, if Council was successful in securing funds for a generator, the risk of being unable to provide essential services in the event of a cyclone or extreme weather event would be significantly reduced.

There is no risk or legislative implication in relation to the Nightcliff Community Centre Hall Cooling Project as provided in **Attachment B**.

ENVIRONMENTAL IMPLICATIONS

There are no environmental implications in relation to the Civic Centre Generator Project.

As shown in **Attachment B**, environmentally preferable and energy efficient solutions have been sought for the Nightcliff Community Centre Cooling Project.

PROJECT DETAILS

The City of Darwin plays a key role in the Northern Territory All Hazards Emergency Management Plan including:

- Emergency response recovery'
- Public Information
- Emergency Management Support arrangements

The Council is progressively upgrading its systems for emergency management to provide an effective support framework across all levels of government.

The tropical weather in the top end causes severe weather patterns which cause varying levels of damage and power outages. It is therefore vital that the City of Darwin can continue to operate in the instance of a power outage in order to continue delivering essential services to the Darwin community. Timely communication between the community and Council is especially critical during an extreme weather event.

The City of Darwin does not have a back up generator it can power the Civic Centre in the case of a power outage. Currently, when a Cyclone Watch is declared, Council has to hire a back up generator to have on site in case the Civic Centre loses power. In addition, an electrician is required to make a connection and operate the manual transfer switch. This poses a major risk in the event of a major disaster.

This funding will be used to purchase a generator to power the Civic Centre in the instance of a power outage. The generator will be able to provide power to the whole building, running all equipment necessary to provide the community with essential services and timely communication during a cyclone. This will ensure business continuity for the organisation and allow Council to implement its Emergency Management Plan and Community Resilience Plan.

If successful in receiving the grant the City of Darwin will purchase a single generator providing 350kVA load. Standard generator acoustic enclosures provide sound attenuation to between 75dBA and 80dBA at 1m. The proposed generator enclosure has a rating of 60dBA which will reduce noise disturbances for nearby residents. The proposed generator is also designed that in the event of a power failure the generator will automatically switch the building load onto the generator supply. When mains power is restored, the building load will automatically switch back

to mains power and the generator will run down and stop. In addition, this system will also include power monitoring facilities, meaning that the unit has the ability to have a future connection to enable remote web based monitoring.

The requested \$260k also includes the installation and associated controls, cabling and the like.

DOES THE PROPOSED PROJECT RELATE TO THE MUNICIPAL STRATEGIC PLAN? YES

The City of Darwin is finalising its Strategic Plan.

WHAT ARE THE ONGOING COMMUNITY BENEFITS EXPECTED FROM THIS PROJECT?

The purchase of a new generator will provide assurance of ongoing essential service delivery and critical communication to the Darwin community in the case of a cyclone or an extreme weather event. This will ensure business continuity for the organisation and allow Council to implement its Emergency Management Plan and Community Resilience Plan in the case of a power outage. This will contribute to Council providing the best level of safety and service for the community. This will be an ongoing benefit as this is a realistic threat every wet season in Darwin.

WHAT OTHER SOURCES OF FINANCE HAVE BEEN CONSIDERED TO FUND THE PROJECT?

The City of Darwin has previously applied for a Special Purpose Grant for this project.

OUTLINE WHAT THE MUNICIPAL'S COMMITMENT IS TO THE PROJECT IN CASH AND KIND?

This project forms part of a larger overall project focussing on Council's business continuity processes. Over the past year, the City of Darwin has invested in excess of \$250k in the larger Business Continuity and Recovery (BCR) project.

The City of Darwin has purchased and implemented BCR software, developed Emergency Management Plans, BCR Plans and a Community Resilience Plan (*currently under development*). Included in this \$250k, the City of Darwin has committed funds for a UPS system to protect Council's electronic equipment from sudden power loss. The UPS also ensures the protection of all Council electronic data and records stored on Council's server. In addition to the UPS, a stand alone generator has been purchased specifically to power and protect Council's server (*expected delivery and installation 8 Dec 2012*). This generator is only for the server and does not provide power to the Civic Centre.

This is all in addition to Council's Guardian system which was implemented in 2008 to assist in the management of a disaster. Guardian is an innovative program that provides the City of Darwin a complete database to track, monitor and respond to all aspects of natural disasters. Every year the City of Darwin delivers extensive staff training and conducts simulations written, prepared by and delivered to City of Darwin staff.

The project is essentially the final piece of the City of Darwin's BCR strategy. With the range of plans and software that the City of Darwin now has in place, this generator will enable staff to continue working within the Civic Centre to deliver essential services in the event of an outage.

The City of Darwin will contribute in-kind costs to this project. Council's Building Manager will provide the project management for the purchase and set up of the generator.

WHAT FINANCIAL PROVISIONS WILL BE PUT IN PLACE TO ENSURE THAT ON-GOING COMMUNITY BENEFIT WILL BE DERIVED FROM THE PROECT?

It is anticipated that an additional amount of 1% of the project cost (\$2,600) will need to be added to Council's annual budget to cover annual maintenance of this new asset. The City of Darwin will also adjust existing cyclone and emergency plans to include the new generator. Council will run regular emergency drills to test the generator and the procedures in place for its operation.

Please refer Attachment A for a preliminary quote for the generator.

Please note: This quote is almost 2 years old, therefore additional costs have been factored in to cover price increases and costs have also been factored in for minor building works that will be required as part of the installation of the generator.

PROJECT DETAILS (attach separate papers if required)

Nightcliff Community Centre is one of the City of Darwin's most heavily utilised community facilities. Corrugated Iron Youth Performing Arts is the anchor tenant for the performance space. The facility is unusable during the warmer months due to the oppressive heat in the space. In response, the City of Darwin has sought to pursue options in developing the cost effective and environmentally sound cooling systems for the space.

A consultancy has been completed on potential cooling options, enabling the opportunity to demonstrate leadership in the area of proactive and responsible planning.

This grant funding application is therefore seeking funds to support the implementation of cooling solutions.

The solution will ensure that the centres patrons are comfortable whilst utilising energy efficient solutions and thereby reducing the running costs and greenhouse gas emissions.

The solution will likely use a variety of treatments including air conditioning to reduce heat load and temperature. The recommended solution for the hall is a packaged air conditioning system with an energy recovery unit that provides greater control over temperature/humidity and fresh air with different types of sensors interlocked with the system.

DOES THE PROPOSED PROJECT RELATE TO THE MUNICIPAL STRATEGIC PLAN? YES

The City of Darwin will shortly launch its new Strategic Plan. Based on the new Plan, this project is aligned to a number of goals and outcomes, being:-

- Goals: 1 Collaborative, Inclusive and Connected Community
 - 2 Vibrant, Flexible and Tropical Lifestyle
 - 3 Environmentally Sustainable City

Outcomes: 1.1 – Community inclusion supported

- 3.1 Council's carbon footprint reduced.

WHAT ARE THE ONGOING COMMUNITY BENEFITS EXPECTED FROM THIS PROJECT?

The Nightcliff Community Centre is in high demand with a mixture of both permanent and casual users. Corrugated Iron Youth Arts Inc has leased the Nightcliff Community Centre Hall from Council since 1998.

The hall is used every day for youth circus and dance workshops, theatre rehearsals and performances. The hall currently does not have any air conditioning nor insulation under the roof (due to the unenclosed roof space).

During the build up and wet season the temperature and humidity levels in the hall are extremely high which causes health and safety issues for the staff and community members utilising the hall. This in turn prevents the hall being accessed and utilised all year round.

The recommended approach for the Nightcliff Community Hall Cooling Project incorporates environmentally sustainable, energy efficient features and contemporary approaches. All options not only the initial capital and project costs, the ongoing maintenance and running costs, resource implications and the long term replacement costs.

WHAT OTHER SOURCES OF FINANCE HAVE BEEN CONSIDERED TO FUND THE PROJECT?

The City of Darwin funded the initial consultancy for the investigation of options available for the Nightcliff Community Hall Cooling Project. The cost of the consultancy was approximately \$15,000 and was completed in October 2012.

Refer to Attachment A for the budget breakdown.

OUTLINE WHAT THE MUNICIPAL'S COMMITMENT IS TO THE PROJECT IN CASH AND KIND?

The City of Darwin commits +/- \$100k annually to the maintenance of its Community and Child Care Centre's but due to limited funding, is unable to fund large projects such as this.

The City of Darwin will however be committing in-kind costs through staff time. Council's Building Manager will continue to work on the project if the funding is received, project managing all works outlined in this application. Council's Family & Children's Services Officer will be the liaison point between Council and the hall patrons.

WHAT FINANCIAL PROVISIONS WILL BE PUT IN PLACE TO ENSURE THAT ON-GOING COMMUNITY BENEFIT WILL BE DERIVED FROM THE PROECT?

Ongoing continuation of the program.

BACKGROUND

There is no planning history relating to the subject site on the City of Darwin records management system.

Site and Surrounds

The subject site is identified as Lot 1663, Town of Darwin, also referred to as 8 Eden Street, Stuart Park. The current zoning of the subject land is MD (Multiple Dwelling Residential). The proposed rezoning seeks to apply the MR (Medium Density Residential) zoning. Lot 1663 has a total area of 987 square metres.

The subject allotment currently contains an established single dwelling. Residential land in the vicinity of the subject land is a combination of MR, MD, SD (Single Dwelling Residential), SC (Service Commercial) and CP (Community Purpose). The premises at 3 Eden Street, has recently been rezoned from MD to MR and the land surrounding the subject site is zoned MD. The SC (Service Commercial) zone is located to the west and south along the Stuart Highway.

The SD (Single Dwelling) zone is located along the eastern section of Eden Street and Stuart Park Primary School is located on Nudl and Ashley Streets nearby. The subject site is two lots away from a large transit corridor, the Stuart Highway and the Botanical Gardens (Zone PS - Public Open Space) is located on the opposite side of the Stuart Highway.

Current vehicular access to the allotment is via a sealed driveway from Coronation Drive.

DISCUSSION

Current and Proposed Zoning

The current zoning of the subject land is MD (Multiple Dwelling Residential). The proposed rezoning seeks to apply the MR (Medium Density Residential) zoning.

Under the current MD provisions, the $987m^2$ lot could be developed with up to three dwellings, to a maximum of two (2) storeys. Under the proposed MR provisions, the land has the potential to be developed with up to eleven (11), one or two bedroom units, or seven (7) three or four bedroom units, to a maximum height of four (4) storeys.

The development potential of Zone MR will allow for development significantly greater than the established scale of development along Eden Street.

The increased density is likely to significantly increase traffic movement, to and from the subject land. Given the location adjacent to the intersection with Eden Street and the Stuart Highway, it is likely that the majority of traffic will utilise this intersection.

There is a small area of public open space located nearby, along Presley Street and across the Stuart Highway. No other convenient areas of public open space exist within close proximity to the subject site.

The continuing trend, towards higher densities in Stuart Park, incrementally places higher demands on services and infrastructure in the area, including roads and traffic, stormwater, open space and community services. If the Northern Territory Government were to develop a plan to increase densities in the area, then likely impacts on services and infrastructure could be assessed and necessary upgrades and contribution plans could be developed.

The response letter, included as **Attachment B** to this report, notes that should the Northern Territory Government develop a strategic direction to guide future development in the area, which includes higher densities, it may be possible to support a rezoning. However, on the basis that there is no strategic direction to support an increased density in the area, Council does not support this application.

Summary

The applicant seeks to rezone the subject site from Zone MD to Zone MR. The character of Eden Street is mixed towards the western end of the street. Notwithstanding this, dwellings along Eden Street maintain a consistent bulk and scale of development to two (2) storeys, with MD and SD zone developments.

Many areas within Stuart Park are undergoing a 'transition' from established lower densities to higher density and a wider variation in dwelling types. The Planning Scheme does not detail a strategic direction in this instance.

Specific issues relating to traffic, waste and stormwater will need to be addressed during the development assessment process, if this application is approved by the Development Consent Authority.



Rezoning Submission for Lot 1663. 8 Eden Street. Stuart Park 0820

With the current and future growth of Darwin and the accommodation shortage, rezoning of Lot 1663 would be beneficial to address the high demand for housing and increasing population in Darwin.

The locality of Lot 1663 is ideal as it is in a corner, (Eden Street and Coronation Drive) and one Street back from the Stuart Highway, the main Road connecting Darwin City to the Northern Suburbs, Hospitals and AirPort, and the main Road leading in and out of Darwin to Palmerston and the rural area.

It is close to:

Public Transport – 100m, 2min walk and Cycle Paths,

Doctor Surgery with a/h facility, Pharmacy, Convenience Store, Newsagency, Take Away Shops – 270m, 3min walk, 1min drive,

Recreation Parks – B. Sullivan Recreation Park, opposite Stuart Park Shops – 300m, 4min walk, 1min drive, R.F. (Bob) Anthony Memorial Park in Armidale Street – 750m, 9min walk, 1min drive and Dinah Sporting Oval – 1.1km, 13min walk, 3min drive.

Stuart Park Primary School, 500m, 7min walk, 2min drive, Darwin High School – 1.4km, 18min walk, 5min drive, St Johns College – 700m, 9min walk, 3min drive.

George Brown Botanic Garden, Warratah Oval, Gardens Parks Golf Link and Mindil Beach Sunset Market are all approximately 2.6km. 26min walk. 5min drive or much closer/duicker by cutting through Geranium Street and enter Botanic Gardens from the top and enjoy the beautiful Market Gardens.

Darwin Sailing Club and Darwin Water Ski Club are also in close proximity of around 2km, 20 to 25min walk, 5min drive.

Parap Village Market – 1.6km, 20min walk, 4min drive.

East Point Reserve – 4.9km, 55min walk, 9min drive.

Darwin Central Business District is located only 2.8km away 35min walk, 7min drive by car. Buses drive to the CBD frequently.

Stuart Park is located on the fringe of the Citv with a mixture of different zonings. All along the Stuart Highway, starting from Thrifty Rent A Car to Daly Street Bridge, the zoning is SC (Service Commercial), the Stuart Park Shops are C (Commercial), there are several MD Multiple Dwelling) Blocks along Eden and Charles Street, Westralia Street, Henry Street, Queen Street, King Street and Winston Avenue. A few MR (Medium Density) Blocks exist along Coronation Drive. There have been some recent 4 storey developments in Coronation Drive and Queen Street and two Properties, 3 Eden Street and 10 Charles Street have recently been successful in rezoning from MD to MR.

Proposal

Lot 1663 has a total of 987m2 and, under the Northern Territory Planning Scheme, is sufficient for the MR zone. The maximum height is 4 stories.

There are no easements on the property which would allow for full usage of the land.

With the 3m setback from each boundary, a mixture of 2 and 3 bedroom apartments with balconies for open space could be built.

The ground level would be dedicated to 2 car parks per Unit.

There would be a staircase and access corridor in the middle of the Block to separate the Units.

A tropical garden will provide as privacy within the Block and towards the neighbours.

However, as this is not a Development Application, matters regarding the development can be addressed at a later stage with relevant authorities.

Impact on surrounding properties:

The impact on the townhouses corner Eden Street and Coronation Drive, opposite proposed rezoning site would be minimal, as their living/outdoor area faces Coronation Drive, the same way I envisage the development of the Units to face.

The Unit block at the back of the property, 7 Charles Street, also has living/outdoor area facing Coronation Drive.

The impact on the Duplex, 6 Eden Street and 4 small Units on Coronation Drive would be minimal, as a lush tropical garden will be established and 1.8m solid screen fence will provide privacy.

Traffic:

There will be a slight increase of traffic but it should have minimal impact on the area as access to Stuart Highway is immediate. The road system is well established in this area and leads directly to CBD, Northern Suburbs and Palmerston.

Infrastructure

There is a well established infrastructure in the area. There is town water, sewage and main power supply. Any additional services will be provided by the developer to the satisfaction of the relevant authority.

Zoning Table

In regards to the clauses of zone MD and MR. There is no difference between the two zones in the "Index of Zones" in what is permitted, discretionary and not permitted. The obvious difference is the building height restrictions between the two zones.

I am aware that any new development proposal will have to be approved by the appropriate authorities and all questions and issues will have to be addressed then.

As for this proposal to amend the planning scheme in regards to rezoning of Lot 1663 from MD to MR I believe that there would be no negative effects or impact on neighbourhood or surroundings as this is a very well established area.





Thank you for the Development Application referred to this office 18 October 2012, concerning the above. This letter may be placed before Council's Town Planning Committee at its next meeting. Should this letter be varied or not endorsed by Council, you will be advised accordingly.

On the basis that there is no strategic direction to support an increased density in the area, Council does not support this application.

The Northern Territory Planning Scheme does not provide strategic direction with regard to managing the development of urban land in this area and as such it is difficult to gauge whether or not this proposal would result in an appropriate form of development.

Zoning along Eden Street is mixed, with MR (Medium Density Residential) across the road to the northwest, SC (Service Commercial) Zone to the west and to the south along the Stuart Highway. The land directly adjoining the site and in the surrounding area is predominantly MD (Multiple Dwelling) Zone, with SD (Single Dwelling Residential) Zone located nearby, to the north eastern section of Eden Street. While the predominant built form of the area is limited to one and two storey scale developments.

Should the Northern Territory Government develop a strategic direction to guide future development in the area, which includes higher densities, it may be possible to support a rezoning. However, currently there is no strategic direction or indication of the potential impacts the rezoning may have on services and infrastructure, or on the wider community.

BACKGROUND

The site is within the SC (Service Commercial) Zone and is located on the corner of the Stuart Highway and Vanderlin Drive, Berrimah. The site has prominent street frontage to both roads and has entrances and exits along both of these roads. The Stuart Highway and Vanderlin Drive are both under the control and care of the Northern Territory Government. However, the Stuart Highway service road, which provides access for the proposed restaurant, is under the care and control of the City of Darwin.

The existing development contains four (4) retail units and a 'drive-thru' restaurant. Land to the north is part of the Berrimah Zone Substation and the Gull Service Station is located on the opposite corner of the Stuart Highway and Vanderlin Drive, with caryards across the Stuart Highway.

DISCUSSION

The development proposal is for the construction of a new drive-through restaurant to be located on the site, adjacent to the existing drive through restaurant.

Calculations for the car parking do not include the entire net floor area of the new development and as such, the application incorrectly calculates the amount of parking required for the restaurant. The kitchen area and office are excluded from net floor area, resulting in an underestimation of required parking bays for the proposed development.

Twenty (20) car parking bays will also be removed to make way for the new building. The loss of existing bays should be included in the calculations for parking required on site. From the information provided in the application, it is not possible for City of Darwin staff to determine what the existing and proposed parking requirements are for the site.

Thank you for the Development Application referred to this office 2 November 2012, concerning the above. This letter may be placed before Council's Town Planning Committee at its next meeting. Should this letter be varied or not endorsed by Council, you will be advised accordingly.

The following issues are raised for consideration by the Authority:

- i). Council supports in principle the granting of a Development Permit provided the following issues are adequately addressed:
 - a). Council notes that all signage is subject to a separate assessment in accordance with City of Darwin Policy Number 42 Outdoor Advertising Signs Code.
 - b). The application notes that the Stuart Highway frontage is the only building frontage that is not articulated. The street frontage is the most important building aspect, as it is the frontage most viewed by the public. Council recommends that detailing, including windows, be added to the Stuart Highway frontage.
 - c). Council notes that the proposed drive-through does not hold ten (10) vehicles, as required by the Northern Territory Planning Scheme. The Northern Territory Planning Scheme requires ten (10) spaces for cars being served or awaiting service. Therefore, only the number of car parking spaces in the drive-through lane, prior to service window, count towards this requirement. On-site arrangements should be made to accommodate the requirements of the Northern Territory Planning Scheme for ten (10) vehicles awaiting service.

- d). The site plans provided do not show the net floor area of existing buildings and development on site. The application incorrectly calculates the amount of parking required for the restaurant, as the application does not address the parking required for kitchen area and staff. This kitchen and food preparation area should be included in the calculations for parking required on site. Council further questions the applicant's calculations of the amount of car parking required for other existing development on site. It is not possible for Council to determine from the information provided what the existing parking requirements are for the site. Should a car parking shortfall for the site be determined. Council requests the Authority require a monetary contribution is paid to Council in accordance with its Car Parking Contribution Plan in lieu of the on-site car parking shortfall as a result of this development.
- e). As the proposed drive-through restaurant is accessed by the City of Darwin's service road, the City of Darwin requires a comprehensive Traffic Impact Assessment report prepared in accordance with the Austroads document, Guide to Traffic Management Part 12: Traffic Impacts of Developments in the report structure provided as Appendix C of that document, with particular attention to vehicular, pedestrian, cyclist and public transport issues and opportunities, to the satisfaction of the General Manager, Infrastructure.

ii). Should the above issues be adequately addressed, Council offers the following comments:

Council comments on issues for which it is the sole responsible authority, under the Local Government Act and associated By-Laws:-

- a). Council requests the Authority requires a schematic plan demonstrating all stormwater to be collected on the site and discharged underground to Department of Infrastructure's stormwater drainage system, to the satisfaction of the City of Darwin. The applicant's plans fail to demonstrate how on-site stormwater will be collected and discharged underground to this drainage network.
 - 1). The plan shall include details of site levels and appropriate stormwater drain connection point/s. The plan shall also indicate how stormwater will be collected on the site and connected underground to the Northern Territory Government's system.
 - 2). Council requires a stormwater drainage plan to confirm that it is technically feasible to collect stormwater on the site and

dispose of it into the Northern Territory Government's stormwater drainage system. It is also necessary to ensure that no stormwater will sheet-flow into the road reserve or onto adjoining properties.

Should this application be approved, the following conditions pursuant to the Planning Act and Council's responsibilities under the Local Government Act are also recommended for inclusion in the Development Permit issued by the Development Consent Authority.

- Designs and specifications for landscaping of the road verges adjacent to the property shall be submitted for approval by the General Manager Infrastructure, City of Darwin, and all approved works constructed to Council's requirements at the applicant's expense.
- The location, design and specifications for proposed and affected crossovers shall be provided to the satisfaction of the General Manager Infrastructure, City of Darwin and at no cost to Council.
- Kerb crossovers and driveways to the site shall be provided and disused crossovers removed, public footpath and cycleways shall be provided, stormwater shall be collected and discharged into Council's drainage network, and reinstatement works carried out, all to the requirements and satisfaction of the General Manager Infrastructure, City of Darwin and at no cost to Council.
- Car parking spaces and internal driveways shall meet the requirements of the relevant Australian Standard and be linemarked and sealed with an impervious material.
- The total number of required disabled car parking bays shall be met on site.
- All developments on or adjacent to any easements on site in favour of Council shall be carried out to the requirements and satisfaction of the General Manager Infrastructure, City of Darwin.
- Waste bin storage and pick up shall be provided in accordance with City of Darwin Policy Number 54 Waste Management.
- Any proposed signage for the site shall be subject to a separate assessment in accordance with City of Darwin Policy Number 42 – Outdoor Advertising Signs Code.

In considering this application, the Development Consent Authority is requested to take into account any implications of the Disability Discrimination Act (Cth) or the Anti Discrimination Act (NT) with regard to access for the disabled.

I am writing to you in relation to the proposed heritage listing of the WWII Naval Oil Tanks, the Esplanade.

The nomination of the WWII Naval Oil Tanks to the NT Heritage Register was accepted by the Heritage Advisory Council on 30 August 1994 under the terms of the now revoked *Heritage Conservation Act*. The Heritage Advisory Council wrote to the City of Darwin on 18 August 1994 seeking comment on the proposed heritage listing.

The City of Darwin wrote back to the Heritage Advisory Council on 23 January 1995 raising concerns about the proposed heritage listing.

It appears that the Heritage Advisory Council was not able to resolve the concerns.

There is now a new *Heritage Act* for the Northern Territory, which replaces the *Heritage Conservation Act.*

The new Heritage Council has decided that, due to the many years that have passed since heritage listing was first proposed in relation to the WWII Naval Oil Tanks, the heritage listing process should not proceed any further.

The Heritage Council has also written to the person who nominated the WWII Naval Oil Tanks for heritage listing with this advice.

Please note that the *Heritage Act* allows for anyone, at any time, to re-nominate the WWII Naval Oil Tanks to the NT Heritage Register under the provisions of the *Act*.
