The substitution of the Liquor Licence will consist of:

- Relocation of the business to shop 4/28 Mitchell Street, Darwin;
- Change of business name from "Go Sushi Train" to "Go Sushi Grand Central"

Go Sushi Train is currently located in shop 5 which is located in the northern corner of the premises with an entrance from Chapel Lane. Go Sushi Train is proposing to move to shop 4 of the same premises, which is located on the opposite side of the building, adjacent to the Mitchell Street service lane.

Shop 4 was occupied by the restaurant known as Hot Rocks, which was issued a Liquor Licence in 2007.

The transfer of the Go Sushi Train's Liquor Licence to the new premises at shop 4, is not expected to affect the amenity of the area as these premises are currently licensed.

No issues are raised regarding the proposed name change from Go Sushi Train to Go Sushi Grand Central.

#### Conclusion

There appears to be nothing related to this application which would require additional considerations or conditions of the proposed licence under Section 3 & 6 of the Liquor Act.

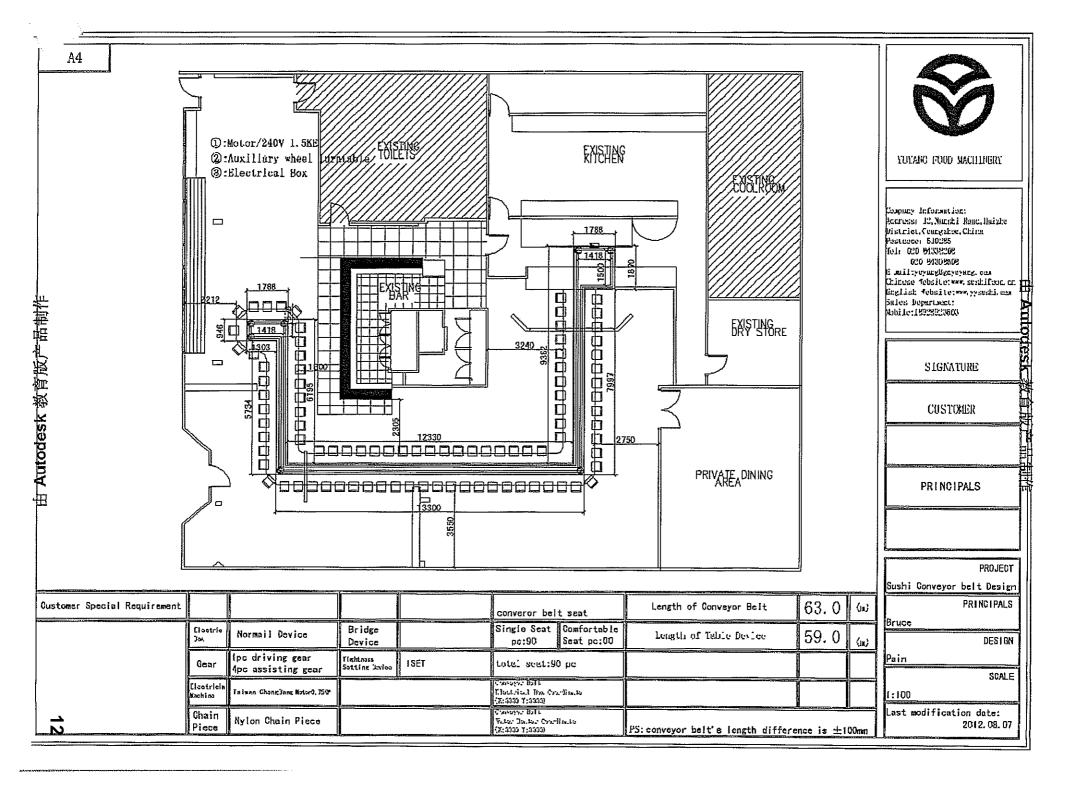

The purpose of this report is to seek Council's approval of an application to lease Council road reserve to allow the construction of additional car parking for Lot 1450 Stuart Highway, Winnellie.

- The need for additional car parking is being driven by the changing commercial face of the Winnellie area.
- The additional car parking would be accessed via the property's internal road and parking network.
- The applicant is requesting a lease over the land from Council.
- No short or medium term Council use/ need for the road reserve area has been identified.
- A Lease or Permit to Occupy would mean that Council would retain ownership should it ever require the road reserve.

  - That the developer/owner will be responsible for the ongoing maintenance of the verge landscaping.
  - That the developer/owner will be responsible for the ongoing maintenance of the car park area.
- C. THAT the City of Darwin pursuant to Section 32(2) of the Local Government Act 2008 hereby delegates to the Chief Executive Officer, the power to finalise the Permit to Occupy including all associated conditions and financial arrangements and the design, construction and final acceptance by Council of the car parking and landscaping within Hickman Street and Winnellie Road, road reserve adjacent to Lot 1450 Stuart Highway. Winnellie in accordance with Report 12TS0140 LC:LM.

#### **BACKGROUND**

Council has received a request from the owner of Lot 1450 Stuart Highway, Winnellie to construct car parking which would be accessed internally off the allotment within parts of the Hickman Street and Winnellie Road reserves, **Attachment A**.

**Attachment B** provides a site plan of the allotment, road reserves and affected portions of the road reserves.

#### **DISCUSSION**

The applicant has been in discussion with Council Staff over a period of time about options to facilitate additional parking for Lot 1450 Stuart Highway, Winnellie.

Currently a significantly wide road reserve exists on Hickman Street (approximately 30 metres) and Winnellie Road (approximately 40 metres). The road reserve appears to have been created to cater for the future potential widening of the road pavements. Council staff have been unable to locate documents detailing why the reserves have been developed to these widths. Currently Council has no short or medium term plans to modify the road.

The applicant has indicated that the need for additional car parking is driven by the changing commercial face of the Winnellie area as it drifts from its open warehouse, open yard and lower person density use.

Given the location of the site it is considered that the proposal to provide parking accessed via an internal network presents a safer option then the normal practice of on-street angle parking.

#### **BUDGET AND RESOURCE IMPLICATIONS**

The annual rental for the occupation of the road reserve will be negotiated at market rates determined by an independent valuation and the annual rental will be reviewed annually in line with the consumer price index.

At this point in time a valuation has not been obtained.

All costs associated with the preparation of the valuation and the permit to occupy and all construction and maintenance costs will be met by the applicant

Dear Mr Cercarelli,

Further to recent discussions on 24/7/12 and related emails, I confirm, ----

- We seek approval from Council to provide additional public car parking on Council
  owned street verge land accessed from the internal road network of our property as
  previously detailed along as much of the Hickman and Winnellie Rd frontages that
  safe practice and safe traffic flow will permit.
- 2. The carparking proposed is on verge land considerably wider than the average street verge and is no longer required for other possible uses now that the airport terminal has been relocated to its current location. Even with a 6 to 7 m depth of carpark there remains approx.5m of lawned verge area (it varies along the frontage) which we will continue to maintain, as we have done since 1985.
- The angle carparking will be constructed to Council Standard Designs with no cost to Council. Should existing tree / shrub plantings need to be reduced, we will replace or modify the landscaping to current Council specifications.
- 4. We understand that Council's current policy prefers that you do not sell the proposed land area to us, but lease it instead, for use as public carparking and we have no objection to that option.
- 5. We confirm that internal access is the only option available to this extra carparking proposal, as access from the street frontage is primarily prevented by safe traffic flow considerations because of the close proximity to the two very busy, fast moving intersections of Stuart Hwy / Hickman and Hickman / Winnellie Rd. (as well as

- disruption to existing U/G services and the need for an ugly and intrusive retaining wall.)
- 6. The need for additional carparking is driven by the changing Commercial face of this area of Winnellie as it drifts from its open warehouse, open yard, lower person density past.

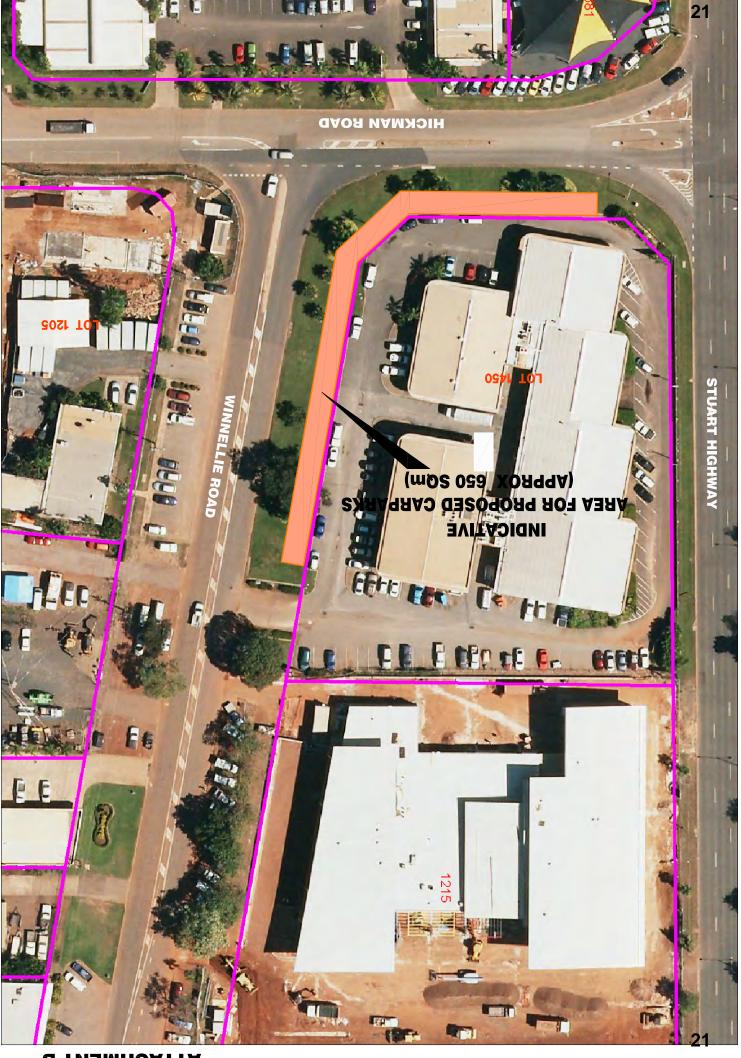

This report provides an update on progress for the Cavenagh Street upgrade project for the month of August 2012.

#### **DISCUSSION**

Cavenagh Street is a major CBD road that is over 50 years old. It is approaching the end of its effective useful life and is due for reconstruction.

Based on sound asset management principles and road condition data Cavenagh Street was identified as a high priority for upgrade. The Australian Government Roads to Recovery funding assistance has provided Council with the opportunity to deal with this matter in a timely and effective manner.

The scope of work includes the following:

 Pavement refurbishment/reconstruction including re-design of the existing road surface for improved drainage;

Landscaping of Cavenagh Street median at the Daly Street;

- Widening of the Cavenagh Street median island from Daly Street to Searcy Street by 200 mm to provide increased space for landscaping;
- Replacement of 2 median islands along Gardens Road with new landscaping;
   and
- Replacement of a damaged section of stormwater drain along Cavenagh Street.

There will be no loss of on-street car parking bays along Cavenagh Street after project completion.

Construction works commenced on the 16 August 2012 and will be completed in December 2012.

The works have been staged in order to minimise impact at any one time and to allow the management of traffic. The indicative staging plan is shown in **Attachment A**.

All necessary detours and traffic management will be in place to facilitate the works in a safe and efficient manner.

Reasonable efforts will be made to minimise disruption and inconvenience. However, given the scale and nature of this project, there will be some level of disruption and inconvenience to the public.

Council staff continue to work with businesses and property owners within the works zone to minimise disruption, providing access and ensure they are fully informed.

Temporary arrangements have been put in place to transfer bus routes from Cavenagh Street to Smith Street. The temporary bus-stops and bus route along Smith Street is now operating and these arrangements will remain in place for the duration of the construction works along Cavenagh Street.

Two temporary kerb-side bus-stops have been established along Smith Street, one at the front of Spillet Park, utilising the new shade structure constructed in that location as part of the MY0800 project, and the other across the road from the Saint Mary's School, to provide a facility for school buses.

In addition, through consultation with both the Northern Territory Government and the Taxi Council, arrangements have been put in place to temporarily transfer the taxi parking bays outside Woolworths along Cavenagh Street, to Smith Street, across the road from the ANZ, on the other side of the Woolworths car park.

These temporary changes will facilitate the reconstruction program. Appropriate signage and line marking are in place and advertising has been undertaken.

#### **CONSULTATION PROCESS**

A consultation plan was developed and is being implemented.

The project stakeholders have been identified and face to face discussions have and continue to occur with key stakeholders-including the business owners/occupants along both sides of the affected section of Cavenagh Street, the Taxi Council and Public Transport section of the Northern Territory Government.

Hand-delivered letters, with attached project fact sheets, question and answers sheets and feedback forms were also provided to the above mentioned stakeholders.

Letters, with attached project fact sheets, question and answer sheets and feedback forms were also sent to other key stakeholders including Emergency Services and Chamber of Commerce, NT and Property Council of Australia, NT.

Copies of the project Fact Sheet, Question and Answer Sheet and Registration to be kept informed have been previously provided to Council for information (Report Number 12TS0090DM:LM June 2012).

In summary, Council staff have found that stakeholders along the Searcy to Daly Street section (work zone) at Cavenagh Street are understanding of the need to reconstruct Cavenagh Street, and acknowledge they will be disrupted to various degrees. Council staff will continue to work with stakeholders throughout this process to minimise disruption.

Consultation with affected businesses along Smith Street was undertaken regarding the relocation of bus stops and taxi ranks. This involved face-to-face information drops for the occupants of the businesses along Smith Street, between Knuckey Street and the furthest temporary bus-stop along Smith Street. Businesses were informed of the temporary bus-stop and taxi parking arrangements along Smith Street and to provide context for these temporary measures.

The information provided included an information leaflet outlining the temporary busstops and taxi parking arrangements, including a plan showing the locations of these temporary facilities and a copy of the fact sheet that was used in the consultation with the Cavenagh Street business owners/occupants.

Advertisements have been placed in the local paper advising of the commencement date of the works. All information, including the current Works Plan, have been provided on the City of Darwin website. The website will be updated on a regular basis.

Variable Message Boards (VMB's) have been installed at various locations to forewarn of the impending road works along Cavenagh Street, including the closure of the inbound lanes at Daly Street. The messages on the VMB's will be adjusted to reflect the staging of the works as they progress.

Regular advertisements will be placed in the local paper to keep the general public informed of works progress.

A media release announcing the commencement of the works was issued on the 15 August 2012.

Community consultation will continue through to the completion of the project.

#### **POLICY IMPLICATIONS**

This project is an essential asset-renewal project and will extend the life of Cavenagh Street in line with Council's asset management strategies.

#### **BUDGET AND RESOURCE IMPLICATIONS**

The Australian Government funding from the Roads To Recovery Program – 2009-2014 for the delivery of this road reconstruction is \$2,862,000 (excluding GST).

Funding to the value of \$400,000 was allocated in the 2011/12 Capital Works Budget for delivery of the landscaping components of this project. It will be requested that this funding be carried forward into 2012/2013 for its intended purpose.

The tender was awarded to East Arm Civil Pty Ltd for the \$3,019,787 (including GST).

Based on the available Australian Government funding and the identified 2011/2012 capital works carry forward there is sufficient funding within the 2012/2013 budget to undertake the works.

#### RISK/LEGAL/LEGISLATIVE IMPLICATIONS

Risk mitigation, traffic management and legislative requirements will be managed throughout the project.

#### **ENVIRONMENTAL IMPLICATIONS**

Enhancement of existing median island landscaping will provide improved environmental benefit.

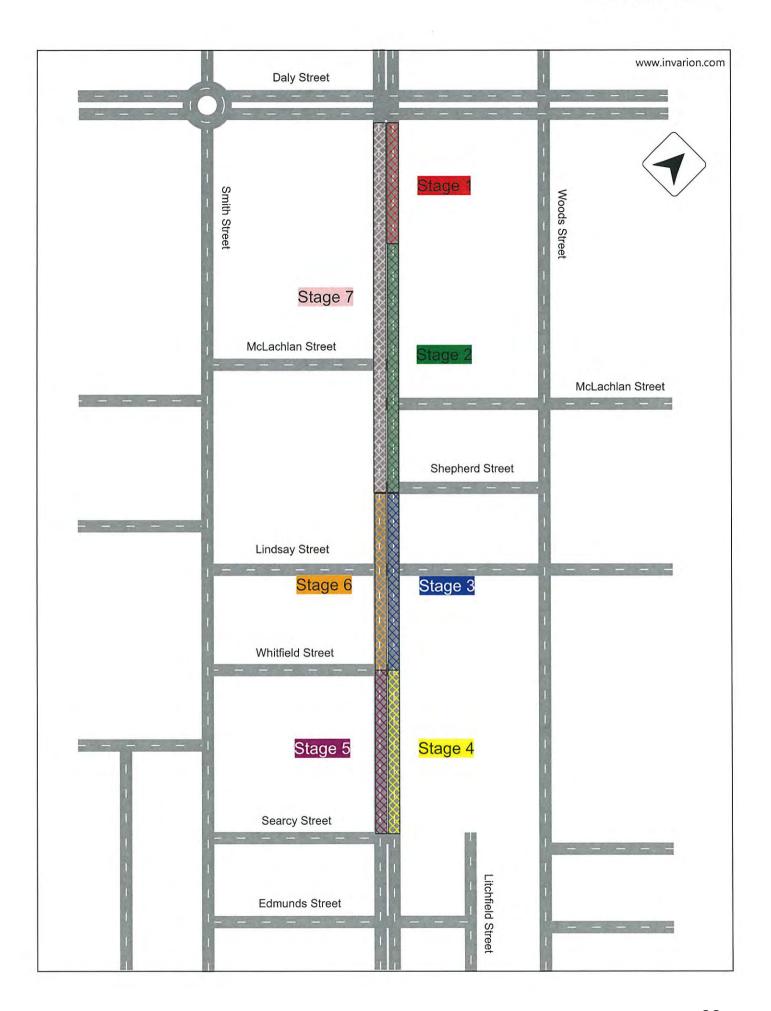

#### **PURPOSE**

The purpose of this report is to consider the construction of a footpath within Legune Avenue, Leanyer.

#### LINK TO STRATEGIC PLAN

- This report recommends the construction of a footpath within Legune Avenue as it would provide a safe pedestrian network to schools and adjacent amenities/streets, keeping pedestrians off the road.
- The construction of a footpath within Legune Avenue has been previously scheduled and has faced some opposition from residents.

#### **RECOMMENDATIONS**

THAT it be a recommendation to Council:-

- A. THAT Report Number 12TS0086 ND:LM entitled Legune Avenue, Leanyer Footpath Construction, be received and noted.
- B. THAT Council endorse the construction of a footpath on the even numbered side of Legune Avenue, Leanyer within the 2012/13 financial year.

#### **BACKGROUND**

Legune Avenue currently has no footpath on either verge for the length of the street. There is a pathway connection through a walkway to Leanyer Drive. There are also several properties that have restricted pedestrian access due to verge vegetation, causing pedestrians to use the road. The construction of a footpath would provide a safe, dedicated route for all users that meets access and mobility standards.

The construction of a footpath in Legune Avenue has been in several works programs. In 2003 and 2005, the then Member for Wanguri, Paul Henderson, wrote to Council requesting the status of the construction of a footpath in subsequent financial years. Due to residential opposition the footpath was not constructed in these years.

The Legune Avenue footpath was programmed for construction in 2010/11. Letters were sent to all residents of Legune Avenue advising them of the intended construction of a footpath on the even numbered side. One responded to Council's letter objecting to the construction. A subsequent letter was also provided, signed by sixteen (16) properties (eighteen signatures) from the even numbered side of the road also objecting to the footpath construction.

As a result of the objections received, a second letter seeking further feedback was sent to all residents. The letter sought feedback relating to whether a footpath was supported and if so, what side was preferred and any other comments. The feedback received included responses both for and against the footpath construction. To be noted is that only seven (7) of the sixteen (16) properties that signed the petition responded to the Council's letter with an objection to construction. There were also five (5) properties from the original objecting letter that responded supporting the footpath construction (though not necessarily for it to be constructed on their side of the road).

Due to the history of the Legune Avenue footpath construction being programmed then deferred on multiple occasions, this report seeks Council's direction in regards to the footpath construction.

#### **DISCUSSION**

It is considered that the construction of a footpath in Legune Avenue would benefit the broader community due to its location and proximity to schools, community services and shops. It would provide a significant network linkage to adjacent roads with footpaths and a walkway that connects to Leanyer Drive and the schools.

Footpaths are selected by a number of factors, including, but not limited to;

- finishing connections within streets
- providing footpaths along all sub arterial roads and collector roads
- providing footpaths to streets requiring network connection, ie to adjacent streets and walkways

damaged existing footpaths requiring significant maintenance

This is in accordance with Councils Policy, Number 048 – Footpaths, which states;

 New footpath construction will be determined according to the road hierarchy, town planning zones and special needs.

#### And:

#### Footpath Construction and Reconstruction for Existing Roads

Within financial constraints and priorities based on condition and need, Council will provide a footpath on:

(i) one side of the road for local roads

Legune Avenue, as shown in **Attachment A**, provides a connection from multiple streets through to an open walkway (with footpath constructed) that connects to Leanyer Drive. Immediately within the vicinity of the Leanyer Drive connection there are two (2) primary schools, two (2) churches and further down the road is the Hibiscus Shopping Centre.

If constructed, the footpath network would be completed by a short Hodgson Drive connection from Legune Avenue to Leanyer Drive to reduce the number of road crossings required for access to the schools.

The even side of the road is considered to be the most suitable to link to the walkway and connect to adjoining roads' footpaths.

#### **Feedback**

The feedback received from the initial letter regarding construction was one objection, as would be expected for new footpath construction. In most instances the concerns of the resident(s) can be resolved, but as mentioned in the Background section of this report, a letter with signatures opposing the construction was also received and hence the construction placed on hold and letters requesting further feedback sent out to all residents.

The table below summarises the feedback received.

The numbers above show that less than 25% of residents object to the footpath, with nearly 21% wanting a footpath and over 54% having no comment. To be noted is that several comments were in regards to irrigation and 'digging up' concerns, all

which are managed at the time of construction. These comments came from both negative and positive feedback groups.

Some of the more detailed comments received include:

#### **Negative**

- Visually the street is already attractive
- Not needed
- The road is quiet enough for people to walk along, never had a problem
- Front fencing wasn't allowed in the covenant so gardens went to the verge

#### Positive

- We have trees out the front but they can come out
- Great idea, children coming and going from school won't be on the road, there
  have already been accidents
- Ensures the safety of pedestrians, particularly children that now have to walk on the road to school
- Don't mind which side as long as we get a footpath

The negative comments are consistent with those received for most works within verges and can usually be resolved by discussing individual issues with the resident. The positive feedback highlights the need to provide a safe route for pedestrians and is consistent with Council's policies.

For the reasons discussed in this report, it is recommended that Council endorse the construction of a footpath on the even numbered side of Legune Avenue, Leanyer within the 2012/13 financial year.

#### **CONSULTATION PROCESS**

Consultation with Legune Avenue residents has been undertaken as discussed in the Background and Discussion sections.

If Council endorses the recommendations then a letter would be sent to all residents and homeowners advising them of the outcome and of the programmed construction. If Council were to defer the construction of the footpath then this would be advised also.

If endorsed, the footpath would be placed on the 2012/13 Footpath Construction and Reconstruction Program with construction to commence within the next three months.

#### RISK/LEGAL/LEGISLATIVE IMPLICATIONS

There are two main risks to Council;

- 1. That the footpath is constructed and residents continue to oppose and attempt to stop the construction, this may be through the media and/or petitions.
- 2. That the footpath is not constructed and pedestrians continue to use the road due to a safe alternative not being provided.

#### **ENVIRONMENTAL IMPLICATIONS**

Increasing the accessibility of Darwin's pedestrian network increases the likelihood of usage and therefore reduction in the reliance on vehicles. For Legune Avenue this would be particularly beneficial to primary school children in the area by providing a safe route along Legune Avenue to the connections to the schools.

The following key points can be highlighted in the April to June 2012 quarterly report on the Cash for Containers Scheme, provided by the Northern Territory Government:

- One in three eligible containers have been redeemed this quarter increasing from one in four last quarter,
- There has been a 52% increase in container redemptions by the community, compared to the first quarter of the program's implementation;
- There has been a 31.31% redemption rate across all eligible containers and material types in this quarter, which equates to an increase of 52% on last quarter;
- More than 12 million containers were processed through Collection Depots this quarter (up from 8 million last quarter);

 More than 38 million approved containers have been sold in the Territory this quarter;

#### **BACKGROUND**

The Environment Protection (Beverage Container and Plastic Bags) Act 2011 (NT) (the Act) establishes the Northern Territory Container Deposit Scheme (CDS), referred to as Cash for Containers. The Cash for Containers components of the Act commenced on 3 January 2012. The aim of the scheme is to reduce beverage container litter, increase resource recovery and contribute to a 50% reduction in waste going to landfill in the Northern Territory.

#### **DISCUSSION**

The second quarter report on the Cash for Containers Scheme has been released by the Northern Territory Government.

The following information is provided as a summary to the Northern Territory Government Quarterly Report on the Cash for Container Scheme. The information and figures have been extracted from the Government Report. The full report is available at:

Highlights from the Northern Territory Government April to June 2012 Quarterly Report on the Cash for Containers program; include:

- There has been a marked increase in the number of containers returned up from 1 in 4 containers redeemed last quarter to nearly 1 in 3 containers redeemed this quarter;
- More than \$1.2 million was paid out in deposits;
- An increase in container redemptions of over 113% in areas outside of the Greater Darwin region from the first quarter; and
- 100% of all containers collected through the scheme were recycled or re-used.

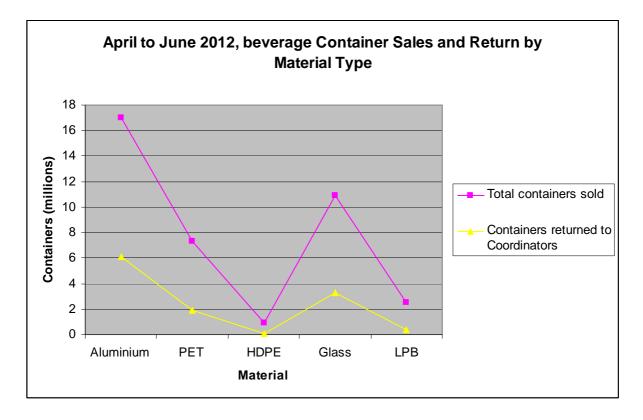
The Government report indicates that the success of the scheme in collecting containers is increasing.

- PET (polyethylene terephthalate) refers to the product that plastic beverage containers are made from (for example, water bottles);
- HDPE (high-density polyethylene) refers to materials such as some juice containers;
- LPB is liquid paper board which is utilised in the packaging of beverages such as popper juices. LPB also includes ASEPTIC which is the packaging of a beverage in a sterile container, used for example in long life UHT beverages; and

• Other containers refers to steel, foil sachets and other plastics including biodegradable, photo-sensitive and plant-based plastics. Also includes resin types established since 1988 and those marked with the number 7.

The Government indicates that a number of new Collection Depots have opened during this quarter, including Tennant Creek, Elliot, and a Reverse Vending Machine (RVM) at Parap. A mobile collection system has also been in operation in Wagait Shire and more regional and remote areas such as Adelaide River are to be serviced in the coming months.

The report further states that, Cash for Containers, Coordinators have reported that 100% of returned material is either being recycled or reused and not going to landfill. The report indicates that the glass is being stockpiled for use in road base and that the remaining materials are being stored for sale.

#### **CONSULTATION PROCESS**

#### **POLICY IMPLICATIONS**

Council Policy Number 006 Environment – General, supports the Container Deposit Scheme.
