ITEM NO: 5.2

SYNOPSIS:

The Department of Natural Resources, Environment, The Arts and Sport (NRETAS) has confirmed support for the development of a regional playground within the Casuarina Coastal Reserve at Dripstone Cliffs, on the proviso that a suitable tenure arrangement can be negotiated and that the associated immediate and long term operational costs are met by Council. Agreement with those terms will enable Council to progress the project to community consultation.

NRETAS has agreed to negotiate a tenure arrangement with Council for a site of approximately 5,000 m² at Dripstone Cliffs. The site will provide for a playground of

approximately 700m² and associated infrastructure including, seating tables and barbeques.

The agreement is premised on Council covering the cost of the transfer of land, playground construction, maintenance and future upgrades, irrigation and general water use, including the installation of a water meter. NRETAS also requires Council to undertake the public consultation phase. The correspondence from NRETAS is at **Attachment A**.

Since identifying the preferred site within the Reserve, Alderman Lambert has received a request from a resident that Council assume ownership and management of Casuarina Coastal Reserve in total. The request was based upon their observation that the East Point reserve is well managed, with few weed problems, an active revegetation program and regular track maintenance. In comparison they argued that the Casuarina Reserve is becoming increasingly degraded and will be facing further resource cuts in the near future. Correspondence has been sent to NRETAS to canvas the request and seek their thoughts on the proposal.

In the interim, as Council is keen to progress the development of the playground, the next important step is to consult with residents of the Richardson Ward and the wider Darwin community. Dripstone Cliffs and the Casuarina Coastal Reserve are popular recreation areas and it is anticipated that there will be considerable public interest, in addition to the attention of residents in the immediate vicinity. Consequently it is proposed that a consultant be engaged to provide the necessary resource.

The consultation adheres to Council policy and will comprise the following elements, leaving a degree scope for additional opportunities as identified by the consultant;

- Letterbox drop to residents
- Web page for information and an on line questionnaire
- Print and other media circulated through appropriate avenues including the libraries, fun bus, and school newsletters.
- On site consultation during a minimum of two defined periods of high use, including information boards and a display of the concept.

FINANCIAL IMPLICATIONS:

Council has previously allocated \$100,000 towards the preparation of concepts, community consultation and tenure agreements.

A tenure agreement will be negotiated between NRETAS and Council defining the site and stipulating ongoing responsibility for infrastructure management.

ENVIRONMENTAL IMPLICATIONS:

Development of the site will be cognisant of the natural values of the location and local biodiversity.

PUBLIC RELATIONS IMPLICATIONS:

It is likely that the proposal for a playground will be widely supported, however concerns as to the location may be raised by local residents and other users who enjoy the existing openness of the site for passive use and its inherent value.

COMMUNITY SAFETY IMPLICATIONS:

Play equipment installed by Council is required to meet Australian Standards. Consideration will also be given to the playground in context, in particular providing separation from roads and the cliff top.

Dear John

Further to our meeting on 12 May 2011, I confirm the Parks and Wildlife Service support for the development of a regional playground within the Casuarina Coastal Reserve at Dripstone Cliffs and provide in-principle agreement to:

- Darwin City Council covering the cost of construction, maintenance and future upgrades of the regional playground and any costs associated with transfer of land;
- The Parks and Wildlife Service and Darwin City Council will enter into a long-term agreement to lease or subdivide the playground land providing full management and maintenance of the land and the playground to Darwin City Council. The subject site will be approximately 5 000 m² in area, comprising 700 m² for the playground and the remaining area for picnic tables and barbeques (see attached aerial map);
- Darwin City Council will install a water meter for the subject land and pay for water use; and
- Darwin City Council will run the public consultation phase of the project.

Legal advice is currently being sought through the Department of Justice on the preferred option for a long-term agreement through either leasing or subdividing the subject land under the *Planning Act*.
