## SOCIALLY RESPONSIBLE CONSIDERATIONS

When owning an animal it is understood that certain requirements are met to ensure the animal is kept safe and healthy. The below table outlines some of the considerations owners should consider when adopting an animal.

I commit to practising responsible pet ownership by:

- Managing my animal to prevent noise nuisance
- Taking appropriate steps should verified complaints be made
- Meeting the requirements for my animals health and well-being
- Providing continued physical and mental exercise and stimulation for my animals
- Walking my animals on a leash
- Educating my family to care for the animal
- Keeping my animals vaccinations up to date
- Watching my animal when in the presence of children or strangers
- Collecting faeces and dispose of in a sanitary manner
- Continuing the training and socialisation process
- Ensuring my animal is appropriately contained.

In choosing to care for an animal I understand these are my minimum requirements.
