

# Commercial outdoor activities policy

# Policy No. 6250.100.E.R

#### 1 Purpose

The purpose of this policy is to provide a framework supporting a range of commercial activities on City of Darwin land, while maintaining public amenity and access.

### 2 Scope

This policy applies to all public land within the Darwin municipality managed by the City of Darwin.

This policy addresses commercial activities such as:

- busking and street performing
- food and beverage premises such as outdoor dining and licensed premises
- parklets
- outdoor classes
- street food
- tourist coach parking bay operations adjacent to Bennett Park
- other commercial activities.

This policy does not apply to:

- any land or road reserves that are under the ownership, administration or management of the Federal Government, Northern Territory Government, private owners, or the Darwin Waterfront Precinct
- City of Darwin managed land where a property agreement authorises the use of the land
- events where an alternative permit process exists.

# 3 Policy statement

This policy sets the objectives for the commercial use of City of Darwin's land.

The key policy objectives are to:

- activate public places, enhance outdoor activity and promote safety
- encourage business and stimulate the local economy
- ensure the design addresses the equity of access to, and through, public spaces
- maintain and enhance public amenity
- create versatility in the use of public spaces
- create cool and green public places through design elements and sustainable infrastructure.

City of Darwin issues authorisations for the following activities in line with the *City of Darwin By-Laws 2023 (NT)* and City of Darwin's strategic directions:

Activity	Description
Busking and street performing	The performance of music, dance, solo singing, poetry recitation, juggling, magic tricks, chalk art or street theatre on City of Darwin land.
Food and beverage premises	Extension of a hospitality business which serves substantial meals and/or drinks on City of Darwin public land.
Parklets	Extension of a premises into an on-street car parking bay for use by patrons and the public.
Outdoor classes	Commercial health and fitness providers who use City of Darwin owned land, for fitness training services.
Street food	Registered food business operating from a mobile platform such as a cart, van or other vehicle.
Tourist coach parking bay	Tour vehicle parking for multiple passenger pickups, drop-offs, with an ancillary stall to sell tours
Busking and street performing	The performance of music, dance, solo singing, poetry recitation, juggling, magic tricks, chalk art or street theatre on City of Darwin land.
Commercial activities	Any other commercial activity on City of Darwin land, including, but not limited to:              • retail trading             • tourism activities  Commercial activities could include activities on public footpaths, parks and roadways for commercial purposes that also serve broader community benefit.

#### 3.1 Fees and charges

Fees apply for the use of City of Darwin land and associated administration fees for the issuing of licenses.

Fees are reviewed and adjusted annually.

#### 3.2 Public liability insurance

Unless exempt, licence holders are required to have public liability insurance for commercial activities conducted on City of Darwin Land.

The coverage amount is subject to assessment of the level of risk associated with the activity type. The specific coverage requirements for Public Liability Insurance will be determined by City of Darwin.

#### 3.3 Single use plastics

Single use plastic items were phased out from 1 January 2019 by City of Darwin, including any deliberate release of helium balloons. City of Darwin considers the environmental impacts of those using City of Darwin land, and aims to engage businesses and organisations that demonstrate environmentally sustainable practices.

#### 3.4 Trial period

A trial may be considered for new, innovative commercial ventures for an agreed period. In this case, all impacts will need to be assessed and conditions will apply for the duration of the trial.

A review of the trial will then inform the conditions of any ongoing licence.

#### 4 Definitions

**Busking and street performing** means performing of music, dance, or street theatre on public land for the purpose of receiving monetary contributions from members of the public. Buskers and Street Performers are not paid or hired directly for their performance but rely on passers-by appreciating their work and choosing to pay the performer.

**Commercial activity** means any operation or undertaking that involves the provision of goods or services for financial gain, brand or product awareness or other commercial interest or gain.

**Licensed premises** means a premises that holds a Licence under the *Liquor Act 2019* (NT) for the sale, supply, or service of liquor.

**Parklet** means a temporary structure placed in an on-street car parking bay. It is usually a small platform or deck that extends from a footpath into a parking space and provides seating and landscaping for public use.

**Public place** means places that are owned by City of Darwin, open and accessible to the public, including footpaths, road reserve, areas surrounding activity centres, parks, and other similar areas.
