By-Law 56

APPLICATION FOR NEW REGISTRATION – DOG/CAT

All cats and dogs three months or older must be registered. The owners of a dog or cat who fail to register their animal may be liable to a fine. A child's dog or cat must be registered in the parent's or guardian's name.

<ul style="list-style-type: none">• Managing my animal to prevent noise nuisance• Taking appropriate steps should verified complaints be made• Meeting the requirements for my animals health and well-being• Providing continued physical and mental exercise and stimulation for my animals• Walking my animals on a leash• Educating my family to care for the animal• Keeping my animals vaccinations up to date• Watching my animal when in the presence of children or strangers• Collecting faeces and dispose of in a sanitary manner• Continuing the training and socialisation process• Ensuring my animal is appropriately contained.
